**5:00 PM** – Supervisor opened the meeting and led the Pledge of Allegiance.

#### 1. BUSINESS

A. Review end-of-year Trial Balance for the various Town Departments. Karen McPeck, Bookkeeper, explained that these are the balances as it stands today, 12.27.2012; however, it will change a little when the bills are paid tomorrow. She would be happy to answer any questions. There were no questions.

**B.** Rosaria Peplow noted that the Town Clerk's Annual Report shows the money that was collected in 2012 and the money that was paid out.

Litts found it amazing that the disbursement and receipts equal to the penny.

Peplow said that the Quicken reports show all the deposits and expenditures from the Town Clerk, Water and Sewer checking accounts. She gave the reports for each Councilmember to sign as when the books were audited by New York State, the auditors looked for the signatures of the Town Board members.

B. **RESOLUTION** made by Brennie, seconded by Paladino,

**WHEREAS** the Sewer district is waiting for rents that were re-levied on the 2013 tax rolls in the amount of \$95,080.32

**WHEREAS** these rents are needed for the operation and maintenance of the Sewer District in 2012

WHEREAS there are excess funds available in the Sewer District Debt fund

**NOW, THEREFORE, BE IT RESOLVED** the Sewer District Debt fund will loan the Sewer District Operation and Maintenance fund \$30,000.00 to be repaid when referenced funds are available and received from the collected taxes in 2013.

Karen McPeck explained that this resolution is for a short-term loan between the Sewer Debt and the Sewer Operations and Maintenance account which is a little short.

Unpaid Rents are re-levied on the 2013 property taxes in the amount of \$95,000-plus and that is 2012 money which won't come in until 2013 when the taxes will be paid. It is anticipated that the money will be paid back by February.

Paladino asked what 'Central Communications' meant.

McPeck answered that includes the internet, the server and when the IT people come in to fix problems; she feels that is why the account went over.

Paladino asked the amount of the contingency balance and McPeck replied that before this amendment it was \$89,171.72.

Supervisor announced that he will be out of town from December 29 to January 9. The liaisons will remain the same but if anyone would like to change liaison positions, he asked that they contact Elaine Rivera, Deputy Supervisor. He would like to discuss the duties and responsibilities of the liaison positions. He feels that there needs to be better communications among departments and committees. If a department head has a problem rather than tracking him or Rivera down, they should be able to go to their liaison for help and the liaison could bring it back to the Town Board for further discussion.

Brennie suggested having two liaisons for the bigger departments.

Karen McPeck offered that the department heads need to be encouraged to speak to their liaison as to what is going on in their department.

Guerriero would like the engineers to communicate better with department heads instead of taking matters into their own hands.

McPeck agreed that Morris Associates needs to communicate better with everyone. She said that she has received a FEMA check for \$575,000 and does not know what it was for; she will to track it down. If the engineers have the paperwork, she would like them to share it with her from the beginning so she knows what to expect.

Supervisor stressed that as they are all elected Town Board officials and if there is a question, to pick up the phone and ask the questions. Part of the discussion today was that even though the vouchers are audited, Guerriero could look at the Highway vouchers to see if there is something to question.

Guerriero said that when auditing there are a lot of code numbers with which he is not familiar and he would like them explained a little better.

**MOTION** made by Litts, seconded by Brennie, to adjourn the meeting at 5:10 PM.
