IV. OLD BUSINESS

The committee embarked on a review of local social service agency requests from the September 27th meeting.

Todd Joncas went over a spreadsheet he created noting multiple options for distribution of funds using various percentages/scenarios. Discussion ensued on funding ideas by individual members.

Consensus was reached on 100% level funding of FY 12-13 distributions, with the exception of decreasing Derry Sonshine Soup Kitchen from \$940.00 to \$500.00 per annum. Consensus also reached to not fund Family Promise request for the next two year period as this agency is not at this point up and running and as such can't quantify its local contribution to Londonderry residents.

Tom Dalton made a motion to level fund last year's charitable contributions at amount of \$50,864, second by Todd Joncas.

Later in meeting it was suggested that the committee take each agency funding number and approve individually. Each of the twelve agency contribution amounts was motioned by Todd Joncas, second by Tom Dalton, and unanimously approved.

Final social services agency funding recommendation for FY 14-15: \$50,864 motion by Todd Joncas, second by Tom Dalton, approved 5-0 by committee. (Note: Please see attached spreadsheet for individual social service agency funding numbers)

IV. NEW BUSINESS

Discussion ensued on FY 2014 budget process. Initial budgets for both the town and school district are expected shortly before Thanksgiving. Todd Joncas asked that we challenge both entities to provide information we need to give the budgets appropriate consideration they deserve.

Minutes of all such meetings, including names of members, persons appearing before the bodies or agencies, and a brief description of the subject matter discussed and final decisions, shall be promptly recorded and open to public inspection within 144 hours of the public meeting, except as provided in RSA 91-A: 6, and shall be treated as permanent records of any body or agency, or any subordinate body thereof, without exception.
