The continuing questions on the condition of the Sanborn ave site were answered as the site did not pass its soil test and still requires clean up, it was also brought to the attention of the committee that the Dog Park committee also had interest in the site and a unanimous vote was taken to share the potential site with the dog park as well as affordable elderly housing.

There was a discussion on the difference between Workforce housing and HUD 202 housing.

The mission statement for the EAC was reviewed and approved as written.

A: 2 Meetings Open to Public.

II. All public proceedings shall be open to the public, and all persons shall be permitted to attend any meetings of those bodies or agencies. Except for town

meetings, school district meetings and elections, no vote while in open session may be taken by secret ballot. Any person shall be permitted to use recording devices, including, but not limited to, tape

recorders, cameras and videotape equipment, at such meetings. Minutes of all such meetings,

including names of

members, persons appearing before the bodies or agencies, and a brief description of the subject matter discussed and final decisions, shall be promptly recorded and open to public

inspection within 144 hours of the public meeting, except as provided in R SA 91

A: 6, and shall be treated as permanent records of anybody or agency, or any subordinate body thereof, without exception.
