V. STANDING REPORTS

• Transportation: Bonnie invited to sit on the Greater Derry Londonderry Chamber of Commerce Government Affairs Meeting on Transportation and will share our findings. Kevin Smith wants to follow up on discussion this summer regarding transportation. Joe has a few people who keep an eye on CART and report that it is not improving. New director there and new personnel have not made it more effective. Dolores gave a summary of work done this summer on survey. We need new prices on costs. Minuteman press is a new press in town, and Steve Cotton does printing for us. Insert in tax bills is a possibility. Other possibilities offered. Surveys could be available at Senior Center events.

- Housing: Intro: Tracey Hamlin-Landry, All American Assisted Living Tracey presented on new housing options in Londonderry. Different concept for assisted living in NH. Costs run 5,000-10,000 month. Memory loss programs are more. "Companion living" target for apartments is folks of varying levels of independence. Apartment has a shared living room and kitchen, with private bedrooms with sitting area. Price is much lower 3,900-5,300 price ranges. Full services of nursing care, transportation, etc are included. Scheduled to open by May 2016. Tracey is looking for input. NH is only state with multiple levels of assistance. Most plans are private pay. Veterans benefits available. Informational sessions are planned.
- Senior Center Update: Holiday craft fair Nov. 7th. Many gift baskets and cookies, etc. Tickets on sale Monday through Friday.
- Londonderry Police Liaison: Checking credit reports is recommended. Stolen personal information is used for gift cards. This is newest scam in our area.
- Londonderry Fire Liaison: October is Fire Prevention Month. Check your batteries in alarms.

VI. NEW BUSINESS

- New Name?: Bonnie suggests that perhaps our current name may not be comprehensive enough for our mission statements. Suggested change to "Senior Affairs Committee" to replace Elder Affairs, because we are here for all seniors including those who are younger and independent.
