The initial discussions centered around providing affordable housing in Londonderry. The majority of the workforce can't find affordable housing in this town. Starter homes are hard to find. A.Garron suggested that we spend the first part of our sessions educating ourselves on the needs of the community. He suggested bringing in some guest speakers and/or having workshops. M.Soares suggested addressing the zoning to provide for more density for building. J.Michels suggested defining a percentage for elderly, starter homes, etc. M.Bove said we also need to define what type of impact it will have on the schools, hospitals, police, fire, etc. M.Soares said perhaps we should look at elderly housing that could change after 30 years if desired, because the demand may not exist in 30 years. M.Bove suggested mixed villages (i.e. elderly housing, starter homes, assisted living, etc). He suggested using the services of professions in training (i.e. nursing, doctors) at these mixed villages as part of their education. S.Thrall said she would definitely be interested in finding out more about using those services
