### Programs –

- On Thursday, September 15, 2011, at 7:00 p.m., the library will sponsor the program "Susan B. Anthony The Invincible!" with Sally Matson. In this program, Susan B. Anthony is brought to life by performer Sally Matson. The play uses letters, speeches and diaries to highlight Miss Anthony's interactions with such notables as Frederick Douglass, Harriet Tubman, Horace Greeley, and Elizabeth Cady Stanton. The program is being co-sponsored with the Londonderry Historical Society.
- On Thursday, October 13, 2011, at 7:00 p.m., the library will offer "Silent Movie Performance with Richard Hughes". In this program, silent movie pianist Richard Hughes will provide a glimpse into cinematic history as he discusses the silent film industry and performs several sample musical pieces of the day. He will then present several short comedy films along with their musical accompaniment, including a Buster Keaton film, a Charlie Chaplin film, as well as the Laurel and Hardy comedy *Habeas Corpus*.
- On Thursday, November 10, 2011, at 7:00 p.m., the library presents Rob Velella as Nathaniel Hawthorne. In this program, actor Rob Velella portrays author Nathaniel Hawthorne. As Hawthorne, he will briefly introduce himself and then read from several of his well-known short stories such as "The Minister's Black Veil" and "The Birth-mark."

### Announcements -

- I was notified on June 14, 2011, that the contract to replace the roof was awarded John Daniels. The work on the roof began on June 28, 2011 and is still in process on July 28, 2011. The roofer notified the Library Director of an issue with the original roof on the south side of the building. There was no insulation along the soffits and both the roofer and Steve Cotton recommended that insulation be added. There are some ceiling tiles in the Reference area that got wet after the roof tarp was removed before some rain storms. These tiles will be replaced by the roofer.

# **Assistant Director and Head of Circulation Services Report:**

- The summer reading programs are having another successful year. The Children's Summer Reading Program has signed up over 1,200 children who have already read nearly 9,000 books. There were a total of 39 children's programs and activities in July with a total of 2,424 participants.
- The special programs each week have been well attended. The Luau and the Traveling Tide Pool were very popular.
- The Young Adult Summer Reading Program has signed up over 450 teens who have already read over 1,500 books. The weekly programs have been well attended by an enthusiastic group of teens. Among the most popular so far have been the movie night and the book discussion, both of them of *Percy Jackson & the Olympians: The Lightning Thief*. This is the first book in a series by Rick Riordan that is almost as popular as the Harry Potter books.
- Coming up in August, the Children's Summer Reading Program has several special programs. On Wednesday, August 10 from 11:00 a.m.-12:00 p.m. the Traveling Storyteller will be sharing *Nanuk's Arctic Adventure* and some tales of the frozen north. The summer program wraps up on Wednesday August 17 and Thursday, August, 18 from 11:00 a.m.-12:00 p.m. and 2:00-3:00 p.m. on both days, with a visit from the world traveling pigs, Toot & Puddle. Attendees who have reached their reading goal may pick up their prize bags at the shows. Everyone has until close on Saturday, September 10 to reach their goal and pick up their prize bag.
- The Young Adult Summer Reading Program features a movie night on Thursday, August 4 from 5:00-7:15 p.m. with *The Voyage of the Dawn Treader*. The remaining Thursday evenings are from 6:00-7:00 p.m. On Thursday, August 11 *Movie or Books?* discusses the differences between the books you have read and movies based on them. On Thursday, August 18 come and share your favorite books and characters in *A World of Books*. The program wraps up with a pizza party and raffle on Thursday, August 25. Reading logs for the Janice Anagnos Memorial Prize must be turned in by close on Saturday, September 3. This prize and certificate will be awarded to the teen who read the most books from June 1 to September 3, 2011.

# **Assistant Director and Head of Reference Services Report:**

- Our Adult Summer Reading Program is well underway. We have nearly 400 participants who have earned over 1300 raffle tickets for books they have read. We have given away 16 prizes so far in our weekly drawings and also have two winners for our first two trivia contests. It's not too late to register for this fun program and the chance to win prizes!
- We have our third installment of the Summer Reading Program's 'Novel Destinations' on display this month. We have made our way to Europe and Asia

where you will find books, travel books, and DVDs set in these continents. A few titles include <u>The Matchmaker of Kenmare</u> set in Ireland during World War II; <u>The Paris Wife</u> based on the life of Ernest Hemingway and his wife; <u>The Calligrapher's Daughter</u>, the story of family traditions in early twentieth century Korea; and <u>Under Fishbone Clouds</u>, a love story during the Cultural Revolution of China. Our third trivia contest available on the display table is a simple geographical crossword puzzle.
