Jim Bilodeau gives presentation to property owners of the reasons why name and numbering changes are needed.

Handouts were given with the suggested names of Cobalt, Copper, Gold, Nickel, Onyx, Platinum, Quartz, Ruby, Sapphire, Silica, Tin and Zinc.

Suggested suffixes of Dale, Knoll, Pass, Passage or Place.

Addition handouts with answers to frequently asked questions, 911 guidelines for street renaming and a synopsis of the December 2, 2002 ruling involving Swanzey N.H.

Many residents were concerned about additional confusion that could result in delays to their mail delivery. Residents advised that delivery to their park assigned mailboxes is already an existing issue.

It was explained that the park assigned mailboxes were the responsibility of the Park Management, but It was anticipated that the mailboxes would be given new labels with whatever new names were ultimately decided upon. The address of 192 By-Pass 28 would be eliminated for park residents.

Most residents present at the meeting did not like the suggested names or theme. Residents requested that The names be changed to something as simple as possible.

Kathleen Chambers suggested that color be the theme instead of minerals.

The Task Force advised that the suggestion would be taken into consideration.
