STREET NAMING SYSTEM TASK FORCE MEETING MINUTES DECEMBER 8TH, 2011

The Londonderry Street Naming System Task Force held a meeting on December 8th, 2011 in the Woodmont Room of Londonderry Town Hall. The Meeting began at 9:30 am.

Present: Task Force Members: John Vogl, Karen Marchant and Bobby Jones

- J. Vogl and K. Marchant welcomed B. Jones to the Task Force. Both gave him a summary of the task force charge and activities thus far and described what is pending. K. Marchant said that we held meetings regarding Kelley Road and were waiting on feedback from Ryder Daniels regarding names the residents would support. J. Vogl said he had reached out to Mr. Daniels but was unable to reach him. He will continue to try. He said that the deadline he and Mr. Daniels had agreed to was coming to a close. Members agreed they would wait a little longer for a response. If no valid names are suggested, the Task Force will proceed with 'Stagecoach'.
- B. Jones mentioned that he had heard of issues with address changes resulting from alarm services. He said that in some instances, property owners did not notify alarm companies of the address change. He said we need to be more explicit about informing property owners to follow through on notifying all parties they interact with. Members also discussed 9-1-1 practices used relative to street issues and GPS devices.
- J. Vogl said that after the failure to get the Hardy/Hovey resolution past first read, the Task Force should reeducate the Council about the Task Force's charge and the reasons for it. He said offering a status report before the discussion regarding Kelley Rd/Kelly Ave would be appropriate. B. Jones said he would review airport documents to see how Kelly Ave is addressed and see if it can be changed.
