Whispering Pines Mobile Home Park

Nancy Acheles advises that she has not received any changes regarding the box numbers for the office, salon and store of the park.

Jim Bilodeau advises he thought that Jayne Gagnon of Derry Fire Department was going to implement those changes as they are all in Derry.

Nancy Acheles advises that the post office will begin forwarding mail to the new addresses on April 20, 2011.

Postal officials will change the mailbox labels to the new names and numbers on April 16, 2011.

Airport Area Roads

J. Vogl said that the future of the Town's portion of Pettengill Road is uncertain and thus section K could not retain the name 'Pettengill Road'. Until the Town's portion is constructed, this would create two disconnected Pettengill Roads in Londonderry. He and Jim Bilodeau agreed that the section should be given a unique name. J. Vogl said that he and Public Works Director Janusz Czyzowski had spoken with Mr. King (landowner) who suggested that the name 'Roundstone Drive' be used for this section.
