# LONDONDERRY TARGET SHOOTING TASKFORCE "COMMITTEE CHARGE"

#### **PURPOSE:**

The Londonderry Task Force on Target Shooting in the Musquash and other Town-owned Conservation Land is tasked with studying the issue of target shooting in the aforementioned areas, and making recommendations to the Town Council as to what changes, if any, should be made to current Town ordinances governing such.

### **REPRESENTATION:**

The "Task Force" shall consist of **ten (10)** members, **nine (9)** of whom shall be voting members, to be appointed by the Town Manager:

Londonderry Chief of Police or designee, Chairman (non-voting member)

- One (1) appointed representative from the Conservation Commission
- One (1) appointed representative from Londonderry Trailways
- One (1) appointed representative from Londonderry ALERT
- One (1) appointed representative from the Londonderry Fish and Game Club
- One (1) appointed representative from the Londonderry Fire Department
- Two (2) appointed representatives from the Hunting/Target Shooting community
- Two (2) appointed representatives from neighborhoods abutting the Musquash

The Town Manager and the Planning & Economic Development shall provide administrative and technical support to the Task Force.

### **ORGANIZATION:**

The Town Manager shall notify the Chairman of the Task Force of its appointees in writing on or before Dec. 15, 2014.

The Task Force shall determine its own rules or order of business, unless otherwise provided by law or Town Charter.

The Task Force Chairman shall appoint a secretary for the committee

### **DUTIES / RESPONSIBILITIES:**

- 1. Hold meetings and keep minutes of any such meeting, in accordance with RSA Chapter 91-A.
- 2. Prepare a written report with findings and recommendations to the Town Council no later than April 1, 2015.
- 3. Maintain a permanent project file that at a minimum, includes:
  - A. Committee minutes:
  - B. Researched materials, data, and other analytics;
  - C. Task Force correspondence:
  - D. Other material as deemed necessary.
- 4. Provide periodic report to the Town Council.

	Vice Chairman Butler opened the meeting with the Pledge of Allegiance. This was followed by a moment of silence for a

17	Town Manager Smith stated that the PSNH presentation has been moved to the next meeting on the 17th.

21	Town Manager Smith stated that the Council has consulted with this Town Attorney and after going through a variety of				
22	different issues with the Attorney, the Council is going to go in a slightly different direction than having another workshop.				
23	Councilor Farrell stated that the Council is going to ask the Town Manager to start the process to form a task force which will be sanctioned by a Resolution and sanctioned by the Town Council to go out and study and understand all of the issues

29	NEW BUSINESS

31	Town Manager stated a high level overview of the FY16 budget. Town Manager Smith stated that there will be a budget				
32	workshop on Saturday, November 15th at Town Hall when the Council and the Budget Committee together. Smith stated that				
3	he was tasked with coming in with a budget that starts off at default which is what has been done for the last two years. When				
54 55	looking at the default operating budget, the increase is just over 2%, most of which is due to retirement rates since the rates				
66	have gone up and the decrease/amount of State funding the Town is getting for retirement has gone down. Smith stated that it has become the Municipalities obligation to fund more of that. Smith stated that there are some adjustments that will be made				
7	between now and then. Smith stated that originally it was budgeted in the default budget of 3% increase for health insurance.				
8	Smith stated that what he found out on Friday, the maximum increase is actually only going to be 1.7%. Smith stated still,				
9	typically the rate has come in lower than the maximum. Smith stated that aside from the operational budget, as was stated in				
10	previous meetings regarding how FY14 year ended, Smith stated that there is the ability to use some of the fund balance this				
·1 ·2	upcoming budget cycle. Smith stated that no appropriations were made into the Capital Reserve Accounts and made very small appropriations to Roadway and Expendable Maintenance Trust Funds. Smith stated that in putting his budget together				
2	this year the priorities are going to be Capital Reserve Account, which will include appropriations to ambulance, fire				
4 5	equipment, fire trucks, highway trucks, heavy equipment and the Pillsbury Cemetery along with higher appropriations to				
	roadway maintenance fund. Smith stated that there are a couple other potential separate warrants which would include				
6	improvements made to the money from the Reclamation Fund to be used for the Drop Off Center, that's self-funded so that				

would not require use of the Fund Balance or raising taxes either. Smith stated equipment for ambulance he is looking at 3

CPR devices, one for each ambulance. Smith stated there will also be money for both the GIS Services and the Zoning Code re-write. Smith stated that there are five Union Contracts that are still in negotiation at this time. Smith stated that may be late additions to the Warrants. Smith stated that he is looking to do all of this with looking to achieve a steady tax rate. The three main variables making up the tax rate are the total appropriations, total Town evaluation and outside revenues. Smith stated that outside revenues were up due to the addition rooms and meals money from the State. The Town evaluations went up on the commercial and industrial side. Smith stated that the hope is to set the evaluations right so that it may improve the tax rate, which is exactly what that did. Smith ended by saying that the goal is to come to the Council on November 15<sup>th</sup> with a budget that keeps what the Town has for the current tax rate, pretty much steady.

Vice Chairman Butler introduced Resolution #2014-05, a Resolution Declaring the month of November "Pancreatic Cancer Awareness Month" in the Town of Londonderry, New Hampshire. Councilor Green read the Resolution into the record. Councilor Green motioned to approve Resolution #2014-05. Second by Councilor Freda. Chair votes 4-0-0.

Vice Chairman Butler introduced Resolution 2012-19 (B), an amendment to the sanctioning of Londonderry express soccer association. Councilor Farrell voted to waive the reading Butler stated that because it is a Resolution it is not open to the public but understanding the issue surrounding the Resolution it will be open to the public. Councilor Green stated that he is the Recreation Committee liaison for the Town Council. Councilor Green stated that he attends each one of the meetings so that he can bring the information back to the Council. He doesn't vote on it and he has nothing to do with the Recreation Commission as far as what they bring to the Council as far as voting goes. Councilor Green stated that anytime a Resolution has come forward for a sanctioning regarding Londonderry United Soccer Club or Londonderry United Youth Soccer Club, because he is Vice President of Londonderry Youth Soccer Club, Green stated that it is important to step out of the vote and not take his Council privilege and vote on it tonight. Councilor Green stated that this Resolution was never about breaking up teams. The intention is to try to illuminate this cross fighting that was going on.

Art Psaledas stated that in the past there has been no age limits. Psaledas said if it goes through with an age limit, it is going to shut out a team, or several teams that have been in existence since the nineties'. Councilor Freda sked what the names of the groups are. Psaledas stated that LYSA is the recreation soccer and Express Soccer is the travel team, registered with the State. Now they have been going by Londonderry United Soccer Club for the past twelve years. Psaledas stated that that is the reason for the confusion with their name. Councilor Freda stated that the other Recreation Resolution that was passed recently had an age limitation; participants had of be over the age of eight. Councilor Freda stated now we are looking to change that to drop the age limitation and to also change the name. Psaledas stated that is correct. Councilor Freda asked what the effect will be of dropping the age limitation. Psaledas stated that they will be able to continue with forty kids in the fall and the sixty kids in the spring that are under that eight year old limitation, that are currently playing. Councilor Freda asked why there is an age limit to begin with Psaledas stated that it was necessary to come up with some better definitions of what they were doing. It just happened. The age limit came up because there is one soccer groups said that they shouldn't start playing competitively until eight years old. Psaledas stated if we don't get rid of the age, what will happen is those people whose kids are playing travel now and can't in Londonderry, will move out of Town to play.

Todd Ellis, 298 High Range Road, stated that US Soccer does run different in regards to ages. Currently there are U-7 and those kids turn 7 after August first. Ellis stated that people will go out of Town if they cannot play in Londonderry.

Dave Kelly, 3 Angelo Lane, stated that Art had mentioned difficulty a few years ago about another soccer club being formed and it did cause the process to slow down because of all of the competition. Kelly stated that what happened this past winter that ignited a lot of grief between the two organizations were that some of the people in the recreation group tried to form another travel soccer club and use West Road fields. Kelly stated that is what caused the trouble. Kelly stated that his kids played both recreation and travel soccer. Kelly stated that he feels there is a place for both organizations in Town but the most important thing is the families have a choice. Clinics are done for the younger kids and that's all it is, skills clinic.

Gary Sloper, 13 Buckingham Drive, passed out a handout to the Council. Sloper stated that he is currently a U-6 coach for LYSA as well as a parent to a child who is one the travel time. Sloper stated that he has been a coach for the past three years. Sloper stated that there is a targeted bias towards soccer. He has kids in both organizations. Sloper stated that he doesn't do player profiles and he doesn't keep scores. Sloper asked the Council before they put the Ordinance through, think of the kids.

118	changes made to both the ordinance and the sanctioning Resolution's. There was an initial vote at the Recreation				
119	Commission that approved it in August which is one the original one was done with the age limit. Smith stated that there				
120	were meetings after that where the Recreation Commission said; no they don't want the age restriction in there. That is why				
121	tonight there is the current proposal that would move the age restriction limit out of the sanctioning.

123	Keith Gagne, 84 Hall Road, stated that he is the coaching coordinator for Londonderry United. Gagne stated that he believes				
124 125	there was an agenda here when it was brought to the Recreation Commission. It was brought to a meeting before the organizations were consulted.
