TOWN COUNCIL MEETING/BUDGET WORKSHOP January 07, 2013

The Town Council meeting was held in the Moose Hill Council Chambers, Town Hall, 268B Mammoth Road, Londonderry, NH.

PRESENT: Chairman, John Farrell; Councilors: Jim Butler, (7:05PM); Joe Green; Tom Freda; Acting Town Manager, LPD Chief William R. Hart; Executive Assistant Margo Lapietro. Absent: Vice Chairman Ton Dolan.

Call to Order

Chairman Farrell opened the meeting at 7:00PM with the Pledge of Allegiance. This was followed by a moment of silence for the first responders, those in service here and abroad and for those in the Sandy Hook Elementary School.

Chairman Farrell explained at the last meeting he received text messages; he spoke to the Town Attorney and protocol was correctly followed. There was an editorial that questioned if it was an interruption and he received a letter from Dana Coons, 2 Aspen Circle, that he read into the record (copy attached). He explained that this Council is trying to remain completely transparent on everything. D. Coons letter was sent to all the Councilors in which he expressed his disappointment at Chairman Farrell receiving and reading an e-mail during a public meeting. He went on to say that other citizens have to come to the meeting to be heard, and he felt the town owes an apology to the people in attendance. Chairman Farrell said he allowed the e-mail to be read so if there is any apology, he apologized. It was done in full transparency and with the full consent of the Council. They believe if they can get public information from the community in any shape or form from any media method, this Council wants full transparency and full participation from the community. He apologized again if he offended anyone.

He stated that he received another letter from Ruth Bolduc, 5 Sequoia Avenue thanking Council for displaying the Nativity Scene on the Town Common.

Public Comment

Londonderry Trailways — Bob Rimol, 2 Fay Lane and Sandy Lagueux, 2 Fiddlers Ridge members of the Londonderry Trailways were in attendance to discuss the proposed Citizen's Petition to obtain \$227K on a Warrant Article to pave a portion of the rail trail. S. Lagueux explained the Rail Trail runs from Derry to Concord. There is approximately 6 miles located in Londonderry. In 2012 per B. Rimol they signed a rail trail agreement with the State of NH, DOT and the Town of Londonderry. They self-funded a preliminary engineering study that cost \$10K which was funded 100% by Trailways through private donations. They did extensive clearing, prepping and grading work. S. Lagueux said in 2012 they got a \$20K grant that requires a 20% match which was 100% funded by Trailways. She explained they have received corporate and citizen donations totaling \$22,500 from state and local grants, \$9,700 from individual donations and \$7,200 in corporate. She said recently they received an update from DOT that there are no federal funds designated in 2013, funds won't be available until 2017. B. Rimol said they got word that there was no money available a few days after the last Council meeting. S. Legueux

said the Citizen petition is for a mile of paving between Sanborn Road and Symmes Drive. Chairman Farrell asked how muc where they were asking for. B. Rimol responded the estimate from their engineering firm is \$227K which includes engineering fees, paving and applying loam and seed. Councilor Green asked what is the total cost for the rest of the trail. B. Rimol responded he couldn't give an overall figure because there are two difficult crossings of Rt. 28 in the North and in the South. Right now it is easier to do the easier sections because construction is cheap. Other towns have done it segment by segment. Councilor Butler asked about the two problem areas. B. Rimol said the two Rt. 28 crossings could be problems with different ways of handling the crossings. Councilor Freda clarified the six miles will link Derry to Manchester, B. Rimol responded yes. Councilor Freda asked if we have ownership on all the six miles. B. Rimol responded all the ROW's are no problem. The ownership they do not have is in the northern segment which is owned by the Manchester Airport. The Airport has agreed to work with both us and Manchester with the rail trails – it is a non-issue. S. Lagueux also pointed out that the rail trails are in the MHT Master Plan. Councilor Freda stated that the entire cost would be about \$1.4M for Londonderry. S. Lagueux also pointed out that another segment is owned by Pillsbury LLC. Chairman Farrell asked what the ROW is, B. Rimol said it varies but it is about 25 ft. Chairman Farrell explained that would culminate in 5- 10 acres of open space. He asked if they have talked to the Conservation Commission about using open space monies. S. Lagueux and B. Rimol agreed it was a good idea and they would contact them.

Dan Watson, 10 Manasquan, said he is in favor of it. The Derry/Windham trail is great; he rides 30 miles to work in good weather on the trails. He pointed out that the trails are all around the state.

Stacy Thrall, 9 Crosby Lane supported the trails. She has a home business caring for elder adults and on good days she has taken them out to enjoy the trails.

Ann Chiampa, 28 Lakeview Dr. supports the project and asked what avenues they have pursued to get grant money. S. Lagueux responded they will take any and all grants. Chiampa suggested contacting the Woodmont developers and the National Guard for help. B. Rimol said they fundraise every day and expect to get more donations. S. Lagueux gave their website Londonderrytrailways.org.

Chairman Farrell said he received an e-mail about the agenda being posted to the website. Acting Town Manager, LPD Chief Hart said it has been worked out.

<u>Update on Planning Director Search</u> Acting Town Manager, LPD Chief William Hart talked about the needs of the current position. They discussed a variety of possibilities including not filling the position at least as it was characterized in the past as a Director position. The current staff looked at different models to possibly include contracting out on a retainer basis and said that they have received a proposal. He said he and staff have talked about the needs of the Planning Department. One of the issues is going forward as we work with Woodmont and other projects that come up. We might need assistance in the planning process rather than the economic development piece. He asked staff to look at that as well. We have some ideas, and he is thinking about having staff make a presentation with some numbers based on the growth in town and the dollars involved. He said we might be able to do it for less dollars going forward. He is asking for guidance from Council and would like to come back in two weeks or come back

after the deliberative session and have an overview and discussion about what direction we want to go in. The consensus was to come back on 2/18/13.

Chairman Farrell informed the public that they have come down to four candidates for the Town Managers position. Human Resources has been directed by Council set up an interview day in January, they hope to have the interviews completed by the end of January.

He proceeded to read a letter (copy attached) from LFD Chief MacCaffrie announcing his intention to end his 47 year career in the fire service by retiring effective 3/1/13. He explained he wanted to spend more time with his family. He thanked the LFD employees and town employees for serving with them for the past five years. Acting Town Manager, LPD Chief Hart read his response letter (copy attached). He announced that effective 3/1/13 Battalion Chief Darren O'Brien will act as Chief until a decision is made going forward. Chairman Farrell thanked the Chief and said the Council looks forward to working with Acting LFD Chief O'Brien. Councilor Butler said he hopes the acting LFD Chief can continue to work with the current staffing levels of 10. Acting Town Manager, LPD Chief Bill talked about the new SUV's being leased by the LPD. He said they are also looking at changing their uniforms and explained why. He showed some pictures to the Councilors. Chairman Farrell suggested getting opinions at the Deliberative Session.
