29 where it was discussed in August and a notice was sent out to abutters for this meeting as well. Marchant stated that they
30 spoke with Stratham Tire, located facing Nashua Rd, and they stated that they have no problem with the name change. They
31 will be changing that section of Meadow Drive to Horizon Drive. Motion to approve Resolution #2015-05 made by
32 Councilor Green and second by Councilor Freda. Chair votes 5-0-0.
