<u>Bartley Hill</u> – Lynn Wiles (not in attendance) asking about a traffic counter? Discussion followed and no reason to put a traffic counter here. Public Works Director Czyzowski advised they could paint "do not block" in the road at the Stonehenge end.

OLD BUSINESS

<u>Stonehenge & Hardy Roads</u> – Public Works Director Czyzowski advised the committee that the Project is complete and sees no more problems. Police Department confirmed we have had no accident there and continued patrol in the area.

Rt 128 @ Pillsbury Road – Public Works Director Czyzowski advised the State is still reviewing the intersection. Tabled to the October 2018 Meeting.

Rt 28 @ Seasons Lane – Public Works Director Czyzowski advised the State conducted a traffic study. They do not feel this area is a troubled spot for the Town. Can request to be re-evaluated in a few years if the Town chooses.

<u>Page & Mammoth Roads</u> – Public Works Director Czyzowski advised that at this time it will remain a 2-way stop as it would be difficult for the TT Units to stop and start. Due to the thunderstorm this evening, no members of the public regarding this issue were present. Tabled to the October 2018 meeting.
