B. School Board Financial Review – Peter Curro

- \$1,034,000 Surplus
- Surplus will go to retaining some of the money with the new law adopted in the Spring, \$252,000. School District can now retain 2.5% of any surplus for future emergencies.
- •The rest will go back to offsetting the following years Budget.
- •Revenue from Middle School Food Services dropped by \$50,000
- •All other schools had had a surplus at Food Services
- •At this time Bond rates are not favorable to loan out money to do further work at North School
- •Side Note Bus Routes will be posted August 9th, 2013
- •Side Note School district will be taking in 60 students from Hooksett, NH this following year
