

Londonderry Conservation Commission Tuesday, September 25, 2012 Minutes

1 2	Present: Deb Lievens; Gene Harrington; Mike Considine; Paul Nickerson; and Marge Badois
3	D. Lievens called the meeting to order at 7:30 PM.
4	
5	Joint Negotiating Committee- D. Lievens met with Acting Town Manager Chief Hart to explain the newly
6	formed Joint Negotiating Committee as well as educate him about the work of the Commission. She
7	reported that it was a very productive conversation.
8	
9	New England Cottontail- At the June 12 meeting, Heidi Holman of New Hampshire Fish and Game (F&G) and
10	Town Forester Charlie Moreno had presented a proposal to create the kind of early successional habitat the
11	endangered New England Cottontail relies on in a 60 +/- acre section of the Musquash Conservation Area. D.
12	Lievens, M. Badois, and G. Harrington walked the site with F&G and Town Forester Charlie Moreno, along with
13	Bob Saur, President of Londonderry Trailways, a reporter from the Londonderry Times, and a member of the
14	U.S. Fish and Wildlife Service on September 14. M. Considine will provide his input to F&G when he revisits
15	the area with them at a later date. Commissioners reviewed the walk with the help of a map created by the
16	Town GIS Manager (see attached). C. Moreno has coordinated with Continental Paving who offered access
17	for the logging through one of their adjacent properties. He will also be responsible for putting the timber
18	cut out to bid. The objective is to begin the logging in late March/early April of 2013 so that desired shrubby
19	growth will become evident by May or June. The time frame was chosen in part to avoid impacting white
20	pine tree pine cones since that would result in the proliferation of white pines which are not conducive to the
21	habitat being created. P. Nickerson requested that bird nesting season, which typically begins in late April,
22	also be considered in the timing of the project. M. Badois explained the point made during the site walk that
23	the cost of the logging will be lower at that time of year because it is off-season for loggers. D. Lievens
24	stated that a TV show will be produced at some point through the Cable Access Center that can run this fall as
25	well as next spring to educate the public about the reason for the cutting. Richard Olson, President of the
26	NH Wildlife Federation (and President of the Londonderry Fish & Game Club), informed D. Lievens that his
27	non-profit organization may be able to partner with the Town to obtain funding for the management portion
28	of the project.
29	G. Harrington made a motion to authorize the Town's consultant Forester (Charlie Moreno) to put
30	out to bid the creation of the New England Cottontail Management cut in the Musquash Conservation Area
31	and inform F&G as well as any other interested parties. P. Nickerson seconded. The motion was
32	approved, 5-0-0.
33	
34	October 9, 2012 meeting- As a majority of members present will not be available for the October 9 meeting,
35	G. Harrington made a motion to cancel the October 9, 2012 meeting. P. Nickerson seconded. The
36	motion was approved, 5-0-0. G. Harrington and M. Considine were authorized by consensus to act as a
37	subcommittee in the event that any time sensitive issues arise.


<u>Trail day</u>- M. Considine reported that the trail day he mentioned at the September 11 meeting at the Kendall
Pond Conservation Area will tentatively take place on October 13. He must first coordinate with



55	had not attended the meeting.

57	G. Harrington made motion to adjourn the meeting. P. Nickerson seconded. The motion was approved,
58	5-0-0.
