3 D. Lievens called the meeting to order at 7:35 PM.

5 Sunnycrest Phase I- At their September 12, 2011 meeting, the Town Council approved the  
6 assignment of this easement to the Rockingham County Conservation District. A baseline  
7 report will be needed, along with a one-time donation to RCCD's stewardship fund.

9 Merrill easement- This issue went before the Town Council for their approval at their  
10 September 12 meeting. Ken Merrill asked at that time that the matter be continued to the first  
11 Town Council meeting in November.

13 Target practice in the Musquash- This topic was before the Town Council at their September 12  
14 meeting and was postponed until September 26.

16 Monitoring- P. Nickerson and T. Bloom volunteered to carry out the annual monitoring of the  
17 Moose Hill Orchard easements. RCCD will be perform the monitoring of Ingersoll and the  
18 Sunnycrest easements.

20 DRC- Akira Way Roadway Extension subdivision, 28-31

21 Comments: None with project. We do have problems with the 60' ROW unconstructed  
22 exiting existing cul de sac to the southeast. Reports of sedimentation and  
23 buffer encroachment.
