# **Proposal for 50 + Adult Softball League**

Jim Edwards presented a proposal for the creation of a new 50 and Over Mens Softball league. He is interested in two fields per week. They played last year with 28 players the mens league gave them one slot to play on Tuesday nights for an 8-10 game schedule. The new league is looking for two slots per week for the upcoming season. He does not know if the Mens lague will be resceptive of giving an additional slot. The mens league played 24 games last year. Season would begin in April thru September. Expecting to have 4 teams of 12 players and allow substitutions from other teams. As presented this would be a new league, which would require sanctioning by the Town Council. It was recommended the Jim discuss with the Mens league the formation of an Over 50 division in their league. Jim will be attending the Mens League meeting on February 18<sup>th</sup> to discuss the new leagure with them.

#### Proposal for a curfew at Neslon Road

Londonderry Police Officer Garcia called Art Psaledas with a concern over the increase of police responding to incidences at Nelson road over the last few years. See statistic provided by the police department below. In 2006 there were 16 calls in 2015 106 calls, this year there have been 23 calls. Setting a curfew could be difficult since games could be played later in the evenings. Councilor Green also asked at a past meeting to keep the basketball court lit until 11 PM. The commission would like to get more details on the times the calls are taking place. Officer Garcia suggested a now loitering or prowling ordinance. Art would need to talk to Town Manager, Police Chief, and Town Attorney to see

what could be enforceable. The committee was agreeable to move forward and get some more information from the PD.


# **OTHER BUSINESS**

Town Meeting attended by 73 people. The warrant article to repair the basketball and tennis courts was moved to the ballot with no discussion.


Recreation Commisson website page. Glenn asked if we could update the town web page to add Mens Softball league and all other groups using town facilities. Art will contact the town to update.
