The Londonderry Street Naming System Task Force held it's seventh meeting on November 5<sup>th</sup>, 2009 in the Sunnycrest Room. The Meeting began at 7:00 pm.

## Workshop regarding Nelson Road, Dan Hill Road and 49A Seasons Lane

Jim Bilodeau opened the workshop for property owners at 7:00 pm. Only one resident was present, Michelle Rossi, owner of 49A Seasons Lane. Jim described the history and mission of the task force and explained that we were meeting to try to reach consensus. Michelle Rossi said she was excited about the prospect of a new address and that there had a lot of confusion about locating her house now. She asked about the timing of the name change and Jim Bilodeau explained that it would take effect 60 days after a Council decision, which would occur at the November 30<sup>th</sup> Council meeting at the earliest. Michelle Rossi suggested four names that the group might adopt: Snowcap Way, Scenic Way, Birch Way, Aster Way. Members agreed Snowcap Way was acceptable. It is similar to Snowflake Lane but since the road is in the same neighborhood, members agreed it would not be problematic. Members agreed to get Karen Marchant's opinion before making a decision. Jim Bilodeau will let the Rossi's know the Task Force's decision and inform them what number would be used. John Vogl clarified that the driveway will remain a private driveway, no matter what it was named.

John Vogl said that he had contacted Art Psaledas regarding Nelson Road. He said the opinion of the LAFA program was that they would accept any road names.

He also said that Continental, an abutter on Dan Hill Road had contacted Karen Marchant and said they would be ok with any road name changes. He also had spoken to the Department of Public Works, regarding the Londonderry Drop-off center on Dan Hill Road. He said that the Department suggested "Recovery Way" as the new name for their section. Members agreed this was an acceptable name.

Cindy McCann asked about signage, and how quickly they can be put up. John Vogl said he would get the answer from DPW.

## Other business

Members reviewed a Frequently Asked Questions sheet Jim Bilodeau introduced and offered comments on introducing the process at future meetings. Members discussed information needs for future meetings. John Vogl said he would clarify what new street numbers would be used when street are re-numbered. Cindy said she would get recordings of confusing dispatch calls ready for future meetings.

## Minutes

Members reviewed the minutes from the 10/14, 10/15 and 10/27 meetings. Cindy McCann offered suggested corrections. John Vogl will make the corrections. **Jim Bilodeau made a motion to adopt the minutes as amended.** Cindy McCann seconded. No discussion. Motion passes unanimously.
