STREET NAMING TASK FORCE MEETING MINUTES September 8, 2010

The Londonderry Street Naming system Task Force held a public workshop meeting on September 8, 2010 in the Sunnycrest conference room of the Londonderry Town Hall. The meeting began at 9:30 A.M.

Present: Task Force Members: Karen Marchant, Jim Bilodeau, John Vogl and Cindy McCann

Meeting opened at 9:30 A.M.

Discussions

Task force members discussed property owner suggestion that the theme for the name changes at Whispering Pines Mobile Home Park, Londonderry be colors. All indications from Derry are that They will adopt any changes that this task force recommends.

Motion made by Karen Marchant to accept the theme of colors. Second by Jim Bilodeau. Passed unanimously.

John Vogl suggests associating the colors with the specific existing lanes in the park for clarity.

Said suggested name changes are as follows:

1.	Aqua Place	Lane 1 (Derry)
2.	Burgundy Place	Lane 2
3.	Coral Place	Lane 2A
4.	Gold Place	Lane 3
5.	Grey Place	Lane 3A
6.	Lavender Place	Lane 3B
7.	Lime Place	(Maintenance Building Section of Road)
8.	Orange Place	Back Section of Lane 3B
9.	Peach Place	Lane 3C
10.	Purple Place	Lane 4
11.	Raspberry Place	Little section of Lane 4A
12.	Tan Place	larger section of Lane 4A

Karen Marchant feels that park management is under the impression that the Town of Londonderry would be responsible for the cost of changes to the street signs and mailboxes within the park.

Karen Marchant advises that there are a total of 258 units within the park. 221 of the units are in Londonderry. 165 of the units located in Londonderry are owned by the park. 56 of the units located in Londonderry are individually owned. 37 of the units in the park are in Derry and ownership is not known at this time.

Task force members agree that Park Management is responsible for these associated costs. This will be specified in future meetings and will be made clear to park management.

Jim Bilodeau suggests another meeting with park management. Karen Marchant suggests that Derry Officials and Postal officials also be at the meeting in order to address any other issues.

Old Business

John Vogl advises that the resident of 55 Hovey Road has suggested Dragonfly Way instead of Stagecoach Way for that section of Spring Road that needs to be renamed.

Karen Marchant makes motion to accept Dragonfly Way as the new name for what is currently known as 55 Hovey Road including the section of the roadway that houses the Comcast building.

Second by Jim Bilodeau.

Motion Passed unanimously.
