

The Londonderry Street Naming System Task Force held a meeting on October 4th, 2011 in the Woodmont Room of Londonderry Town Hall. The Meeting began at 9:30 am.

Present: Task Force Members: John Vogl, Karen Marchant and Brian Johnson

Discussion re: changes to Kelley Road

Members discussed the status of changes to Kelley Road. This had been on hold pending the Council meeting on 9/15 in order to get the sense of the Council regarding changing business addresses. The Task Force decided to continue with changes to the residential properties on Kelley Road. With no names being offered by the residents, members decided to continue with Stage Coach Road as the alternate name. John Vogl said that he and Cynthia McCann had promised the residents there would be a second public workshop on this street. A workshop was scheduled for October 20<sup>th</sup> at 7:00 pm. Letters should be mailed out on Thursday, October 6<sup>th</sup>. A resolution would be ready for first read and adoption at the upcoming November 7<sup>th</sup> and 21<sup>st</sup> Council meetings.

The following schedule should apply:

- October 6 (thurs) – John V to send letters re: 2<sup>nd</sup> workshop
- October 20 (thurs) – public workshop with residents; location tba  
Draft of resolution to follow
- November 4 (fri) – John V to send public hearing notice to residents

- November 21 (mon) – Second read and adoption at Council meeting
- January 20, 2012 – Implementation

#### **Discussion re: Harvey/Hardy/Hovey Roads**

Members discussed the status of name changes in this area. Given the direction of the Town Council to leave the name Harvey Road in place, members agreed to move ahead with changes to Hardy and Hovey Road. Karen Marchant explained that Harvey Road sounded similar to both Hovey and Hardy. We could not let either of the two streets remain. Members discussed alternate names for the streets. John Vogl suggested that Schoolhouse Road be used for Hardy Road. Members discussed other names for Hovey Road including Pinkerton, Tavern Hill, Horizon and Flax Field. Karen Marchant suggested that Flax Field be used. Karen Marchant said that two meetings should be provided to accommodate large numbers of expected people. John Vogl suggested that the process could be carried out and a resolution made ready for the December 5<sup>th</sup> adoption.

- November 21 (mon) First read of resolution at Council meeting
- December 5<sup>th</sup> (mon) – Second read and adoption at Council meeting

All three agreed that changes to Griffin Ave/Griffin Road would be the next order of business after completing these streets.
