## Previous Minutes

## Spring Sports

Softball 7/8 - Sharing services for softball with Thetford Academy. Both us and Thetford were short players. Home games played at thetford, they will pay for ref, and home games here we will pay for refs. They will wear our uniforms, which we are all set with. Their players will play for free, less revenue, but fewer expenses too.

## Beach/Ball field Project

Abutters to pond, attorney has written letter to DES, stating they weren't notified of contingencies of the original 2009 permit being met. That reconsideration is being reviewed by DES now.

Rec Commission discussed this new action, and considers it just another ploy to just delay this project hoping we will just give up.

Our intention is to proceed with construction as soon as weather permits.

## Tennis Court/Basketball Court maintenance

The money for the Recreation Facilities Capital Reserve Fund, which included the repairs to the Tennis and basketball courts, was approved at Town Meeting. Couture will contact the firm who quoted the maintenance repair work for the courts at the pond recreation area. The proposal with Advantage Tennis will be signed and sent in. Our goal is to get on his schedule for as early as we can this spring.
