## RIVER ROAD REPAIR

Moderator Bill Waste called the meeting to order at 7:00pm advising attendants this was an informational meeting and that no decision(s) would be made. He instructed that comments be respectful and non-repetitive and that people listen with an open mind and present their comments fairly and without intimidation.

Former Selectman Richard Jones presented information gathered from traffic pattern assessments he continues to do.

Peter Holden from Holden Engineering presented slides and explanations of findings upon assessment of the River Road area of current concern. His comments included history of damage, what's been done to date to deal with the situation, and suggested solutions. Solutions included six (6) options ranging in broad scope of repair to closing the road. Options ranged in price from \$1,008,386.00 to \$42,631.00 based on figures provided by current DOT materials/labor/machine pricing.

Charles Ragan introduced Collis Adams, NH-Department of Environmental Services (DES) representative.

After it was clear the subject matter had been well covered, upon inquiry by Moderator Waste, it was suggested and agreed that the meeting had provided information and opportunity to be heard and that it would be adjourned at 9:10 pm.
