# Trustees of the Trust Funds **Meeting Minutes** November 17, 2011

PRESENT: Members – Peter Glenshaw, and Blake Allison

The meeting came to order at 4:25 p.m.

Marlene's absence meant that none of the previous meeting minutes could be approved because a quorum could not be achieved that involved the attendees for at each of the two meetings. . Peter was absent for the October 20<sup>th</sup> meeting, and Blake did not attend the September 15<sup>th</sup> meeting, causing approval of the September 15th minutes to be postponed. Similarly, with Marlene absent for this meeting and Peter having been absent in October, the October minutes could not be approved.

## **Fund Deposits**

• The meeting was spent primarily on the task of depositing into the appropriate trust funds, money that had been raised by the town's voters by approving Article 6 on the March 8, 2011 Annual Town Meeting Warrant. All but three checks were deposited in the corresponding NHPDIP accounts as follows:

Emergency Enrollment Cap. Res. Fund - \$50,000 (Check #000021484 from SAU #76/Lyme School District) – Acct. needs to be opened.

### 2. Other Business

- Selectmen Administrative Assistant Dina Cutting briefly appeared to discuss the above mentioned check deposits and disposition of the Bessie Hall Trust at year's end. Due to lack of time, it was decided to table the Bessie Hall discussion and take it up at the next Trustees meeting.
- Special Meeting Because depositing the above mentioned checks left insufficient time
  to address other pressing end-of-year concerns, it was decided to convene a special
  meeting of the Trustee of Trust Funds at the Town Offices on Tuesday, November 22,
  2011 at 4:30 p.m.
- **MS10 Filing** Blake reported that he had filed the Form MS-10 in person on October 24, 2011 at the Department of Revenue Administration in Concord, NH. Blake confirmed that the State has Form MS-9 already on file, and the required filings are now complete.
