CONSERVATION COMMISSION MEETING April 8, 2010 7:30 p.m.

<u>MEMBERS PRESENT:</u> Chair Mike Decubellis, Andy Roeper, Pauline Ball, and Sharon Slater

NEW BUSINESS:

Forest Management Plan

Andy Roeper made a suggestion that the ConCom consider developing a forest management plan for the town's conservation properties and to think about a timber cut on Putnam Pond conservation land which would help improve wildlife habitat on that property. He also acknowledged that the Curtiss Dogwood Park has not been reviewed in a number of years and trails should be opened and cleared.

The Commission agreed that a forest management plan may be a good project to discuss with Amber and Joe at Preserve Land Works. M. Decubellis agreed to contact them and invite them to a meeting.

Conservation Fund

M. Decubellis explained that the Lyndeborough Trails Group has applied for a grant to assist in the repair of the Highbridge Road bridge project. The amount of the grant is about \$30,000-\$50,000 and must be matched with cash and/or labor.

The Group has suggested that any donations that they receive should be tax deductible. Although the LTA is a registered corporation it is not allowed to collect tax deductible funds; therefore they have asked if the Conservation Commission if it would collect donations on its behalf so that they could be tax deductible to the donors. M. Decubellis reviewed the RSA's and contributions to the Commission are tax deductible and this project, the repair of the bridge is an allowable Conservation Fund expense. All Commission members unanimously voted to approve accepting funds for this purpose and to allow an equal amount to be sent to the LTA once fundraising is complete.
