Dennis Noe from TRITECH (parent company of IMC) gave a brief overview of the software and presented a quote for a three user program. The cost would be \$18,095 which is down from the original quote of \$21,995. The new quote is about the price of a typical one user program. While the Board agrees this reporting software would be a big improvement over the current program, the cost was not included in the 2011 operating budget for the PD. And there may be other needs of higher priority. The Board plans to share this information with Captain Burke. Any purchasing decision will have to wait until near year-end to see if there are savings from other places in the town operating budget that might allow an expenditure of this size.
