Mr. Boucher explained that he recently moved to Greenfield and met Building Inspector Peter Hopkins when building his home. Because of his interest in this trade, he began working on inspections with Mr. Hopkins. He attended a 1 day seminar; has been studying the building inspection manual and he's almost ready to apply for a license.

Presently his full time employment is with St. Joseph's Hospital in Nashua as a Maintenance Supervisor. He works closely on construction projects with in house crews and general contractors, electricians and plumbers and is familiar with building code regulations. He believes in following all safety rules and regulations and would like to work with people by helping them through the building inspection process. He prefers to show home owners how to complete a project the proper way and avoid enforcement issues because of compliance violations. He will be accessible through e-mail, cell phone/pager and because he has flexible hours at St. Joseph's, scheduling inspections will not be an issue.
