Fire Department Rescue Truck Purchase Update

Ratification of July 19, 2017 Conservation Commission Vote, Authorizing Expenditure of Funds (per RSA 36-A:4-a), Re: Map/Lot 206-003 & 212-002

The Selectmen reviewed the vote taken by the Conservation Commission on July 19, 2017, to contribute \$50,000 from the Conservation Fund to assist in the purchase of the Proctor property Map/Lot 206-003 and 212-002.

VOTE: Selectman Chamberlain made a motion, seconded by Selectman Schultz to ratify the vote of the Conservation Commission to expend funds on the assisting of a third party (PLC) in the purchase of the Proctor property Map/Lot 206-003 & 212-002 in accordance with RSA 36-A:4-a. Motion passed 3-0.

VII. Selectmen's Report

a. MACC Base Action & Agenda

T/A Boland presented the MACC Base agreement for 2018 to the Board. The Board reviewed the agreement and agreed MACC Base is providing excellent service to the town.

VOTE: Selectman Chamberlain made a motion. Selectman Schultz seconded the motion to sign the agreement with MACC Base for 2018. Motion passed 3-0.

b. Transportation Committee

c. Planning Board

The next meeting is December 21, 2017. Public notices for two public hearings have been posted in three public locations and on the town's website as well as in this week's the Milford Cabinet to review zoning changes for Home Business and Home Occupation plus Accessory Apartments. The Planning Board secretary announced there was no quorum for the November therefore no business was conducted.

d. Heritage Commission

The commission will meet in January.

e. Safety Complex & Other Options Committee

The Committee will meet on December 14, 2017 to finalize what they will bring to the Selectmen in preparation for their Town Meeting presentation.

VIII. Information Items Requiring No Discussion

The Board instructed T/A Boland to have the plaques at Citizens' Hall dedicating the trees in the Handicap parking area be removed for the winter.

IX. Non-Public Session RSA 91-A:3II (a & c)

VOTE: Selectman Schultz moved, Selectman Chamberlain seconded to enter a non-public session RSA 91-A:3II (a & c) at 6:30pm. Roll call, all voted in favor. Motion passed 3-0.

VOTE: Selectman Schultz made a motion, Selectman Chamberlain seconded to exit the non-public session at 7:33pm. Roll call, all voted in favor. Motion passed 3-0.

The Board announced that in non-public session they had approved an override of the Town's earned-time carry-over policy for an employee, due to extenuating circumstance outside of the employee's control. The situation will be reviewed in six months.

The Board announced that they had approved a tuition reimbursement request for an employee.

The Board had a discussion regarding the Police Department budget. The Board concluded the funds for the Winter and Summer Chief's conference should be removed from the budget.

Vote: Selectman Schultz made a motion, Selectman Chamberlain seconded to remove \$700 from the Police Department training line item, specifically the Winter and Summer Chief's Conference. Passed 3-0

The Board reviewed the need to increase the Police Department overtime line by 176 hours, due to the policy of paying employees who work on federal holidays time and a half for the hours worked. The Board also agreed the line item for part time officer wages can be reduced by 176 hours.

Vote: Selectman Chamberlain made a motion, Selectman Schultz seconded to increase the overtime line in the Police Department budget by 176 hours and to reduce the line for part time officer wages by 176 hours. Motion passed 3-0.

X. Adjournment:

All scheduled items having been addressed, the public meeting was adjourned at 7:45pm.

VOTE: Selectman Schultz made a motion, Selectman Chamberlain seconded to adjourn at 7:45pm. Motion passed 3-0.
