• Review and Approval of May 21, 2018 Meeting Minutes

The "name of the committee" was discussed and decision made to go with the wording "Street Light Study Committee" as it was published in the Warrant Article. Discussed removal of signature lines on minutes.

- Develop Dates to Meet with Eversource: Discussed meeting with Elizabeth Larocca and Paul Hausmann at Eversource and the date of June 25, 2018 was decided upon. Steve Brown to discuss logistics with T/A Russ Boland.
- Tour Current Lighting Locations: The intent of the Committee is to look at replacing incandescent and metal halide fixtures with LEDs. Review light locations and recommend removing, adding or relocating lights to improve safety and the character of the neighborhood. Factors to consider include cost of new fixtures, type of new fixtures and whether existing pole location is relevant today. The Committee should complete the report in October to incorporate lighting improvements into the operating budget or a Warrant Article. The Committee discussed type, color, direction and programing of the lights as well as signage. The Chair suggested that Committee's approach should be: every light should earn its way to stay where it is, then determine what light would work best there and evaluate the need to add lights.

We will reach out to Department Heads for their input. Consideration should also be given to residents who like the lights for walking in the village at night. The Committee felt the gas style electric lights be a reasonable expense and on posts not poles.

- Request information from LCS if there is a need to have lights for student's to walk to school since there are no sidewalks and only preschool and kindergarten are in this building..

- ➤ Steve Brown will check with T/A Boland regarding reaching out to Department Heads for Historical Data and to see if the two lights at the Fire Station are in the Committee's purview.
