Village Manager, Verrastro stated that the time limits and fees on certain meters in the Village have recently been changed and this proposed local law increases time limits on the meters that were one hour or 90 minutes to 2 hours.

On motion of Trustee Ryan, seconded by Trustee Hofstetter:

RESOLVED that Proposed Local Law 15-2007 be and hereby is enacted as Local Law No. 12-2007 and shall read as follows:

A Proposed Local Law amending Section 326-52 (Time Limits) of Article V (Metered Parking zones) of Chapter 326 (Vehicle and Traffic) of the Code of the village of Mamaroneck pertaining to Metered Parking Zones 9, 10(d), 13, 14, 15, 16(a) and 16(b) located at Mamaroneck Avenue, Halstead Avenue, West Boston Post Road and East Boston Post Road.

Be it enacted by the Board of Trustees of the Village of Mamaroneck as follows:

- **Section 1.** Subsection L of Section 326-54 (Fees) of Article V (Metered Parking Zones) of Chapter 326 (Vehicles and Traffic) of the Code of the Village of Mamaroneck is hereby amended by increasing the maximum time limits and shall read as follows:
 - L. A fee of \$0.25 for 30 minutes, or any fraction thereof, for a maximum of 2 hours, is hereby established for parking in Metered Parking Zones 16(a) and 16(b), and in the first through sixth spaces commencing from Sheldrake Place in Metered Parking Zone 2(b).
- **Section 2.** Subsection M will be added and will read as follows:
 - M. A fee of \$0.25 for 20 minutes or any fraction thereof, for a maximum of 2 hours, is hereby established for parking in Metered Parking Zone 10(b).
- **Section 3.** Subsection N will be added and will read as follows:
 - N. A fee of \$0.25 for 20 minutes or any fraction thereof, for a maximum of 2 hours, is hereby established for parking in Metered Parking Zones 9, 10(d), 13, 14 and 15.
- **Section 4.** If any section, subsection, clause, phrase or other portion of the Proposed Local Law is, for any reason, declared invalid, in whole or in part, by any court, agency, commission, legislative body or other authority of competent jurisdiction, such portion shall be deemed a separate, distinct and independent portion. Such declaration shall not affect the validity of the remaining portions hereof, which other portions shall continue in full force and effect.
- **Section 5**. This Local Law shall take effect immediately upon filing in the office of the Secretary of State in accordance with Section 27 of the Municipal Home Rule Law.
