PRESENTATION BY POLICE DEPARTMENT - COMMUNITY SERVICES UNIT

Sergeant Eric Lindh, Police Officer Sandra DiRuzza, Domestic Violence and Youth Officer and Officer Ozzie Ramos, Youth Officer, gave a Power Point presentation on the work that the relatively newly formed, Community Services Unit (CSU) of the Police Department is doing.

Sergeant Lindh gave a background on the Unit and their Mission. He stated that the Unit was created to reach out to the community and make them aware that there are Officers specifically trained to handle domestic and youth related issues. There are eight officers in the Unit, including five bicycle officers. He touched on the different programs the Unit is involved in, i.e., child safety seat installation, the D.A.R.E. program, outreach programs and working with the schools on issues that affect the youth of our Village.

Police Officer DiRuzza spoke about domestic violence and the training she has received to handle these situations. She informed the Board and residents what CSU does to help victims of domestic crime and the resources available to them.

Officer DiRuzza then spoke about the programs offered for the youth of the Village and how they work on safety issues, i.e. stranger danger, safe ways to use the Internet, operation safe smiles- where kids' fingerprints and DNA information is taken, how to get to school safely and visiting the schools to talk about trick or treating safely. There is a Bicycle Rodeo conducted by officers at the schools where they talk to the students about safe bike riding and fit them for helmets and other safety gear. Officer DiRuzza gave an overview of a program created to work with the elderly in conjunction with the Chamber of Commerce. She is also working with the Hispanic Resource Center on the issue of domestic violence. Officer DiRuzza informed residents that there is information on domestic violence outside of the CSU office door on the second floor of the police headquarters; therefore, if there is someone who is having a problem or knows someone who is, they can come by and pick up information without ever going into the CSU office.

Sgt. Lindh talked about R.A.D.A.R., which is a program made up by high school officials, residents and members of the police department, which deals with alcohol and drug issues. He also spoke about the bicycle unit, which is an integral part of the Community Services Unit. Sgt. Lindh spoke about the many benefits of having a Community Services Unit here in the Village. He also gave the contact numbers for the Unit, which will be posted on the Village website. Sgt. Lindh mentioned that he sees many kids just hanging around the streets after school and as it is said, "It takes a village to raise a child", this is something that needs to be looked at with the offering of programs and facilities for our youth. There will be a meeting coming up involving residents concerned about this problem. Sgt. Lindh invited any and all residents who would like to attend to please contact him.

A resident inquired as to why the D.A.R.E. program ends with the sixth grade, as middle school students could greatly benefit from this program. Officer DiRuzza stated that there are programs geared more towards middle and high school and the issue in this community is that middle and high school students have very rigorous schedules and it would be difficult to fit a 12-week program into those schedules. The upper level schools also offer health classes that cover many of the issues covered by D.A.R.E. The CSU unit did send out letters to school administrators offering seminars on issues prevalent in their schools that they may avail themselves of.

Mayor Savolt thanked the Officers for their work on behalf of the community.

1. COMMUNICATION TO THE BOARD

Ms. Ellen Hauptman of Chestnut Avenue and Ms. Peggy Jackson of James Street appeared to ask the Mayor and Village Manager about a meeting they had six months ago to which they were awaiting answers. The Mayor apologized for not getting back to them; however, she was waiting for additional information. She does have answers on some of the questions which she will send to them by the end of the week. Ms. Jackson asked that a community flood update be held. The Mayor informed Ms. Jackson that the editor of the Sound & Town has offered her a regular column in their publication and her first column gave an overview on what the Board is working on. Her next column will be a flood update as she is meeting with the Army Corps of Engineers, and County and State Officials on Wednesday, October 29th. Village Manager Verrastro stated that there will be a Flood News page on the new Village website. Ms. Jackson also asked when all of the neighborhood associations will be meeting together. Mayor Savolt informed Ms. Jackson that she wants to meet with all of the associations individually before having a group meeting. There are still some organizations that she knows exist and have not yet reached out to her. The Mayor asked that if there are any neighborhood associations that have not yet met with the Board, Village Manager and Police Chief, to please contact her office.

5. NEW BUSINESS

A. Resolution to Increase 2009 Harbor Island Beach and Parking Fees

Mr. Verrastro requested that this item be tabled as there is information needed from the Recreation Supervisor before moving forward.

B. Transfer of Funds – Veggie Truck

Mr. Verrastro reported that at the request of the Committee for the Environment and the Board of Trustees, Tony Iacovelli, General Foreman was requested to investigate the conversion of one of our DPW vehicles to run on Veggie oil, similar to what has been done by several other communities. This would save the Village approximately 60 gallons of diesel fuel per week at \$2.97/gallon. Therefore, this conversion would pay for itself in approximately two years. If the Board approves, the amount for the conversion would need to be transferred to the Sanitation Department from the Contingency Account.

Based on information obtained by Tracy Schmaling, our Lead Maintenance Mechanic, the cost to convert one of our sanitation trucks, including the equipment to process the oil will be approximately \$15,000.

If the above transfer is approved, a balance of approximately \$115,000 will remain in the Contingent Account, excluding the additional funds allocated by the Board.

Trustee Ryan believes this is a "home-run". It can be a real community project with having school children participating by collecting cooking oil, as was done during World War II. She also believes it will pay for itself and is something the Village needs to do. Trustee Hofstetter agrees and believes that it could be educational for children to participate. Trustee Hofstetter asked about the truck being converted. Mr. Verrastro stated that it will be done on an older, less fuel-efficient sanitation truck.

Trustee Murphy asked where the Village will get the oil. Mr. Verrastro informed him that according to Mr. Iacovelli, some food establishments are getting paid for their used oil; however, we are trying to obtain donated oil.

Mayor Savolt hopes that this is the beginning of Mamaroneck being a model environmental Village where other municipalities look to us for our leadership. She would also like to see a place where residents can bring their used vegetable oil for use in the vehicle and not pour it down the drain.

Trustee Robinowitz agrees that this is exactly the direction in which we need to go.

The Board thanked Mr. Tracy Schmaling for taking the initiative in this matter.

An agreement was received from the Westchester County Clerk to provide remote access to the Public Viewer for Land and Legal Records which allows the Village access to information and/or images of a variety of records maintained by the County Clerk's office. This agreement would provide for up to four annual extensions. Authorization from the Board is required for the Village Manager to execute this agreement.

E. Declaration of Lead Agency – Mamaroneck Train Station Building

Mr. John Verni of Parkview Station, the owner of the Property, appeared to inform the Board that they have met with the Planning Board and are due to go before the Zoning Board of Appeals next week and the Harbor and Coastal Zone Commission on November 19th. He hopes that the Board will adopt the resolution naming itself lead agency and that a public hearing on the re-zoning of the property can be scheduled at the next meeting.

Ms. Insardi reminded the Board that a circulation letter had been prepared and sent to all involved agencies on September 25th. At this point, no objections to the Board declaring lead agency status have been received. In fact, the only letter received was from the County. It was in favor of the rezoning. This letter has been filed for the record. At this time, the Board can assume lead agency status in connection with the SEQRA review of the Mamaroneck Train Station Rezoning project.

Ms. Insardi also suggested that a public hearing be set at the next meeting scheduled on November 10, 2008.

WHEREAS, the Board of Trustees directed that a lead agency coordination letter be circulated among the various involved agencies together with the Petition for a zone change, including the EAF and any other application or information prepared and submitted by the applicant to date; and

WHEREAS, the coordination letter was sent on or about September 25, 2008 and no objections have been received.

NOW, THEREFORE, BE IT RESOLVED that the Board of Trustees is the lead agency in connection with the SEQRA review of the Mamaroneck Train Station Rezoning project.

F. Schedule Public Hearing on PLL 11-2008 – Code of Ethics

Trustee Hofstetter reported that this is something that the Board has been looking at since he was elected, unfortunately, there was not much cooperation from the Village Attorney at that time. At that time, Greenburgh had put forth a more in-depth ethics code and they asked the Village Attorney at the time to use this as a model, incorporating pieces into the Village's proposed code. Again, not much was done. Ms. Insardi, as Village Attorney, has drafted a proposed code as well as disclosure statement for the Board's review.

Mayor Savolt thanked Ms. Insardi for all of her work on this and for educating the Board on what other communities are doing as far as their ethics law is concerned. She feels that what has been crafted is exemplary and will be a model for other municipalities; Harrison has already asked for a copy. The Mayor also announced that this will reconstitute the Ethics Board. She asked residents interested in serving on this Board, to please contact one of the Board of Trustee members.

G. Authorization – Harbor Fest 2009

Mr. Verrastro stated that Ms. Jennifer Graziano recently attended a work session and submitted a proposal to the Board outlining the 2009 Harbor Fest at Harbor Island. This idea was originally suggested by The High Road, the event planner who coordinated the last Historic Harbor Street Fair and also coordinates the Norwalk Oyster Festival. As this is a self sustaining event, it was suggested to run it over two days, a Saturday and Sunday and as it would be very expensive to close Mamaroneck Avenue for two days, it was decided the best venue would be at Harbor Island Park. Mr. Verrastro asked that the Board authorize the use of Harbor Island Park on May 16 and 17, 2009, resolve that the funds in the Historic Harbor Street Fair Trust Account be utilized for this event and appoint Jennifer Graziano and Leonard M. Verrastro (effective with his retirement as Village Manager) as Co-Chairpersons for Harbor Fest 2009.

Ms. Jennifer Graziano appeared before the Board to expand on Mr. Verrastro's comments. She informed the Board that this event will be similar to the Norwalk Oyster Festival with two days of concerts, crafts and artists. She also stated that this in no way is meant to detract business from the Mamaroneck Avenue merchants and she, working as part of the Mamaroneck Chamber of Commerce,

will do everything they can to direct patrons to the Avenue to shop and dine. Ms. Graziano gave her

contact information for any residents interested in volunteering.

May 16 and 17, 2009 in connection with holding the first Mamaroneck Harbor Fest; and

I. Consolidation of Community Services Program

Mr. Verrastro previously distributed for the Board's review with the work session agenda, the

memorandum, organizational charts, proposed operating budget as of January 1, 2009 and the chart of

required actions and timeline prepared by Anna Danoy in connection with the proposed consolidation of

our Community Services and Senior Programs with the Town of Mamaroneck.

Several meetings have been held with the Town staff in discussing and outlining the structure and

procedures to accomplish the consolidation. Steve Altieri, Town Administrator and Mr. Verrastro have

also spoken with the seniors at the Village's Senior Center and met with the staff.

Mr. Verrastro strongly believes that the consolidation, as stated in Ms. Danoy's memo will extend

many additional activities and opportunities to Village of Mamaroneck residents and also offer our

nutrition program to Larchmont and Town seniors. He also stated that with this consolidation, the

Village of Mamaroneck will save approximately \$200,000 per year.

In order to proceed, the Board needs to adopt a resolution approving the proposed plan

consolidating these programs.

Mayor Savolt stated that this came to her attention over a year ago while she was campaigning.

Many seniors told her that as they appreciated the hot meals offered weekdays, they would like more

activities and mental stimulation. They also need a place to go for outreach programs.

Trustee Ryan was able to sit in on the talks regarding the consolidation and she feels very

comfortable about it, as it will afford the Village seniors many more activities.

Trustee Hofstetter asked about the nutrition program. Mr. Verrastro stated that as the meals are

catered at the Town, all that has to go over to the new center are the steam tables. He also stated that the

kitchen at the Town will be renovated.

Trustees Murphy and Robinowitz also are very much in favor of this and thanked Mr. Verrastro for

all of his work on this effort.

On motion of Trustee Robinowitz, seconded by Trustee Murphy:

RESOLVED that the Board of Trustees be and hereby approves the proposed plan for the

consolidation of the Town of Mamaroneck and Village of Mamaroneck Community Services and Senior

Citizen Programs; and

RESOLVED that the Village in connection with the consolidation authorizes the transfer of any

contracts with Westchester County for the funding of the various programs and services to the Town of

Mamaroneck for the continuation of said programs; and

Mamaroneck, including the assignment of contracts, transfer of personnel and he be designated the

liaison to the Town of Mamaroneck.

II. COMMUNICATON TO THE BOARD II

Mr. Irving Scharf suggested having local real estate companies market their properties for sale at the 2009 Harbor Fest.

Trustee Murphy announced that a meeting was held on October 21st with the Chairs of the land use boards, Trustee Ryan, Ms. Insardi, Mr. Verrastro, Mr. Fusco, Mr. Winter and Ms. Kathy Zalantis, of Silverberg Zalantis, Attorney to the ZBA.
