RESOLVED that Proposed Local Law 4-2008 be and hereby is enacted as Local Law No. 4-2008 and shall read as follows:

## **LOCAL LAW NO. 4-2008**

A Local Law known and cited as Amendments to Metered Parking Regulations, \$326-52 and 326-54, of the Village Code.

Be it enacted by the Board of Trustees of the Village of Mamaroneck as follows:

**SECTION 1.** Purpose and Intent. The purpose of this local law is to amend certain fees and time limits for Metered Parking Zones 12, 16(a), 16(b) and 17.

**SECTION 2.** Chapter 326 is hereby amended as follows:

- a) Amend Section 326-52 (B) to delete Metered Parking Zone 17 to read: The parking of vehicles in Metered Parking Zones 5, 6, 10(b), 13, 15, and 22, established by this article, for a period in excess of one hour is prohibited.
- b) Amend Section 326-52(C) to add Metered Parking Zones 16(a), 16(b) and 17 to read: The parking of vehicles in Metered Parking Zones 10(c), 11, 12, 14, 16 (a), 16 (b), 17 and 20, established by this article, for a period in excess of two hours is prohibited.
- (c) Amend Section 326-52 (F) to delete the reference to Metered Parking Zone 16(a) and 16(b) to read: The parking of vehicles in Metered Parking Zones and 10(d) and in the first through sixth spaces commencing from Sheldrake Place in Metered Parking Zone 2(b), established by this article, for a period in excess of 90 minutes is prohibited.
- (d) Amend Section 326-54 (C) to delete the reference to zone 17 to read: A fee of \$0.05 for a minimum of 10 minutes, \$0.10 for 20 minutes or \$0.25 for 60 minutes, or any fractions thereof, for a maximum of one hour is hereby established for parking in Metered Parking Zones 6 and 22.
- (e) Amend Section 326-54(F) to delete the reference to zone 12 to read: A fee of \$0.25 per hour for a minimum of one hour, or any fraction thereof for a maximum of two hours, is hereby established for parking in Metered Parking Zone 11.

(f) Amend Section 326-54(K) to delete the reference to Metered Parking Zones 16(a) and 16(b) to

read: A fee of \$0.25 for 30 minutes, or any fraction thereof, for a maximum of two hours, is

hereby established for parking in the first through sixth spaces commencing from Sheldrake

Place in Metered Parking Zone 2(b).

(g) Amend Section 326-54(N) to add a reference to Metered Parking Zones 12,

16(a), 16(b) and 17 as follows: A fee of \$0.25 of 20 minutes, or any fraction

thereof, for a maximum of two hours, is hereby established for parking in

Metered Parking Zone 9, 10(d), 12, 13, 14, 15, 16(a), 16(b) and 17.

SECTION 3: SEVERABILITY. If a court of competent jurisdiction declares any portion of this local law

illegal or unconstitutional such declaration shall not prevent the enforcement of any other portion of this local

law.

SECTION 4. Effective Date. This Local Law shall take effect immediately upon filing in the office of the

Secretary of State.
