2. Draft Proposed Local Law to Address License Agreements

This is a matter that has been a concern to the Building Department, Village Attorney and Manager. The draft proposed local law will lay out a rational approach to all of these issues, related to the driveways, retaining walls, fences, stairways, and any other structures placed on or next to roads on Village rights-of-way. The Board asked that wing walls are covered to preserve grade. The fees were discussed. It was suggested that the fees not be part of the law, but part of the fee schedule so that they may be changed without having to change the law.
