PRESENTATION OF FINANCIAL STATEMENT

Mr. Dominick Consolo of Bennett Keilson presented the Fiscal Year 2007-2008 Village of Mamaroneck Financial Statement to the Board. Mr. Consolo reviewed the year-end figures in the General Fund, the Capital Projects Fund, the Water Fund and Debt Service. He also reviewed the Fund Balance, Revenue and Expenditures of the Village. He stated that the Village is in great financial condition.

As the Board Meeting was not yet being televised, the Board decided to continue with the agenda until such time as LMC was available to air presentations.

4. OLD BUSINESS

A. Replacement of Gunderboom

This item was tabled from the January 12 meeting as more information was requested. Assistant Village Manager, Robert Yamuder reported that the Gunderboom has outlived its useful life and with the previous repairs done to it has been in use for six years. The Department of Health has notified the Village that if the Gunderboom is not in place, it is unlikely that swimming will be allowed at Harbor Island Beach. Mr. Yamuder informed the Board that the Village will receive a discount if we purchase soon.

Trustee Ryan stated that she is in favor as this the filter has promoted swimming at the beach and Gunderboom is the only company that makes such a filter. Trustee Hofstetter is also in favor as this new system has panels that can be removed and replaced in the event they are damaged without having to replace the entire filter. Trustee Robinowitz stated that the technology of the fabric has changed in the last 10 years and therefore the life of this filter will be longer. Trustee Murphy is in favor of having this in place allowing swimming and the addition of the spray ground have helped to revive the beach. Mayor Savolt stated that she was a Trustee when the Gunderboom was damaged by an oil spill and the beach was closed. Without the filter, the inability to use the beach for swimming hurt the Village and she is fully in favor of its replacement. The Mayor also stated that the next piece of legislation being worked on will help with lowering of bacteria levels of the Sound and is a code that will address impervious surfaces.

On motion of Trustee Murphy, seconded by Trustee Hofstetter:

RESOLVED that \$200,000 be and is hereby appropriated in the Capital Projects Fund for the purchase and installation of a new 800Gunderboom aquatic filter barrier for the 2009 swimming season, including a review of any design adjustments to account for changes in water depths, and

Be it further RESOLVED that the financing in the amount of \$200,000 for this project will be included in the future adoption of the required bond resolution.

As LMC was prepared to go live, the presentation scheduled for the beginning of the meeting were presented.

PRESENTATION MARKING VILLAGE MANAGER RETIREMENT

Mayor Savolt stated that there was a party held the previous week for retiring Manager, Len Verrastro by his friends and family. The Village wanted to officially mark his 28-year career with the Village by holding a reception for him before tonight's meeting officially began. The Mayor honored Mr. Verrastro and presented him with a Congressional Proclamation and gifts from the community. The Mayor announced that Mr. Verrastro's last day of service, January 31, shall now and forever be known as Len Verrastro Day in the Village of Mamaroneck.

A letter from Justice Lanza was read by the Mayor as he could not be present. Trustee Murphy read a letter from Former Mayor Paul Noto who could also not attend the reception.

Mr. Verrastro thanked the Board, the staff and all the residents for their support and their work on behalf of the residents. He also thanked the Volunteer Fire Department for their dedication and all of the volunteers who give up their time serving on boards and committees. He also thanked the residents for the privilege to serve them these past 28 years.

Mr. Verrastro passed on his Village pin to the in-coming Village Manager, Richard Slingerland.

PRESENTATION ON WESTCHESTER COUNTY TAX RELIEF FOR VOLUNTEERS

County Legislator Judy Myers reported on a law that was just passed in the County of Westchester providing real property tax exemptions to volunteer fire fighters and ambulance workers. This is a 10% exemption of assessed valuation of County taxes, but does not include sewer taxes. This applies to all volunteer fire fighters and volunteer ambulance workers who have five or more years of service and they reside in the village that is served by the fire department or ambulance service and have no more than four professional workers in their service. Ms. Myers was honored to vote in favor of this exemption that pays these men and women back in a small way. There is also a credit for fire fighters and ambulance workers who have been permanently disabled in the line of duty and a life time exemption for those who have accrued 20 or more years of active service. There is also an additional exemption for an unmarried spouse of a deceased member of either of these services, killed in the line of duty. A form needs to be filed with the Assessor's office by May 1 for Town of Rye residents and June 1 for Town of

Mamaroneck residents. Ms. Myers asked that if any one has questions to contact her office or their local Town Assessor's office.

5. NEW BUSINESS

A. (1) Appointment of Acting Village Manager

In connection with Mr. Verrastro's retirement as Village Manager effective January 31, 2009, the Village Board will need to appoint an Acting Village Manager until the new Village Manager, Richard Slingerland begins his employment with the Village as of March 23, 2009.

The Village Code requires that the appointment of an Acting Village Manager be a full-time employee, therefore it has been recommended that Robert Yamuder, Assistant Village M anager be appointed.

C. Authorization for Harbor Fest Sponsorship

Ms. Jennifer Graziano, Harbor Fest Co-chair presented this item to the Board. In connection with the Harbor Fest to be held at Harbor Island on May 16-17, 2009, due to the current economic climate, the Harbor Fest Committee is very concerned about obtaining sufficient sponsors to support the event. In the past, the prior Streetfair Committee relied on automobile dealerships and banks as the main sponsors, however both have been seriously affected by the economic downturn and have reduced their budgets for this type of community events.

The Fund Raising Chairperson and the event planner, The High Road, Inc. have both recommended that the Harbor Fest seek funding and a sponsorship from a beer company, since they are still participating in and sponsoring these types of events. Ms. Graziano stated that beer will not be sold by the food vendors; in fact, it might not be sold at all. However, if the sponsors require that beer is sold, it will be tightly monitored and only at a few locations. There will be specific guidelines for volunteers who are serving beer. Ms. Graziano is willing to work with DARE and any school or parental organizations to answer their questions or concerns.

The High Road, Inc., who also plans the Norwalk Oyster Festival stated that the sale of beer would be very controlled and there have never been any serious problems at the Oyster Festival.

Based on the consensus of the Board at the January 12th work session, a resolution authorizing the

sale of beer at the Harbor Fest has been prepared for the Board's approval.

Trustee Murphy has a philosophical problem with soliciting beer and/or alcohol at an event held

at Harbor Island Park as there is a code prohibiting alcohol consumption at any park in the Village. He is

concerned that this can be a slippery slope.

The other Board members understand Trustee Murphy's concerns; however, they believe that this

can be done safely and responsibly.

Village Attorney Insardi informed the Board that according to Section 92-7 of the Village Code,

the serving of alcohol is permitted in a park with the special permission of the Village.

Trustee Hofstetter thanked Mr. Verrastro for dealing with the residents and staff with such grace and fortitude and also wished him well in his retirement.

Trustee Murphy reminded residents that the School Bond vote will take place on Tuesday, February $10^{\rm th}$ at your local grammar school.

Trustee Murphy stated that in addition to all of Mr. Verrastro's accomplishment noted by former Mayor Noto and Mayor Savolt, what most people don't see are the hundreds of acts of kindness shown toward Mamaroneck residents. He thanked Len for being a friend and mentor and he will be sorely missed.

Trustee Robinowitz reported that the Recreation and Parks Commission is close to an agreement with the Rye Neck School Board on holding the Village's summer camp at Bellow's school. She also reported that the junior sailing program, which was on a temporary hiatus, will be back this summer. Ms. Robinowitz asked residents if they are interested in working on a committee to brainstorm on teen programs, to please contact her.

Trustee Robinowitz has known Mr. Verrastro for years and had the unique experience of attending a NYCOM seminar in Albany with him this past year. She reported that not only is he loved in the Village of Mamaroneck, but loved by people throughout the state.

Mayor Savolt thanked Mr. Verrastro for all he has done for the Village and for her. Although she hasn't known him her whole life, it felt that way to her as soon as they met and she will miss him.
