## 1. COMMUNICATION TO THE BOARD

Ms. June Ottinger of The Crescent appeared. Ms. Ottinger was at the meeting in reference to correspondence that was sent to the Board from her engineer, Leonard Jackson Associates dated November 4 and November 9, 2009. This correspondence is regarding the Letter of Map Revision (LOMR) prepared by Leonard Jackson Associates and approved by FEMA. Ms. Ottinger asked that the Village adopt the approved LOMR and not allow this to be subverted by a neighbor's objections.

A. Resolution for Standardized Source Certificate – Excelsior Garage

Mr. Slingerland stated that this is something that came up during the audit process. There are provisions under state law that allows the Village to designate a standardized source if they meet certain requirements, which Excelsior Garage does.

#### DETERMINATION OF STANDARDIZED VENDOR FOR FIRE APPARATUS MAINTENANCE AND SERVICE AS MANUFACTURER'S AUTHORIZED DEALER

On motion of Trustee Ryan, seconded by Trustee Hofstetter:

WHEREAS, the Excelsior Garage at 904 Mamaroneck Avenue has been the Village's selected vendor to service fire apparatus due to the fact that they are the Seagrave Fire Apparatus manufacturer's authorized dealer and service provider, which constitutes approximately half the Village's fire apparatus fleet. They are also the authorized service provider for Pierce, RD Murray/Spartan and Sutphen; and

WHEREAS, since Excelsior Garage is an authorized service provider for these vehicles, and operates within the Village of Mamaroneck's municipal boundaries which saves the Village on travel and transportation of vehicles in the event of failure or emergency.

NOW, THEREFORE, BE IT RESOLVED, that for reasons of efficiency and economy, and the fact that they are an authorized service provider for all of the Village's fire apparatus (which protects and preserves the warranties for these vehicles), that the Excelsior Garage at 904 Mamaroneck Avenue is hereby designated as the Village's standardized vendor for these services.

C. Authorization of Change Order – Shaw Environmental Taylors Lane Site Evaluation

Mr. Slingerland stated that due to the results of the tests conducted on the Taylors Lane site by Shaw Environmental, the DEC determined that additional tests needed to be done. Mayor Savolt stated that 75% of the fees paid in relation to the Taylors Lane evaluation will be reimbursed by the state.

#### RESOLUTIONAUTHORIZING CHANGE ORDER FOR SHAW ENVIRONMENTAL INC. FOR ADDITIONAL SERVICES AND TESTS REQUIRED BY THE NYS DEC

WHEREAS, the Village of Mamaroneck, along with the Mamaroneck School District, Rye Neck School District, the municipalities and school districts in the City of Rye, the Town of Harrison, Town of Mamaroneck, Village of Larchmont, are members of the Activate America Coalition, spearheaded by the Rye YMCA; and

WHEREAS, the Activate America Coalition is desirous of combating obesity, and we are committed to the same goals as Activate America since we are a member of the Activate America Coalition; and

WHEREAS the Village of Mamaroneck and Rye YMCA will finalize the Memorandum of Agreement;

RESOLVED, that the Village Manager is hereby authorized to execute said renewal agreement.

Mr. Slingerland reported that the approval for the stream clean up permit from the Army Corps of Engineers is being filed for the record with the Clerk-Treasurer's office.

## 7. \_\_FLOOD MITIGATION REPORT

Mr. Slingerland reported that he has finally talked with the County Department of Public Works who are reviewing the stream cleaning permit submitted to the County. He also gave them a copy of the Army Corps approval, as it is a coordinated review. The DEC informed Mr. Slingerland that they cannot find the original letters and packages sent to them regarding the stream clean up project. His staff reproduced everything and it was resent. He will continue to follow up with them.

Mayor Savolt gave an update on the meetings in Scarsdale. She attended the Planning Board meeting and testified in reference to two projects there. The Parloto subdivision on Mamaroneck Road was approved but major changes to the site plan were made, keeping the wetlands intact. There is a new project on Garden Road. The Village will send a letter asking that the Village be considered an interested agency as this project is where the Sheldrake River begins.
