# MINUTES OF A REGULAR MEETING OF THE BOARD OF TRUSTEES OF THE VILLAGE OF MAMARONECK HELD ON MONDAY, NOVEMBER 8, 2010 AT 7:30 P.M. IN THE COURTROOM AT VILLAGE HALL, MAMARONECK, NEW YORK

Deputy Mayor Santoro announced that Mayor Rosenblum is out of the country on business and therefore he will be conducting the meeting.

The Village Attorney arrived at 7:35 p.m.

#### 1. COMMUNICATION TO THE BOARD

Dr. Charles Morelli of Beach Avenue appeared on the Pine Street issue. Dr. Morelli wanted to discuss the temporary Certificate of Occupancy issued on 12/16/02. In August of 2009, there were a series of letters from the Village Attorney and Building Inspector regarding the temporary C of O. Dr. Morelli read from a letter written to the developer by Mr. Winter, Building Inspector stating that if steps were not taken to remedy the drainage issues to the Village's satisfaction, the temporary C of O would be revoked. Dr. Morelli also had a copy of a letter from Mr. Slingerland to the developer echoing the same sentiment. Shortly thereafter, the Village Attorney stated in a letter written to the attorney for the developer that she would refrain from responding to each and every baseless claim because the facts of this case are so clear. There was another letter sent to the attorney for the developer in March 2010 by Mr. Winter stating that the developer was issued a temporary Certificate of Occupancy and if all improvements are not made he will be forced to revoke the C of O. Dr. Morelli believes that the temporary C of O was issued in error as there was no end date. Dr. Morelli read from a document he printed on temporary Certificates of Occupancy from the State's Department of Code Enforcement that states that the temporary C of O must be limited to a specific period of time and that the developer must be required to bring the structure into compliance with the code during that time. A local government's code enforcement department must provide that a temporary C of O issued in error (and he believes that this one was as it had no end date), shall be suspended or revoked. He asked why the Temporary

Certificate of Occupancy cannot be revoked at the same time a new Temporary Certificate of Occupancy with an end date is issued.

Ms. Derrico stated that she cannot speak for Mr. Winter and that the Board of Trustees has been advised of the issues and they will take the steps they feel necessary. She also stated that this sitting Board cannot be held responsible for past Board's inactivity and that this Board has to weigh all the facts and make a determination in conjunction with the Building Inspector.

Dr. Morelli asked what the Board is going to do about this. Trustee Santoro stated that the Board should meet with the Building Inspector and Village Attorney to discuss this issue. Trustee Ryan stated that she feels this should happen at the next work session and that Dr. Morelli should be present. She also stated that she does not know all of the options. Trustee Hofstetter asked that at that meeting the Board be informed if pulling a temporary certificate of occupancy has been done in the past. Ms. Derrico reminded the Board that no matter what course of action they choose, there will most likely be litigation.

Mr. Stuart Tiekert of Beach Avenue appeared. He came before the Board two or three meetings ago as he was concerned that the Village Engineer is rewriting Village law regarding Pine Street as Mr. Furey has claimed that the Planning Board resolution was changed by a single member after the fact. The first time Mr. Tiekert brought this up the Board promised that it would be taken up and the second time he brought it up, the Mayor promised him that it would be discussed at the next work session. Trustee Santoro informed Mr. Tiekert that this matter was not on the work session agenda and not discussed. He asked why this has not been discussed by the Board of Trustees and as the Planning Board is about to issue a resolution on Mamaroneck Beach and Yacht, he believes that the resolutions should stand for something and should not be changed randomly. He believes that this is an integral part of the Pine Street situation and if the Board meets on Pine Street, this should be included. Ms. Derrico assured Mr. Tiekert that this has not been ignored and that the Board has discussed this issue at almost every work session since she has been Village Attorney. Mr. Tiekert believes that the Village Attorney should be looking at the comment by Mr. Furey as he believes that this is a legal issue. Ms. Derrico stated that Mr. Furey can make comments and that the Board can or cannot accept these opinions. Trustee Santoro again stated that he will ask that this issue be added to the next work session agenda.

Ms. Sue McCrory of The Crescent appeared. Ms. McCrory asked for more due diligence and fiduciary oversight by the Board on the MBYC settlement. Ms. McCrory looked more closely at the settlement after receiving an unsolicited email by the Mayor explaining why the Board approved the settlement. She is shocked

that the settlement has the Village giving \$825,000 to a corporate entity that does not exist. She has checked and could not find any evidence of their existence and also received confirmation from the Department of State that this entity does not exist. She is unable to confirm the existence of the other two entities listed as doing business as the Mamaroneck Beach and Yacht Club. The final curiosity is that the owner of the property is nowhere named in the settlement. She also checked the IRS form 990 for the not for profit Mamaroneck Beach & Yacht Club, Inc. and this club reported revenues and expenses of \$116,000 with no employees, no staff, no bill for heat and light.

Trustee Ryan also had a question on the water main charge at 160 Mt. Pleasant Avenue. Trustee Santoro informed her that it should read 169 Mt. Pleasant and that was to change out the water line coming into the building. In answer to the flag question, Mr. Slingerland will double check to make sure that they are not duplicates; however, he believes that this was a large order that was split between departments.

B. Resolution to Limit the Planting of Trees to Kwanzan Cherry Trees in the Harbor Island Cherry Grove

RESOLUTION TO LIMIT THE PLANTING OF TREES IN THE HARBOR ISLAND STAND OF CHERRY TREES TO KWANZAN CHERRY TREES

WHEREAS, the Village of Mamaroneck Tree Committee at their September 7, 2010 meeting discussed limiting the planting of trees to only Kwanzan Cherry Trees that may be planted in the stand of Cherry Trees at Harbor Island Park; and

WHEREAS, upon consideration the Tree Committee unanimously adopted this recommendation, based on the rationale that the Village should continue to support the stand of cherry trees as one of the defining aspects of Harbor Island Park; and

WHEREAS, this area of cherry trees extends from Orienta Avenue to the Westchester County Sewage Treatment Plant.

NOW, THEREFORE, BE IT RESOLVED that the Board of Trustees of the Village of Mamaroneck hereby supports and adopts the recommendation of the Tree Committee to preserve, and only plant Kwanzan Cherry Trees in the stand of cherry trees between Orienta Avenue and the Westchester County Sewage Treatment Plant; and

BE IT FURTHER RESOLVED, that the Village will look into the possibility and expense of relocating any other non-cherry trees to other locations within the park, so as to restore the consistency of this stand of cherry trees.

E. Resolution Authorizing the Award of Contract 2010-08, DPW Dump/Plow/Salt Truck

#### **RESOLUTION RE:**

AWARDING CONTRACT 2010-08 - FURNISH & DELIVER ONE (1) PLOW/SALT/DUMP TRUCK

WHEREAS, an item identified in the FY 2010/11 Capital Budget & Plan is the purchase of a new plow/salt/dump truck and accordingly, staff prepared bids and specifications for Contract 2010-08 – Furnish & Deliver One (1) Plow/Salt/Dump truck; and

WHEREAS, the Village Manager reports that he publicly advertised for the receipt of bids and sent notice of such contract to eight (8) vendors; and

WHEREAS, on the bid opening date, two (2) sealed bids were received with the lowest responsible bid received from Gabrielli Mack Sales & Service, 333 Conner Street, Bronx NY 11716 in the amount of \$196,400; and

WHEREAS, a lower-cost bid in the amount of \$194,887 was submitted by Trius, Inc., equipment and truck sales of Bohemia, NY, but this bid did not meet all specifications, in particular the truck body was one foot or 10% shorter than specified, many components of the truck chassis did not meet specifications, and the snow plow and plow frame bid are not as specified and are products that have been problematic for the village in the past; and

WHEREAS, the Village has previously purchased heavy duty vehicles through Gabrielli and has been satisfied with the quality of the vehicles provided.

by the installation of something like flood gates at 313 Fayette Avenue (the DPW garage) and the Volunteer Fire House are being worked on.
