REPORT BY HARBOR ISLAND CONSERVANCY

Mr. John Farris and Ms. Julia Longacre appeared. Mr. Farris reported on the work done at Harbor Island Park beginning with the gazebo and including the landscaping, lamppost and new signs posted. He thanked all those involved with helping make these things happen, including members of the conservancy, local merchants, the Board of Trustees and members of the Department of Public Works. They have one more request, that the Village or the County redo the road going into and around the Park

Mayor Rosenblum thanked Mr. Farris and Ms. Longacre and everyone who was involved. Trustee Ryan thanked all as well as it looks very beautiful.

CONTINUATION OF PUBLIC HEARING ON PLL AA-2010 (Allow Dog Walking in Village Parks & Recognition of Goose Corps Dogs)

Mayor Rosenblum stated that it is the intention of the Board to appoint a committee representing both sides of this issue to study this proposed law. The Parks Department and Parks and Recreation Committee will also be represented. This Public Hearing was postponed until a time after this committee has met.

CONTINUATION OF PUBLIC HEARING ON PLL AB-2010 (Changes to Ethics Law)

Ms. Derrico reviewed the changes made from the last meeting.

The Board thanked the Ethics Board for their work on this. They appreciate their efforts made on the issues that come before them.

On motion of Trustee Ryan, seconded by Trustee Ybarra:

RESOLVED that PLL AB-2010 be and is hereby adopted and shall read as follows.

LOCAL LAW NO. 23-2010

A local law amending Chapter 21 (Ethics, Code Of) Section 21-3 (Definitions), Section 21-4 (Standards of Conduct), Section 21-12 (Review of Lists and Disclosure Statements), and Section 21-13 (Investigations) of the Code of the Village of Mamaroneck.

Be it enacted by the Board of Trustees of the Village of Mamaroneck as follows:

SECTION 1. Section 3 of Chapter 21 (Ethics, Code Of) is hereby amended to read as follows:

\$21-3. Definitions

INTEREST - Any participation, connection or involvement which may result in a direct or indirect pecuniary or material benefit accruing to an officer or employee as a result of a business or professional transaction with them or Village. For the purpose of this Chapter, an officer or employee shall be deemed to have a direct interest in the affairs of:

(1) His/her spouse, children, stepchildren, mother, father, brothers, sisters, grandparents, grandchildren, in-laws and other dependents or relatives.

SECTION 2. Section 4 of Chapter 21 (Ethics, Code Of) is hereby amended to read as follows:

\$ 21-4. Standards of Conduct.

- E. Nepotism.
 - (1) Policy. Employees' relatives will not be employed by the Village under any of the following circumstances:

- (a) Where one of the parties would have authority (or practical power) to supervise, appoint, remove, or discipline the other;
- (b) Where one party would be responsible for auditing the work of the other;
- (c) Where both parties would report to the same immediate supervisor. Every other option, including reassignment within the Village workforce, would be considered in good faith before layoff;
- (d) Where other circumstances might lead to potential conflict among the parties or conflict between the interest of one or both parties and the best interests of the Village; or
- (e) Where one of the parties is an elected official, except when the family member is currently employed by the Village prior to the elected official obtaining office or if the family member is currently employed by the Village and becomes a family member of an official.
- (2) Any employee currently employed prior to the adoption of this Chapter or employed prior to a relative being elected as an officer of the Village shall be exempt.
- P. Village employees. No officer or employee shall direct or cause any subordinate officer or employee to do or perform any service or work outside of the scope of his or her public work responsibilities or employment. Subordinate officers and employees may voluntarily perform such service or work, with or without compensation, outside of the hours during which they are assigned to perform duties for the Village, but they shall not wear any Village-issued uniform while engaged in any such activity. Nothing contained herein shall be construed to prohibit wearing a dress uniform at an officially authorized function or event.

SECTION 3. Section 12 of Chapter 21 (Ethics, Code Of) is hereby amended to read as follows:

\$21-12. Review of lists and disclosure statements.

A. The ethics board shall review:

(1) The lists of officers, board members and employees prepared pursuant to sections 21-10 and 21-11 of this Chapter to determine whether the lists are complete and accurate.

SECTION 4. Section 3 of Chapter 21 (Ethics, Code Of) is hereby amended to read as follows:

\$21-13. Investigations.

C. Each person who has filed a sworn complaint with the Ethics Board and each person who is the subject of said sworn complaint shall be notified in writing of the disposition of the complaint, to the extent permitted by law.

SECTION 5. Severability

If any clause, sentence, paragraph, section or part of this chapter shall be adjudged by any court of competent jurisdiction to be invalid, such adjudication shall not affect, impair or invalidate the remainder thereof but shall be confined in its operation to the clause, sentence, paragraph, section or part thereof directly involved in the controversy in which such adjudication shall have been rendered.

SECTION 6. Effective Date

This Local Law shall take effect immediately upon adoption and filing in the office of the Secretary of State in accordance with Section 27 of the Municipal Home Rule Law.

1. COMMUNICATION TO THE BOARD

Ms. Nancy Wasserman of Raleigh Road appeared. She read a statement which included a copy of the Mamaroneck Village Democratic 2010 Contribution List, submitted to the New York State Board of Elections as required by law. She noted the contributions from Bennett Golub, on September 1, 2010 and Cynthia Golub, on August 23, 2010. These contributions were made one and two weeks prior to the presentation of the Mamaroneck Beach & Yacht Club settlement stipulations. Also attached were minutes of a Board of Trustees meeting where Ms. Golub was present. Ms. Wasserman's recollection of the meeting was that Ms. Golub stated that she had an endless amount of money to fund litigation against the Village if they settled with Mamaroneck Beach & Yacht Club. Ms. Wasserman also read from minutes of a Board of Trustee Work Session dated September 7, 2010 where Mr. Kass, attorney for the Golub's and the Shore Acres Property Owner's Association stated that "we will see you in court" if the stipulation was agreed upon. Ms. Wasserman noted that Trustees Ryan and Hofstetter voted against the stipulation. She also noted that Trustee Hofstetter's parents live in Shore Acres and are members of the Shore Acres Property Owner's Association and she believes that this is reason for him to recuse himself from this matter. She also believes that in light of the most recent contributions by potential litigants, this is another reason why he should have recused himself. She read from the Ethics Law the sections that she believes highlight the reasons why both Trustees Ryan and Hofstetter should have recused themselves from this matter and had the donated monies contributed by those individuals returned. Ms. Wasserman stated that Ms. Rita Rabin also made a contribution; Ms. Rabin is the mother of Ms. Golub. She asked that all of these contributions be returned to neutralize the appearance of votes for sale.

Trustee Hofstetter addressed what Ms. Wasserman said. He stated that the reason why Ms. Wasserman has this information is because documentation required was filed by the Democratic Party at the time when it was necessary unlike his counterparts. He suggested that if she has issue with the contributions, this should be brought to the Ethics Board's attentions. Trustee Ryan stated that she does not know who contributes to their campaign. Trustee Ryan assured all that there is no connection between the Golub's contributions and her vote.

Mr. Gregory Sullivan of Highview Street appeared. Mr. Sullivan is running for Trustee. He informed the Board that a friend of his who owns a local deli suggested that Greg put his campaign sign in his window. At first Mr. Sullivan didn't want to do this, but his friend insisted. He received a phone call from a resident who informed him that a customer in this deli asked that the owner put up a sign supporting the democrats. His friend declined. The customer stated that if he didn't put the democrat's sign up, that she would tell all her friends not to shop in his store. Mr. Sullivan stated that he does not need to be Trustee that bad to make these kinds of threats and he does not appreciate his friend being put in this position. If he found out that someone associated with his campaign said this, he would be extremely upset. He does not believe that Trustees Ryan or Hofstetter had anything to do with this; however, he asks that they echo his sentiment.

Mr. Lee Wexler of Munro Avenue appeared regarding Harbor Island Park. He has been playing soccer on the fields and the situation with the goose excrement is intolerable. He realizes that this is not a new problem and that dogs are being considered for this job; however, he asked if the Village has considered paying a service to simply pick it up. He believes that it would be worth the investment. Mr. Slingerland stated that the Village is looking to contract out dogs to chase away the geese. He has spoken with a couple of companies; however, this can be expensive and has to be done continuously. He has spoken with DPW to have more goose guns available and they are looking at decoys. Having a company clean up the parks has not been looked at nor is it funded for this year. Mr. Wexler looked at vacuum cleaners for picking this up on line. He believes that having someone walk around once a week to sweep this up, perhaps on a Friday, would be a good idea. Mr. Slingerland stated that he will look into this.

Mr. Stuart Tiekert of Beach Avenue appeared. He emailed the Mayor and Trustees last week with three important questions in regard to following the law in the Village of Mamaroneck. Mr. Tiekert was told that the Pine Street issues were going to be discussed in Executive Session. Mayor Rosenblum stated that he believes that it should be decided in Executive Session whether or not it needs to be discussed in Executive Session or in a public meeting. Ms. Derrico stated that she does not see any issues that need to be discussed in Executive Session; however, it is up to the Board to put it on a Work Session agenda. Trustee Hofstetter believes that the three issues brought forward are policy issues and can be discussed in an open meeting. Trustee Ryan and Mayor Rosenblum agreed. Trustee Hofstetter also stated that he is concerned as he is getting legal advice from staff other than the attorney. Mr. Slingerland stated that he has not been giving legal advice; he has only been relaying

situations in his experience. Trustee Hofstetter also brought up the FOIL policy and has asked for

clarification from the Village Attorney.

Mr. Tiekert again stated his concern that a Planning Board resolution was changed by one

member after the resolution was adopted and not at a public meeting, particularly with the application

in front of the Planning Board at this time.

Dr. Charles Morelli appeared on the Pine Street issue as well. He read the as-built resolution on

Pine Street adopted by the Planning Board. He stated that Trustees Ybarra and Santoro promised him

last year during their campaigning that this Board would be different and something would be done; he

is still waiting for something to be done. Dr. Morelli stated that it has been nine years and it is

ridiculous that it has been allowed to go on for so long.

The Board will discuss Pine Street at a future work session.

Fire Chief Dean DeLitta appeared to thank the Board for moving ahead with the replacement of

the ladder truck. He understands that under the economic circumstances, this was not an easy decision

and he and the Department appreciate the support.

4. OLD BUSINESS

Trustee Ryan stated Lori Henry will be the Liaison from the Council of the Arts for the Ad-Hoc Jazz Festival Committee recently appointed.

5. NEW BUSINESS

A. Resolution Accepting American Medical Chest Challenge

Mayor Rosenblum stated that this is an extremely important issue as he has read that misuse of prescription drugs is the number one cause of drug deaths in the United States.

Ms. Janet Buchbinder, coordinator of RADAR for the Mamaroneck/Larchmont area appeared. Ms. Buchbinder thanked the Board for passing this resolution and the Police Department for their support and hosting one of the drop-off sites. She expects this campaign to be a great success. Trustee Santoro suggested having a drop-off day at the senior center. Ms. Buchbinder stated that as long as there is a police officer present, that should not be a problem. Trustee Santoro stated that he would speak with the Police Chief about this. Trustee Ryan suggested that this be sent to the New York Conference of Mayors and Village Managers as a way of including other municipalities in this undertaking. Mr. Slingerland stated that he would forward the information.

WHEREAS, the abuse of prescription and over the counter medicine is a serious threat to our

community's residents; and

WHEREAS, allowing these surplus and often forgotten medications to remain in the

community creates a risk of their mis-use or abuse in ways that are not intended; and

WHEREAS, allowing these surplus medications to be flushed down the toilet or down the

drains creates issues with our drinking water supplies such as the New York City watersheds in

upcounty Westchester County and upstate New York State and other impacted waterways such as the

Long Island Sound, which is a critical and impacted water body; and

WHEREAS, the American Medicine Chest Challenge provides five steps to help prevent the

abuse, misuse, and improper disposal of prescription drugs, and provides direction on how to safely

dispose of unused, unwanted, and expired medicine, in coordination with local police departments and

the US Drug Enforcement Agency.

participate in this program, authorizes the Police Chief and the Village Manager to execute and effect

any necessary agreements or paperwork necessary for this program, and encourages its citizens to safely

Mamaroneck Police Department.

E. Resolution Authorizing the Award of Contract 2010-12 for Tree, Shrub and Plant Landscaping & to Furnish, Supply & Plant Trees, Shrubs and Plants

Ybarra, Hofstetter, Ryan, Santoro, Rosenblum

Mr. Stuart Tiekert of Beach Avenue appeared. He stated that he believes that the contract is in violation with New York State labor laws. Mr. Tiekert read from the Department of Labor's law covering workers on public works contracts. He also believes that there are other problems with the contract in reference to the size and diameter of the trees. He asked that the Board vote no and would hope that the Tree Committee would be involved with a new contract. Mr. Slingerland stated that the diameter should not be part of the contract; however a 5-7 foot tree properly staked should be fine. Mr. Slingerland stated that the Tree Committee has been involved with this contract and the weeding and preparation of the land will be done before the trees are planted. With regard to the wage rates, these were attached to the addendum of the contract and upon checking with the Department of Labor, the Village is in compliance with the law.

Mr. Carlo Reca of Melbourne Avenue appeared. He agrees with Stuart that a 5-7 foot 1.5 inch caliber tree is too small to plant. He also believes that the planting should be done in house. Many communities do it in house and it is cheaper to do so. Mr. Slingerland respectfully disagrees. He has worked with municipalities that plant 5-7 foot trees and they are viable and supportable trees. Mr. Slingerland stated that we are in prime leaf collection season and Mr. Iacovelli has informed him that the Department of Public Works is too busy to plant trees. Mr. Tiekert also believes that DPW could do the planting even into the winter. Trustee Ryan believes that Mr. Tiekert and Mr. Reca made very interesting points and asked if we could possibly look at using the Department of Public Works to plant the trees. Mr. Slingerland stated that as he would prefer the DPW do the work; however the department head told him that his staff was too busy to plant the trees. He also believes that the Village

received very fair prices to have the work done. Mr. Reca stated that he can get prices on the trees and that the trees can be stored until DPW can do the planting. Again, Mr. Slingerland stated that he believes that the price received from the bids for the purchase and planting of the trees is extremely reasonable. He also stated that there is nowhere on Village property to store the trees. Trustee Santoro also would like to see this work done in house and perhaps it can wait until the spring. Mr. Slingerland stated that there are areas that need to be planted this fall due to a commitment made to have trees planted in Shore Acres and also the permits from the county to plant the trees in Meighan Park have been secured. If this work is put off until the spring, new permits and bonding will have to be done, which will be at additional costs. Mr. Slingerland reiterated that the Village staff can be trained to plant trees; however there is still a cost involved, as their labor costs money. Also as we are planning to plant 90 trees and several hundred plants at this time, using a landscape company makes sense. Trustee Ryan suggested planting less now and more next spring. Mr. Slingerland stated that if this contract is changed, the entire contract would have to be scraped. Mayor Rosenblum believes that this contract can be awarded and have the Village use in house workers for the next tree planting event and the costs can be compared. Trustee Ryan would be comfortable with this if it is added to the body of the resolution. It was agreed to add this to the resolution. Trustee Ryan suggested that perhaps some of the planting can be done by residents in the neighborhood.

AUTHORIZING THE AWARD OF CONTRACT NUMBER 2010-12 TREE, SHRUB AND PLANT LANDSCAPING TO FURNISH, SUPPLY AND PLANT TREES, SHRUBS AND PLANTS TO ASCAPE LANDSCAPING OF BLAUVELT, NY

WHEREAS, the Village Of Mamaroneck issued a Notice to Bidders and Request For Bids for Contract #2010-12 – Tree, Shrub and Plant Landscaping to Furnish, Supply and Plant Trees, Shrubs and Plants including Meighan Park Landscaping, The Parkway median landscaping, and Village-wide tree planting; and

WHEREAS, a public notice was published on Wednesday, October 13, 2010, in the Journal News, an official newspaper of the Village of Mamaroneck; and

WHEREAS, during the notice period approximately nineteen (19) companies were contacted by the Village, or contacted the village, and were sent document copies; and

WHEREAS, at 11 a.m. E.S.T., Wednesday, October 20, 2010, the Village of Mamaroneck publicly opened and read seven (7) proposals, of which five (5) were complete and acceptable; and

WHEREAS, on reviewing the proposals, the following is a list of the proposals, based from lowest to highest, as follows:

NOW, THEREFORE, BE IT RESOLVED, that the Board of Trustees of the Village of Mamaroneck hereby award Contract 2010-12 for Tree, Shrub and Plant Landscaping to Furnish, Supply and Plant Trees, Shrubs and Plants to Ascape landscaping of Blauvelt, NY, at the total approximate bid price for this unit price contract in the amount of thirty five thousand five hundred forty three dollars (\$35,543) as stated above; and be it

FURTHER RESOLVED, that the Village of Mamaroneck and the Village Manager are authorized to take the necessary and appropriate actions to sign, execute and award this contract for these services; and be it

FURTHER RESOLVED, that the Board hereby establishes policy that the next planting of trees will be through purchase only and all tree planting will be done by Village forces.

WHEREAS, in addition, Licensee shall provide the Village of Mamaroneck with a certificate of liability insurance naming the Village as an additional insured, at limits approved by the Village Attorney.
