## SWEARING IN OF POLICE CHIEF AND POLICE LIEUTENANT

Mayor Rosenblum officially swore in Police Chief Provisional Christopher Leahy and Police Lieutenant Dominick Falcone.

Chief Leahy thanked the Board for their support. He thanked his family, friends and co-workers for their patience. He thanked the Village of Mamaroneck staff for all of their help during his first days in preparing for this new position. Chief Leahy congratulated Lieutenant Falcone on his well deserved promotion.

Lieutenant Falcone thanked the Board for the promotion. He has been working for the force for a long time and looks forward to working with the PD in his new position. He thanked his family for their support.

Mayor Rosenblum stated that he now believes that the Village of Mamaroneck has the number one police department in the County. Deputy Mayor Santoro congratulated both gentlemen and invited all residents to attend the upcoming Swearing in Ceremony to take place on October 13, 2010 at 7 p.m.

CONTINUATION OF PUBLIC HEARING ON PLL X-2010 (Establishing Alternate Member Positions for Planning and Zoning Boards)

On motion of Trustee Santoro, seconded by Trustee Ryan: RESOLVED that the continuation of the Public Hearing on PLL X-2010 be and is hereby opened: Ayes: Hofstetter, Ybarra, Ryan, Santoro, Rosenblum Nays: None

Trustee Ryan had questions. She asked for clarification of what "otherwise" means in the statement on the second page, when a member "otherwise" is not able to vote. She believes that this is subjective and broad. She asked for the direct guidelines in this instance. She also asked if the substitution of a member will be at the very opening of an application; so that the alternate has an opportunity to participate in the entire hearing. She asked how one alternate will be chosen over another if there are two alternates.

Ms. Derrico replied that in regard to the statement on a member otherwise not being able to vote, they can look at examples of what is done in other communities and that this will come down to a local custom and practice. She said that this will be something to work out with the Chairs. Ms. Derrico also feels that whether or not an alternate is appointed at the opening of a hearing will be determined on a case by case basis. She can put together some guidelines for the Chairs.

Trustee Ryan asked what "from time to time" means in the statement further down the page in regard to the Mayor appointments. Mr. Slingerland believes that would be in the case of a vacancy in an appointed position. Trustee Ryan suggested that be made clear in the law.

Trustee Hofstetter asked if we ever found out if the other municipalities that were polled and use alternates use two and how many require a recusal. Ms. Derrico stated in her own research she determined that Bronxville, Briarcliff and Scarsdale do allow for the broader interpretation of when an alternate can be used. Mr. Slingerland stated that they did not look at the legislation of the thirty or so municipalities polled, so he cannot answer that question. Trustee Hofstetter has issue with the appointment of two alternates as it can be perceived as cherry picking members who will vote one way or the other. He still does not understand why this is being changed when many land use members expressed that there is no need for it.

Mr. Clark Neuringer of Stiles Avenue appeared. Mr. Neuringer is also a member of the Zoning Board of Appeals. Mr. Neuringer feels that this law is unnecessary and that it could be interpreted as a bad law. He does not understand the need for this change. He asked how the use of alternates would help expedite the application process. Mr. Neuringer served on the Planning Board and BAR as well as

the ZBA and in all of his experience he does not remember a time when an alternate would have helped any situation. He doesn't understand what precipitated the need for this law and what the perceived problem is and the solution. He did ask the Board to appoint only one alternate if they decide to adopt this law because the last thing we should do is give the Chair of a board the discretion of appointing members to that board.

Ms. Derrico stated that with the recent opinion by the Ethics Board in regard to recusals, board members may feel more comfortable recusing themselves if they know that there is an alternate able to take their place.

Mr. Greg Sullivan, member of the Zoning Board of Appeals appeared. Mr. Sullivan agrees with Mr. Neuringer; however, in the case of recusals, he can understand using an alternate. He strongly suggests having only one alternate appointed to each board if this law is adopted.

Mr. Neuringer appeared again and he did agree that there are times when a member has recused themselves and that it has never been an issue. He reminded the Board that there were many land use board members that stated that alternates are not necessary and that the Board should listen carefully to them.

Ms. Mary Vozza of Soundview Avenue appeared. She was present at the last meeting when members of the Planning and ZBA spoke about the potential issues that may arise due to the use of alternates. She asked that if this Board is inclined to pass this law, a balance test or standard be implemented whereby the competing values and interests of both the ZBA and Planning Boards are weighed against a benefit an alternate may serve an applicant. She believes that this law should be passed only when quality and fairness is achieved between those competing values.

Trustee Hofstetter stated that he will be voting no as the option of having two alternates could lead to potential problems and "funny business" and it was never made clear to him what the existing problems are and how this local law will solve them. He believes the system should be left as is.

Trustee Ryan stated that she will also be voting no as she does not understand why a law is going to be enacted if no problems have been communicated. This Board has heard from many members of the land use boards stating that they do not see the need for this change; that things work very well the way they are. She believes that the Board should listen to the volunteers who have voiced their concerns.

Trustee Santoro stated that he will be voting yes and that he has listened to the different board members. If he believes that if an alternate is ever needed, this law will be on the books.

Mayor Rosenblum takes objection to the comment that "funny business" could take place as everyone who serves on our boards takes an oath to uphold the constitution of the United States, the constitution of the state of New York and the rules and regulations of the Village of Mamaroneck. To insinuate otherwise, he believes is an insult. He also stated that there are differences in opinions and for the last decade that he has observed many boards and commissions, he found it objectionable when an applicant was forced to either accept an approval when there was not a full board present or to put their application off another month, at the risk of increasing the costs associated with this application.

# LOCAL LAW NO. 22-2010

A LOCAL LAW AMENDING CHAPTER 58 OF THE VILLAGE CODE REGARDING THE PLANNING BOARD, AND TO AMEND CHAPTER 342 OF THE VILLAGE CODE REGARDING THE ZONING BOARD, TO FORMALIZE THE NUMBER OF BOARD MEMBERS AND THEIR TERMS FOR THE PLANNING BOARD, AND TO AUTHORIZE ALTERNATE MEMBERS FOR PLANNING AND ZONING TO BE APPOINTED PURSUANT TO NYS VILLAGE LAW.

BE ENACTED BY THE BOARD OF TRUSTEES OF THE VILLAGE OF MAMARONECK AS FOLLOWS:

SECTION 1. Section 58-1 of the Village Code on the Planning Board, entitled, PLANNING BOARD, Section 1 "Statutory authorization; powers" is hereby deleted in its entirety, and a new section adopted as follows:

\$ 58-1 Statutory authorization; powers; board membership; alternate members; terms.

A Planning Board is hereby created pursuant to Chapter 7-718 of the Village Law of the State of New York hereby giving and granting to said Planning Board all of the powers enumerated in said Chapter 7-718 of the Village Law of the State of New York, or any amendments thereto, including, but without limiting the generality of the foregoing, the power to approve plans showing new streets or highways and, simultaneously with the approval of such plans, either to confirm the zoning regulations of the land so platted as shown by the Official Zoning Map of said village or to make any reasonable change therein in accordance with the provisions of said Act or amendments thereto. Board membership shall include a total of five (5) members, with up to two (2) alternate members, as authorized under Chapter 7-718, Part 16, of the Village Law of the State of New York. Terms of membership for members and alternate members shall be five (5) years.

Each alternate member of the Planning Board shall attend meetings of the Planning Board and shall be entitled to participate in all activities of the Planning Board as if such alternate was a member, but shall vote only in the event that a member is absent, has a conflict of interest or is otherwise unable to vote with respect to a particular matter and the Chairman designates such alternate to so vote. The chairperson of the Planning Board may designate an alternate member to substitute for a member when such member is absent, has a conflict of interest or is otherwise unable to vote with respect to a particular matter. When so designated, the alternate member shall possess all the powers and responsibilities of such member of the board. Such designation shall be entered into the minutes of the initial Planning Board meeting at which the substitution is made.

This subsection is adopted pursuant to the authority granted by 10, Subdivision (1)(e)(3), of the Municipal Home Rule Law and shall supersede any provision of the Village Law which is inconsistent herewith.

SECTION 2. Section 342-88 of the Village Code on the Board of Appeals, entitled, "Continuation of existence" is hereby deleted in its entirety, and a new section adopted as follows:
\$ 342-88 Continuation of existence; board membership; alternate members; terms.

The Board of Appeals is hereby created pursuant to the provisions Chapter 7-712 of the Village Law the State of New York and shall consist of five (5) members with up to two (2) alternate members appointed from time to time by the Mayor subject to the approval of the Board of Trustees. Board membership shall include a total of five (5) members, with up to two (2) alternate members as authorized under Chapter 7-712, Part 11, of the Village Law of the State of New York. Terms of membership for members and alternate members shall be five (5) years.

Each alternate member of the Board of Appeals shall attend meetings of the Board of Appeals and shall be entitled to participate in all activities of the Board of Appeals as if such alternate was a member, but shall vote only in the event that a member is absent, has a conflict of interest or is otherwise unable to vote with respect to a particular matter and the Chairman designates such alternate to so vote. The chairperson of the Board of Appeals may designate an alternate member to substitute for a member when such member is absent, has a conflict of interest or is otherwise unable to vote with respect to a particular matter. When so designated, the alternate member shall possess all the powers and responsibilities of such member of the board. Such designation shall be entered into the minutes of the initial Board of Appeals meeting at which the substitution is made.

This subsection is adopted pursuant to the authority granted by 10, Subdivision (1)(e)(3), of the Municipal Home Rule Law and shall supersede any provision of the Village Law which is inconsistent herewith.

### SECTION 3. Severability

If any clause, sentence, paragraph, section or part of this chapter shall be adjudged by any court of competent jurisdiction to be invalid, such adjudication shall not affect, impair or invalidate the remainder thereof but shall be confined in its operation to the clause, sentence, paragraph, section or part thereof directly involved in the controversy in which such adjudication shall have been rendered.

## SECTION 4. Effective Date

This Local Law shall take effect immediately upon adoption and filing in the office of the Secretary of State in accordance with Section 27 of the Municipal Home Rule Law.

Mayor Rosenblum read a letter from David Neufeld, Chair of the Zoning Board of Appeals who is in agreement with the use of alternates, in the instance of a conflict of interest. He also believes that the use of an alternate may be helpful in the instance when a board member is absent, especially if they will be absent for a longer period of time. Trustee Hofstetter stated that it would have been helpful to get a copy of the letter before it was read this evening.

Mayor Rosenblum stated that although the law does allow for the appointment of two alternates, it is his intention to only appoint one alternate to each board unless there are drastic circumstances presented. Mayor Rosenblum also stated that while the Mamaroneck Beach and Yacht Club application is before the Planning Board, an alternate will not be appointed.

Trustee Hofstetter stated that he will again be voting no on this as he did the previous resolution.

Trustee Ryan stated that she will also be voting no with the new information received.

WHEREAS, Chief Edward Flynn approached the Board of Trustees and requested a retroactive pay increase that would span a three year time frame, which the Mayor and Board of Trustees considered; and

WHEREAS, upon consideration of his request, and after careful deliberation, the Board of Trustees hereby agree to this retroactive pay increase to Chief Flynn, starting October 1, 2007, and ending on September 30, 2010, in the total amount of \$84,000.

On motion of Trustee Santoro, seconded by Trustee Ybarra:

NOW, THEREFORE, BE IT RESOLVED, that the Board of Trustees of the Village of Mamaroneck hereby agree and authorize the Village Manager to enter into on behalf of the Village an employment agreement with Ed Flynn, that provides for retroactive pay increases in the total amount of \$84,000 (\$14,000 the first year, \$28,000 the second year, and \$42,000 the third year), and also provides that he agree to release any and all claims that he may have against the Village of Mamaroneck in this regard; and be it further

RESOLVED, that the Village Manager and the Clerk/Treasurer are authorized to undertake such administrative acts as may be necessary and appropriate to enact and execute this employment agreement.
