Mayor Rosenblum asked if the Board would take Item 5N out of order.

RESOLUTION AUTHORIZING APPOINTMENT OF A LIEUTENANT TO THE VILLAGE OF MAMARONECK POLICE DEPARTMENT

WHEREAS, at the August 16, 2010, the Board of Trustees appointed Lt. Christopher Leahy to the position of Chief of Police for the Village of Mamaroneck on a provisional basis, beginning on or after September 26, 2010; and

WHEREAS, in order to maintain continuity in the management and administration of the Police Department the Civil Service list for Police Lieutenants was called for and obtained by the Board of Trustees so that the position vacated by Lt. Leahy may be filled; and

WHEREAS, the Board of Trustees, in their capacity as a Board of Police Commissioners, met to interview prospective candidates to assume the position of Police Lieutenant;

On motion of Trustee Ryan, seconded by Trustee Santoro:

RESOLVED, that pursuant to \$8-800 of New York State Village Law, the Village Board hereby appoints Sgt. Dominick Falcone to the position of Police Lieutenant for the Village of Mamaroneck commencing on or after September 26, 2010; and be it further

RESOLVED, that the Village Manager is herein authorized to undertake such administrative acts as may be required to effectuate this appointment.

PRESENTATION OF NYCOM SERVICE AWARDS

Mayor Rosenblum presented Mr. Lloyd Wright, the Village Assessor, with an award for 45 years of service. Mr. Wright thanked the Board, the staff and residents for their support during his 46 years with the Village. It has been a pleasure for him.

PRESENTATION ON MAMARONECK SHARES EVENTS

Ms. Peggy Jackson and Ms. Ellen Hauptman appeared to present the monies raised at the Mamaroneck Shares events. The Larchmont Mamaroneck Community Counseling Center, the CAP Center and the Keep a Breast Cancer Research Fund were each given a check for \$4,145. Ms. Jackson gave a recap of the event and thanked all for their support. There will be six events planned for next year. Volunteers will be needed.

PRESENTATION BY WJWW ON WATER RATES

Mr. Tony Conetta of the Westchester Joint Water Work appeared to discuss the increase in the water rates. Mr. Conetta gave background on where our water comes from and what the rates have been for the last several years. The Village's water comes from the New York City water supply which originates in the Catskills through the Croton System. The Water Works services the Villages of Mamaroneck and Larchmont, the Town of Mamaroneck and the Town/Village of Harrison. Mr. Conetta reviewed the water rate increase, which was 75% in the Village. These rate increases are driven by different factors. The water supply cost increased by 28%, utilities went up 15%, chemical costs went up 13%, insurance and taxes raised by 19% and an equipment update and maintenance program went up by 200%, including increases in security and surveillance. To contain costs, an office automation system was embarked upon. EPA regulatory requirements have gone up extensively and the water works needs to assure that they are in compliance. The water works are cognizant of the increases and in an effort to control costs, decreased their labor costs by 13%. Mr. Conetta compared the cost of water to other household items. He also compared our water costs to other local municipalities. Although the cost of water didn't necessarily go up by that much, the cost to protect it has. Since 1992, the charge for water from the New York City water supply has gone up by 1400%. This is 50% of the water works budget. Data on the shortfall over the last eleven years was presented.

Mr. Conetta explained that the rate increase did take effect this summer; however, some households have doubled or tripled their usage due to the lack of rain and residents using water to irrigate their lawns. If the increase had taken effect in the winter months, Mr. Conetta stated that there would not have been as much of an impact. Trustee Ryan asked about maintenance and if any could be put off to the future. Mr. Conetta stated that automation and maintenance are desperately needed and what is budgeted is only what needs to be done this year. Mayor Rosenblum stated that until a couple of years ago, the Village subsidized water rates. Due to a change in policy, those who are using the water are paying for it. Mayor Rosenblum stated that the water works are looking at their real estate and more efficient use of their holdings. Mr. Conetta also stated that there will be major costs coming down the road in a few years as all of the water received will be UV treated and the pipeline serving the Village and Town of Mamaroneck is approaching its useful life.

Mr. Sid Albert appeared. He asked if the WJWW would televise their meetings and post their financial statements on their website. He believes that the more information that can be provided to the residents, the better, as it would help them understand what is happening. Mr. Conetta stated that all meetings are open and all financials are available. He will bring up the televising of the meetings to the Board members. Trustee Ryan suggested that the WJWW Board Members report back to their respective municipalities after their board meeting.

Mr. Doug Dunaway appeared. He asked why the Village of Mamaroneck went up so much more than the other two municipalities that make up the WJWW. Mr. Conetta explained that it is due to the shortfall over the past years. Other municipalities have been raising their rates over the last several years, where the Village had not.

Trustee Hofstetter informed residents that the WJWW Board asked for a 100% increase in their stipend, which was vetoed by the Governor. He cannot understand why the Mayor asked the Village Board to cut their stipends with only a 0.35% increase in the budget and then asked for a 100% increase in his water works stipend with the residents looking at a 75% increase in their water bill. Mayor Rosenblum suggested that Trustee Hofstetter speak with Supervisors O'Keeffe and Walsh about this.

CONTINUATION OF PUBLIC HEARING ON PLL W -2010 - (Bike & other Non-motorized Devices Law)

Mr. Slingerland gave the history of this proposed local law since it was first presented in the summer of 2009. The downtown business district is now considered to be only Mamaroneck Avenue from Halstead Avenue to the Boston Post Road. Mr. Slingerland went over the other changes to the draft which include, not prohibiting leaning of bicycles against buildings, except in the downtown area and those that would impede pedestrian traffic and the penalty structure, which is now a tiered fee: \$25, \$50 and \$100 for violations of the code in a one year period. Mr. Slingerland thanked all who commented on this proposed law as the changes were made with residents' comments and needs in mind.

On motion of Trustee Ryan, seconded by Trustee Ybarra:

LOCAL LAW NO. 21-2010

A LOCAL LAW AMENDING THE VILLAGE CODE ON BICYCLES, ENACTING AN AMENDED SECTION ENTITLED, "BICYCLES, SKATEBOARDS, ROLLERBLADES AND OTHER WHEELED DEVICES", TO UPDATE RULES AND REGULATIONS FOR SUCH DEVICES, AND TO PROHIBIT THE USE OF BICYCLES, SKATEBOARDS AND ROLLERBLADES ON THE SIDEWALKS IN THE DOWNTOWN COMMERCIAL AREA.

BE ENACTED BY THE BOARD OF TRUSTEES OF THE VILLAGE OF MAMARONECK AS FOLLOWS:

Section 1. Enactment

The current language for Chapter 112, BICYCLES is deleted in its entirety, and a new Chapter 112 entitled, "BICYCLES, SKATEBOARDS, ROLLERBLADES AND OTHER WHEELED DEVICES" is enacted as follows:

Chapter 112, BICYCLES AND OTHER WHEELED DEVICES

\$ 112-1. Legislative Findings and Intent.

The Village of Mamaroneck finds that there are benefits to community members utilizing bicycles for transportation and recreation in and around the Village of Mamaroneck. The following goals and objectives are hereby identified:

- Bicycling is an environmentally friendly, efficient, non-polluting and inexpensive means of transportation and recreation for people of all ages, as appropriate, and such transportation and recreation are a vital part of the Village of Mamaroneck community. This includes young children properly supervised by parents or other responsible adults, and people of all ages.
- 2. Bicycles are used for recreation and neighborhood transportation, by commuters traveling to and from different transportation hubs such as the train station, and for other similar uses such as riding to and from local destinations.
- 3. There are currently provisions under NYS Vehicle and Traffic Law, specifically Article 34 of the Vehicle and Traffic Laws, OPERATION OF BICYCLES AND PLAY DEVICES which establish rules and regulations regarding safe operation of bicycles, and require use of helmets by bicyclists at and below certain ages, which the Village hereby acknowledges and enforces.
- 4. The Village of Mamaroneck is seeking to establish updated rules and regulations for safe bicycling and parking of bicycles in the Village, with specific rules regarding the operation and parking of bicycles along Mamaroneck Avenue between Halstead Avenue and Boston Post Road (U.S. Route 1) hereinafter referred to as the "Downtown business district", in coordination with the Village Manager's Office, the Department of Public Works, the Building Department, and the Police Department. The Village's goal is to provide for safe and adequate use of bicycles and other wheeled devices such as skateboards and rollerblades along public thoroughfares and the parking of bicycles on public areas in a manner that allows pedestrians, including the handicapped, to continue to have safe and full access along sidewalks, as well as to and from cars and other vehicles.

\$ 112-2. Operation and equipment standards.

Each person operating a bicycle in the Village of Mamaroneck is required to comply with all applicable vehicle and traffic laws, as more fully delineated and set forth under New York State Vehicle and Traffic Law Article 34 – OPERATION OF BICYCLES AND PLAY DEVICES. Additional rules shall apply in the Village of Mamaroneck, as follows:

- A. No person shall ride a bicycle, skateboard, non-motorized scooter, or use rollerblades or other wheeled device upon the sidewalk in the Downtown business district. In such locations, bicycles may be walked along the sidewalk.
- B. No person shall ride a bicycle, skateboard, non-motorized scooter, or use rollerblades or other wheeled device upon any other public sidewalk within the Village of Mamaroneck in a manner that is unsafe for pedestrians.
- C. No person shall secure a bicycle upon a public street or sidewalk in the Downtown business district other than in a bike rack or in bicycle parking locations as designated by the Village of Mamaroneck under the direction of the Village Manager.
- D. Every bicycle, skateboard, non-motorized scooter, or rollerblades or other wheeled device used on a public highway shall be equipped, maintained and operated in compliance with the Vehicle and Traffic Law of the State of New York.
- E. Impoundment. A bicycle may be impounded for abandonment, which is defined as being left in a location that is on village-owned property, on a public sidewalk or public right-of-way for more than seven (7) consecutive days. A bicycle may be retrieved from impoundment by an owner upon proof of valid ownership by paying a fee to the Village of fifty dollars (\$50).
- § 112-3. Penalties for offenses. [Amended 3-23-1987 by L.L. No. 5-1987, effective 4-2-1987]
- A. Any person, firm or corporation who violates any of the provisions hereof shall be liable to a forfeiture to the Village of Mamaroneck in a sum not to exceed twenty five dollars (\$25) for the first violation within one year, a sum not to exceed fifty dollars (\$50) for the second violation within one year, and a sum not to exceed one hundred dollars (\$100) for the third or more violation(s) within one year.

Section 2. Severability

If any section, subsection, clause, phrase or other portion of this Local Law is, for any reason, declared invalid, in whole or in part, by any court, agency, commission, legislative body or other authority of competent jurisdiction, such portion shall be deemed a separate, distinct and independent portion. Such declaration shall not affect the validity of the remaining portions hereof, which other portions shall continue in full force and effect.

Section 3. Effective Date

This Local Law shall take effect immediately upon adoption and filing in the office of the Secretary of

State in accordance with Section 27 of the Municipal Home Rule Law.

CONTINUATION OF PUBLIC HEARING ON PLL X-2010 (Establishing Alternate Member

Positions for Planning and Zoning Boards)

Mr. John Romans resident for over 25 years appeared. He has also been practicing law for over 40 years and in all his years he has never seen the shabby, outrageous treatment that the Mayor has

perpetrated on the minority members of the Board; giving them less than one hour to digest and

participate in the negotiations surrounding the Mamaroneck Beach and Yacht Club.

Ms. Robin Kramer, member of the Zoning Board appeared. During her time on this Board, an

absent member has not been an issue. Ms. Kramer stated that under Village Law, Chapter 7-718, part 16,

an alternate can only be appointed in the instance of a conflict of interest and she asked that if this law

is adopted, this be the only time that an alternate is appointed. The Board cannot appoint an alternate

if a member is absent. This is stated under Village Law, Chapter 7-712, part 11 as well. Ms. Kramer

warned the Board that if an alternate is appointed under any other circumstance and a vote is taken on

that application, that decision would be illegal and subject to challenge.

Mr. Stuart Sterk, member of the Planning Board appeared. Mr. Sterk agrees that this law is a

bad idea. In his time on this board, no application was ever delayed due to absence. He believes that it

would be very difficult for applicants to have to deal with different members at different times dealing

with their application. There would be no consistency. He is also concerned about appearances;

however, if the policy is changed, he suggests that the policy is changed in six months, so that there is

no taint in appearances on applications currently before the board(s).

Mr. Lee Wexler, member of the Planning Board appeared. Mr. Wexler believes that this

proposed local law would cause more problems than it would solve, it would add more bureaucracy and

confusion to the process. He also believes that it could inject internal politics and suspicion on the

boards and that it is a huge waste of a volunteer's time. He strongly encouraged the Board not to adopt

the law now, but if they do, he also believes it would be a good idea to have it take effect in six months

to a year.

On motion of Trustee Ryan, seconded by Trustee Ybarra:

RESOLVED that the Public Hearing on Proposed Local Law V-2010 be and is hereby closed.

Trustee Ryan asked the Village Attorney to clarify if the Board should comment during the

public hearing or during the voting process. Ms. Derrico stated that if a Board member would like to

make comments and have those comments considered before a vote is taken, then they should make them during the public hearing; however, if they would like to comment generally on the law, then that can be done during the voting process. Trustee Hofstetter stated that he would like to be able to make a statement before a vote is taken.

Trustee Hofstetter believes by passing this law, especially in light of what happened in the Mamaroneck Beach and Yacht Club application, the Board would have the potential of influencing how a board votes on a particular issue. He believes that having the appearance of being able to influence a board is not a good idea. Mayor Rosenblum stated that this is simply a tool for this or a future Board to be able to appoint alternates if they deem necessary or warranted, not to "cherry pick" members who will vote one way or another. Trustee Hofstetter stated that if this is the case, then the law should be effective in a year or so. The Mayor disagrees as there may always be contentious applications before the boards and waiting does not insure this.

Ms. Derrico stated that as there seems to be issues with this proposal and that Trustee Santoro has some suggested changes, she suggests that the Board open this hearing at the next meeting; renoticing it.

Trustee Ryan commented that there have been several people from the Zoning and Planning Boards that raised the same points that those appearing tonight have. Those points are very legitimate; they have not had the experience that alternates are needed. The boards are working well now. Trustee Ryan asked if alternates are appointed, will they be considered full members; can they participate, and ask questions, and can they vote on an application. She finds some of the language confusing; as it also reads that the chair of a board may or may not have an alternate vote on an application in an instance that a member is absent or has recused themselves. The rule is either the alternate, if there is one, either votes or not. It must be consistent not on the whim of the Chair. Mayor Rosenblum agrees with Trustee Ryan on this last point, as he also does not want to put the onus on the Chair. He also agrees that only one alternate should be appointed, to negate the appearance of "cherry picking" an alternate.

Trustee Santoro contacted about a dozen of the communities that Mr. Slingerland listed on his survey. These communities informed Mr. Santoro that they cannot remember the last time they had to use an alternate; however, they are happy that this law is in place in the event that they need an alternate.

Mayor Rosenblum stated that either side can be argued; however, he believes that this is a section of law that is potentially favorable to any applicant in front of the ZBA and the Planning Board. He feels that the process before these boards takes an inordinate amount of time and is an injustice to any applicant. He also believes that this is an excellent training ground for potential full members. Trustee Ryan commented that it is usually not the absence of a board member that results in applications taking time, but because the board asks for more information than the applicant has supplied, using the Verni brothers application as an example. The Mayor also agreed.

On motion of Trustee Santoro, seconded by Trustee Ybarra:

RESOLVED that the continuation of the Public Hearing on PLL V-2010 be and is hereby scheduled for the September 27, 2010 Regular Meeting.

5. NEW BUSINESS

Mayor Rosenblum stated that he would like to add an agenda item; the appointment of a member to the Harbor and Coastal Zone Management Commission, as Mr. George Belsito has resigned his position. The Mayor believes that this Commission should have a full compliment and he will be appointing Mr. Cary Sleeper, who was on the Commission previously. Trustee Hofstetter disagrees with this process, as there are other residents who have submitted resumes and they should be considered before this is just done. Trustee Ryan is not sure if Mr. Sleeper has been off of the committee long enough to be reappointed and she agrees that it is only fair to give residents the courtesy of looking at their resumes before a committee member is considered. Trustee Hofstetter stated that doing things in this manner is embarrassing and distasteful. The Village should be getting better service by their Mayor and their Attorney. Mayor Rosenblum disagrees and believes that it is important to have someone appointed before their next meeting, so that they have a full compliment.

A. Awarding of Contract for Jefferson Ave. Bridge Replacement Engineering & Design Services

RESOLUTION RE: AUTHORIZATION TO EXECUTE A PROFESSIONAL SERVICES AGREEMENT FOR DESIGN AND ENGINEERING SERVICES FOR THE JEFFERSON AVENUE BRIDGE OVER THE MAMARONECK RIVER (BIN 2225080) REPLACEMENT PROJECT

Mr. David Weiss the Project Manager from WSP Sells appeared. Mr. Slingerland gave the history on the process of the upcoming replacement of the Jefferson Avenue Bridge.

WHEREAS, the Jefferson Avenue Bridge over the Mamaroneck River (BIN 2225080), located in the Village of Mamaroneck, is a 2-span concrete encased steel multi-girder with an overall length of eighty (80) feet and an out-to-out width of fifty (50) feet originally constructed in 1931; and

WHEREAS, because of its continued use and damage and wear over the years from severe weather and regular and occasionally severe flooding, portions of the bridge are closed to access, including pedestrian sidewalks and sections of the bridge have fallen through and based on a NYSDOT inspection report and supplemental analyses prepared for the Village, the bridge has been identified as being in need of replacement; and

WHEREAS, in support of this effort and to help offset costs, Assemblyman George Latimer was able to secure a grant through the New York State Dormitory Authority and its Community Capital Assistance Program in the amount of \$400,000 to be used towards design and engineering services for the Jefferson Avenue Bridge Replacement Project; and

WHEREAS, in accordance with this grant award Village staff prepared a Request for Proposals (RFP) for Professional Design Services for the Jefferson Avenue Bridge Replacement Project; and

WHEREAS, the Village Manager reports that he publicly advertised for the receipt of proposals on July 9, 2010 and sent copies of the RFP to twelve (12) firms and on the return date of July 30, 2010, three proposals were submitted; and

WHEREAS, in order to analyze the responses to the RFP, a review committee was formed with representatives from the Village of Mamaroneck and Town of Rye who share joint responsibility for the bridge replacement and interviews were conducted with all three (3) respondents; and

WHEREAS, during the interviews, all firms conveyed a clear understanding of the project scope, had quality references, displayed technical competency and their ability to work with multiple jurisdictions in designing and implementing capital projects; and

WHEREAS, based on the interviews, the RFP review committee unanimously recommended that WSP Sells, 555 Pleasantville Road, Briarcliff Manor, NY, 10510 be retained as the engineering and design firm for the Jefferson Avenue Bridge Project for the following reasons:

- Previous experience with Village of Mamaroneck. WSP Sells (then Chas H. Sells) provided design and engineering services for the Fenimore Road Bridge project and the Village was pleased with the quality of their design and engineering services. WSP Sells has previously provided technical assistance and analysis of the Jefferson Avenue Bridge and they are familiar with all facets of the project.
- 2. WSP Sells has in-house staff to perform many services that other firms would need performed by sub-contractors (right-of-way, environmental, planning). By performing these services in-house, it provides greater accountability and streamlines the design and engineering process.
- 3. Experience with similar bridge project. Since 1999, WSP Sells has been involved in 23 local bridge replacement projects.
- 4. Significant experience in interacting with all levels of government that are, or may be, involved with this project including the New York State Department of Transportation (NYSDOT), Federal Highway Administration (FHA), United State Army Corps of Engineers (USACE), New York State Department of Environmental Conservation (NYSDEC) and Westchester County.

; and

WHEREAS, although engineering and design services are considered a professional service and not subject to competitive bidding requirements, WSP • Sells proposed cost of \$165,000 was the lowest of the three (3) respondents.

B. Awarding of Contract 10-02 Mamaroneck River Maintenance Dredging

RESOLUTION AWRADING CONTRACT# 10-02 – MAMARONECK RIVER MAINTENANCE DREDGING

WHEREAS, a major impact on both flooding and water quality is the accumulation of silt, especially along bridge embankments and other constructed impediments in waterways, in the Village of Mamaroneck, the major drainage conveyance systems include the Mamaroneck River, the Sheldrake River and the Beaver Swamp Brook; and

WHEREAS, although funding for this project was not included in the FY 2010/11 Budget, the Village will realize unanticipated revenue as a result of reimbursements from the Federal Emergency Management Agency (FEMA) and the New York State Emergency Management Office (NYSEMO) as a result of the March 13-15, 2010 windstorm which will cover all costs associated with this dredging work; and

Updates from the Board

Trustee Ybarra informed all that there will be a memorial service held for him on Saturday, October 9 at 11 a.m. at St. Vito's Church with a reception at the Elks Club to follow.

Trustee Ryan thanked Superintendent O'Keeffe for once again organizing the 9/11 Memorial Service held this past week. Trustee Ryan also attended the camp out at Harbor Island. Trustee Ryan thanked the Council of the Arts for all of their work in organizing the summer concert series and the DeRosa family for donating the funds for the outdoor movie.

Trustee Hofstetter also attended the joint municipal memorial service held on 9/11. It was a wonderful ceremony, making sure that we never forget the event. Trustee Hofstetter attended the camp out as well and it seemed like everyone was having a lot of fun. Trustee Hofstetter stated that he received a phone call from the Village Attorney today regarding blogs with information that he had sent out and he wanted to make it clear that he does not post things on blogs. His interpretation of the Mamaroneck Beach and Yacht Club settlement was given to residents when he was asked for it; however, he never posted these comments on any blog. He was surprised to get the phone call as he

does not see the difference between his interpretation of the settlement being on the web and the Mayor's interpretation being posted on the Village's website. Trustee Hofstetter again opined on the lack of information received before this settlement was voted on and anyone who says that the Board performed their fiduciary responsibility is wrong.

Mayor Rosenblum welcomed back Officer Ledonne after his bike accident. He also is also looking forward to the new leadership in the police department.
