PUBLIC HEARING ON PLL U-2010 (AMENDING CHAPTER 326, ARTICLE III, PARKING TICKET PENALTIES AND OFFENSES)

Mr. Sarnoff gave history on the proposed local law and reviewed the changes made since the last public hearing on June 28. The reason behind the proposed amendment is to clarify the penalty section as it exists in the code. The language in this section is somewhat ambiguous and difficult to interpret. These changes will clarify this section. Trustee Ryan requested that the new penalty timing be printed on the tickets. Mr. Slingerland stated that this can be hand written on the existing tickets and printed on the ticket with the printing of the next batch.

LOCAL LAW NO. 19-2010

A local law amending Article VII (Penalties for Offenses) Section 65 (Miscellaneous penalties), Section 66 (Permit parking areas) and Section 67 (Metered parking zones) of Chapter 326 (Vehicles and Traffic) of the Code of the Village of Mamaroneck

Section 1. Section 65 (Miscellaneous Penalties) Part C of Chapter 326 (Vehicles & Traffic) is hereby deleted in its entirety and replaced with the following language:

\$ 326-65. Miscellaneous penalties.

- A. Every person convicted of a violation of § 326-6 or 326-7 of this chapter shall, for a first conviction thereof, be punished by a fine of not more than \$100. For a second conviction within 18 months thereafter, such person shall be punished by a fine of not more than \$200. Upon a third or subsequent conviction within 18 months after the first conviction, such person shall be punished by a fine of not more than \$350. In lieu of or in addition to such fine, a sentence of imprisonment for not more than 30 days may be imposed for a second or third conviction within 18 months.
- B. In addition to any penalty provided by the Vehicle and Traffic Law, any person violating any of the provisions of § 326-4 or Article III of this chapter shall, upon conviction, be punished for the first offense by a fine not exceeding \$20, for the second offense by a fine not exceeding \$30 and for any subsequent offense by a fine not exceeding \$40, except for those violations as indicated in Subsections D, E and F below.
- C. In addition to subsection B above, all violators who fail to pay the base fine within 15 days of the issuance of a summons will be subject to the following penalties:
 - (1) If paid after 15 days but on or before 30 days of summons being issued: double the original fine.
 - (2) If paid after 30 days but on or before 45 days of summons being issued: double of Subsection *C*(1).
 - (3) If paid after 45 days of summons being issued: double of Subsection C(2).

Section 2. Section 66 (Parking permit areas) Part B of Chapter 326 (Vehicles & Traffic) is hereby deleted in its entirety and replaced with the following language:

\$ 326-66. Permit parking areas.

- A. Any person violating any of the provisions of Article IV of this chapter, except \$ 326-49G and H, may, upon conviction, be punished for the first offense by a fine not exceeding \$20, for the second offense by a fine not exceeding \$30 and for any subsequent offense by a fine not exceeding \$40.
- B. In addition to Subsection A above, all violators who fail to pay the base fine within 15 days of the issuance of a summons will be subject to the following penalties:

- (1) If paid after 15 days but on or before 30 days of summons being issued: double the original fine.
- (2) If paid after 30 days but on or before 45 days of summons being issued: double of Subsection B(1).
- (3) If paid after 45 days of summons being issued: double of Subsection B(2).

Section 3. Section 67 (Metered parking zones) Part B of Chapter 326 (Vehicles & Traffic) is hereby deleted in its entirety and replaced with the following language:

\$ 326-67. Metered parking zones.

- A. Any person violating any of the provisions of Article V of this chapter, except \$\$ 326-59G and 326-61, may, upon conviction, be punished for the first offense by a fine not exceeding \$20; and for the second offense within a twenty-four-hour period by a fine not exceeding \$30; and for any subsequent offense within a twenty-four-hour period by a fine not exceeding \$40.
- B. In addition to Subsection A above, all violators who fail to pay the base fine within 15 days of the issuance of a summons will be subject to the following penalties:
 - (1) If paid after 15 days but on or before 30 days of summons being issued: double the original fine.
 - (2) If paid after 30 days but on or before 45 days of summons being issued: double of Subsection B(1).
 - (3) If paid after 45 days of summons being issued: double of Subsection B(2).

Section 4. If any section, subsection, clause, phrase or other portion of this Local Law is, for any reason, declared invalid, in whole or in part, by any court, agency, commission, legislative body or other authority of competent jurisdiction, such portion shall be deemed a separate, distinct and independent portion. Such declaration shall not affect the validity of the remaining portions hereof, which other portions shall continue in full force and effect.

Section 5. This Local Law shall take effect immediately upon adoption and filing in the office of the Secretary of State in accordance with Section 27 of the Municipal Home Rule Law.

1. COMMUNICATION TO THE BOARD

Mayor Rosenblum stated that at tonight's meeting a public hearing on the proposed bike law in the Village will be scheduled for the August 16 meeting. He has asked Mr. David Wilson, President of the Westchester Cycle Club to make a brief statement on the proposed local law and asked that other residents in attendance please hold their comments to the public hearing in August.

Mr. David Wilson, President of the Westchester Cycle Club appeared. He is also President of the Bike/Walk Alliance of Westchester County. This alliance is associated with the East Coast Greenway which goes through the Village of Mamaroneck. He urged the Board to not place the public hearing on the agenda for August as the law in its proposed state needs quite a bit of work. He applauds the Board for looking at the law as it now exists as it could be improved upon. Mr. Wilson believes that the new bike parking ordinance seems the most onerous. The way it is written, it would prevent riders from coming into the downtown area due to the parking restrictions. Many riders stop at a store and simply lean their bicycle next to or near the store and many do not carry locks. He also

believes the penalties are too harsh, giving our Village the reputation of being the least bike friendly in the county. Mr. Wilson stated that he would be glad to work with the Village on this ordinance.

Mr. Slingerland addressed some of the inaccuracies that were in an article posted in the Journal News regarding this proposed local law. He stated that this is something that has been worked on since last summer and the goal is to make the Village more bike friendly; not more restrictive. Mr. Slingerland reviewed some of the changes to the existing law.

Trustee Hofstetter believes that Section 112.2A should be removed as he does not agree with what the "commercial district" refers to. He also has a problem with this as it would prohibit children from riding their bikes to school, if they cannot ride on the sidewalk. Trustee Ryan encouraged all residents to send in what they feel would be a fair law, as the Board would like for it to represent the community.

Mr. Lee Wexler of Munro Avenue appeared. Mr. Wexler agrees that the existing law is out of date. He does not understand why bikers cannot ride two abreast on the Boston Post Road, as the state law reads that bikers may never ride more than two abreast. He believes that it might be best to leave things out that are redundant with the state law, to avoid confusion. Mr. Slingerland stated that most, if not all references to the state vehicle and traffic laws have been deleted.

Ms. Susan Odierna appeared. She is also concerned about the law prohibiting biking on the sidewalk in the commercial area, as she has school aged children riding their bikes to school. She believes that there should be a common sense approach to this and parents should instruct their children to give the right of way to pedestrians and if the sidewalk is crowded, to walk their bikes.

Ms. Karen Weisberg, resident of the Town of Mamaroneck appeared as she bikes through the Village daily. She encouraged the Board to allow for bikes to be put somewhere where they can be protected during a rain event.

I. Amendment to Chapter 236 Vehicles & Traffic – Eliminating Time Limit for Meters on

Jefferson and Van Ranst

the fees for parking spaces within Metered Parking Zones 1, 2(a), 2(b) and 3 located on Jefferson

Avenue and Van Ranst Place; and

WHEREAS, Metered Parking Zones 1, 2(a), 2(b) and 3 provide for a twelve hour limit

with a minimum charge of \$2.50 for the first ten (10) hours and \$0.25 for each additional hour

and because of this minimum charge, it is believed that these spaces are underutilized as there is

a disincentive for motorists who may want to use these parking spaces for shorter durations;

and

WHEREAS, based on this review, it is appropriate to eliminate the existing \$2.50

minimum charge for 10 hours of parking in favor of a standard rate of \$0.25 per hour to

encourage greater utilization of these parking spaces;

P. Report from Ethics Board

Mayor Rosenblum stated that in the event that the Ethics Board is asked to render a decision and that decision is submitted to the Board of Trustees, the Board needs to review the decision and either accept or reject it. The Ethics Board was asked to render a decision in the hiring of Trustee Santoro's son as a seasonal employee and if this hiring was in violation of the Ethics Code. He believes that this is due to the minimum amount of rain received this summer. If the situation does not improve, the Board may consider a mandatory water restriction.
