PUBLIC HEARING ON FISCAL YEAR 2010-2011 TENTATIVE BUDGET

On motion of Trustee Ybarra, seconded by Trustee Santoro:

RESOLVED that the Public Hearing on the Village of Mamaroneck Tentative Budget for Fiscal Year 2010-2011 be and is hereby open.

Mr. Slingerland gave a PowerPoint presentation on the tentative budget summary. The total projected spending for the fiscal year of \$28,545,642 has been reduced from last year's budgeted spending of \$29,060,094 or by 1.77%. Mr. Slingerland thanked all department heads for drafting excellent department narratives and for working so closely and cooperatively with the Assistant Village Manager and Clerk-Treasurer in putting forth such a fiscally responsible budget. This year the Village's allocation of taxes paid by residents is approximately 22%. Mr. Slingerland stated that in the past ten years, the Village has lost approximately two million dollars in the assessed values of homes. This is attributable to tax certioraris.

Mr. Slingerland stated that the lost non-property tax revenue amount for the year is approximately \$500,000. This is attributable to the decline in mortgage tax, sales tax, building permits and parking revenue. The Mayor thanked the Village Manager and Clerk-Treasurer for their foresight in planning ahead during this economic downturn. The pension system appropriations were discussed. Mr. Slingerland reviewed the budget expenditures and the percentage of each department and service. Mr. Slingerland stated that the annual percentage increases over the last several years has been averaging 3.6%, with this year being proposed at 0.35%.

Mayor Rosenblum thanked Mr. Slingerland and Mr. Fusco for a fantastic job. When he was first elected, he informed them that he was looking for a zero percent tax increase and as far as he is concerned, they met that goal. He also believes that this is the best budget in Westchester County and he thanked all staff and department heads for this work.

Trustee Hofstetter stated that money from the fund balance and contingency account are being pulled into this budget and he wanted to make sure that the fund balance is adequately funded. Mr.

Slingerland stated that the current fund balance is approximately \$2.8 and he is expecting to add approximately \$330,000 to it at the end of the year; which will bring it back over \$3 million. At the current rate, this is still 10 percent of the yearly budget. Mr. Slingerland stated that we have a bond rating of A+, which is among the highest in Westchester County. When asked by Trustee Ryan if the Village has ever had a higher bond rating, Mr. Fusco stated that we have not had a higher rating in the last 15 years. Mr. Slingerland stated that the contingency is at \$150,000 and according to our auditors, that along with the fund balance is a supportable figure given the economic times. Trustee Hofstetter asked about filling and funding any open positions in the Village. Mr. Slingerland stated that the open positions will continue to be shown in the budget, but not funded. If additional revenue is restored, the Board may wish to reinstate these positions. Trustee Santoro asked what the reason was for the sharp increase in the fund balance in the last few years. Mr. Fusco stated that the departments have been very cognizant of the economy and have come in under budget. Trustee Hofstetter stated that monies from that fund had been used to pay legal fees in the past and the board worked very hard to build the fund back up. Mayor Rosenblum believes that the Village is secure in its budget and he would like to keep as much money as possible in the hands of the tax payers.

1. COMMUNICATION TO THE BOARD

Mr. Irving Scharf of Richbell Road appeared regarding the reassessment of property. Mayor Rosenblum informed Mr. Scharf that this is being done at the Town level, not the Village and that he should voice his concerns there.

Mayor Rosenblum stated that this is the first set of minutes being presented since the Manager suggested that all public hearings be part of the meeting minutes.

Trustee Ryan had an addition to the minutes of 3/22. On page 2, after Ms. Kramer's comments, Trustee Ryan stated that she is concerned about Ms. Kramer's comments about how the changes will affect the Zoning Board of Appeal as she certainly does not want to tie their hands in allowing them to perform their duties. She said that because of the strong possibility of being fined, she will vote in favor of this proposed law with the understanding that amendments to it based on expressed concerns, such as Ms. Kramer's, will be addressed immediately.

He asked if this is part of the deductible being charged by the insurance company. Ms. Derrico stated that Jackson Lewis has a monthly retainer and also handles separate lawsuits. She will look into these charges and advise. Mayor Rosenblum also asked why the Village only uses the Journal News for posting legal notices when there are four official newspapers in the Village. He asked that if possible, the other newspapers be used for notices. Mr. Slingerland stated that a restriction might be that the Journal News is a daily newspaper and the others are weekly. The Mayor also asked why the Village pays separate cable bills for different buildings across the Village. Mr. Slingerland stated that Cablevision may have different rates of charge for different buildings.

Trustee Hofstetter also asked about the replacement of broken handheld devices. Mr. Slingerland will look into that and advise.

INNOVATIONS, INC. (COMPLUS) FOR PARKING CITATION MANAGEMENT
SERVICES

WHEREAS, for approximately 15 years, the Village has utilized the Parking Citation Management Services of Law Enforcement Systems, Inc., (LES) of Long Island City, New York, to process parking tickets; and

WHEREAS, services provided through this contract include the data entry of hand written tickets, data collection, storage, and mailing of past due violation notices; and

WHEREAS, an item reviewed during the FY 2010/11 budget discussions among Village staff and the Board of Trustees was the current agreement for Parking Citation Management Services and whether additional cost savings or service improvements such as registering of scofflaws with the New York State Department of Motor Vehicles and the provision of handheld ticket writers could be achieved through the solicitation of proposals from qualified firms; and

WHEREAS, our current agreement with LES, executed in 2006, provided for a fee of thirty-six percent (36%) of all parking ticket revenues collected for violations outstanding in excess of sixty (60) days and had a three-year term that expired June 30, 2009 with two (2) additional one-year renewals which renew automatically unless the Village notified LES more than ninety days of in advance of the renewal date of its intent not to renew; and

WHEREAS, the Village provided such notice of its intent not to renew to LES in a letter dated March 4, 2010 and invited and encouraged their participation in a new RFP to be prepared by the Village; and

WHEREAS, Village staff prepared an RFP for Parking Citation Management Services which was reviewed by an internal staff committee with representatives from the Village Administration, Court & Police Department, said RFP finalized and released on March 11, 2010 with copies sent to five (5) firms that provide Parking Citation Management Services; and

WHEREAS, by the response deadline of Monday, April 5, 2010, two (2) responses were received from Complus Data Innovations (Complus) of Tarrytown, NY and T2 Systems (T2) of Indianapolis, IN; and

WHEREAS, in an e-mail dated March 16, 2010, a representative of LES stated they planned to respond and asked for an electronic copy of the RFP so that it could be incorporated into a response; and

WHEREAS, after reviewing the two responses, Staff recommends that Complus be identified as a preferred provider of Parking Citation Management Services and among the highlights of the Complus proposal are the following:

- A flat fee of 10.5% for both in-state and out-of-state tickets;
- Provision of five (5) handheld ticket writers;
- Unlimited free training for Village personnel;
- Registering of scofflaws with the New York State Department of Motor Vehicle's which results in the suspension of vehicle registrations.
- Upgrade all electronic handheld ticket writers at least every 36-months;

- Data entry of all manual tickets as part of the contract;
- Compliance with 60-day implementation schedule;
- Complus to pay for ticket stock for the handhelds for the life of the contract;
- Complus to provide Village with PCs and Laser Printer;
- Repair/replacement of malfunctioning handhelds within 24 hours;
- Free migration of existing data;

and

WHEREAS, the Complus proposal provides for a three-year term with annual renewals available thereafter at the same fixed pricing schedule;

A. Communication on 2006 IMA w/Westchester County for Sanitary Sewer Investigation & Rehabilitation

Mr. Slingerland stated that the Village entered into an IMA with the county in 2006 under which the Village had to file quarterly reports and provide the county with updates on removal of inflow and infiltration, which the Village has been working on, but unfortunately not reporting on. The Village will supply a detailed report to the county. Mr. Slingerland thanked Mrs. Lowey's office for monies which will be used to reline a mile or more of sanitary sewer pipe to keep the I&I out.

- B. Communication on FY 2010 Unified Hazard Mitigation Assistance Program Pre-Disaster Grant Mr. Slingerland reported that one of our grant applications for upgrading our flood plan to an all hazards plan has been picked to move forward.
- C. Communication on Cablevision's HD Channel Line-Up Changes
 Mr. Slingerland read this correspondence.
- D. File for Record Agreement w/The High Road for 2010 Harbor Fest Consulting Services A copy of this agreement was filed for the record with the Clerk-Treasurer's Office.
- E. Communication on Program Change to Verizon FIOS TVMr. Slingerland read this correspondence.
- F. File for Record DEC Notice of Violation

Mr. Slingerland reported that the Village received a notice of violation from the DEC for an audit of the Village's municipal separate storm sewer system program. The violations are subject to fines of up to \$37,500/day/violation. This was received on March 30 and the Manager submitted a response. What they noted at their audit was that the Village was doing the work, but not reporting on it. Mr.

Slingerland reported on what was sent to the DEC with his response letter. Mr. Slingerland has requested a follow up meeting with the State to insure that all issues have been addressed.

7. FLOOD MITIGATION REPORT

Mr. Slingerland reported that he and the Mayor have been in contact with the county to follow up on the stream cleaning permit; which was submitted to the county last fall. Keith Furey is working with them as well so that the Village can get the permit and begin the cleaning. Mayor Rosenblum stated that the Village was extremely lucky in the past month with the big storms that we have had. Mayor Rosenblum stated that he is tired of talking about flooding, and doing nothing. He believes that the Village has to raise the funds or bond the funds so that we are able to complete projects such as the Winfield Avenue Bridge, Jefferson Avenue Bridge and removing the Road to Nowhere, as well as cleaning out silt in the streams and rivers.

Trustee Ryan agrees with the Mayor; however, there are processes that have to be gone through. It takes time and the Village needs permission to do what we can. It has taken since 2007 to get permission, although we are still waiting for the county, to do these projects. Mayor Rosenblum stated that the Village should have applied for funding from the county; however, it was not done because there was a position taken that we cannot do anything until the Army Corps study is done. Mayor Rosenblum stated that the Army Corps and DEC gave the Village permission to remove the Road to Nowhere. Mr. Slingerland stated that his office received notification that the money received from Mrs. Lowey's office can be used for the Road to Nowhere project. Mr. Slingerland is hoping to meet with the county executive in a couple of weeks to show him the problems and projected projects. Mr. Slingerland also stated that the Village staff is being proactive, instead of reactive to potential flooding. Mr. Slingerland reminded all that the kick off meeting for the signing of the agreement with the state, county and federal government will be Monday, May 3. There will be a kick off meeting with the Army Corps sometime in June.
