PRESENTATION ON COMMUNITY COUNSELING CENTER

Dr. Mark Levy, Executive Director of the center appeared. He gave a brief history on how the center was established by the Village of Mamaroneck Board of Trustees in the 1970s. He outlined the different programs offered by the center; the core of which is crises intervention and counseling work. He thanked his staff for their professionalism and dedication.

Dr. Levy informed residents that no one is turned away for any reason. If there are money issues, patients are billed on a sliding scale and if the center does not have the resources to help, residents are referred elsewhere.

Mayor Rosenblum asked about funding. Dr. Levy stated that as the center is a non-profit agency, with no grant writers or extra staff to do marketing, they rely on donations from the community. The bulk of their funding comes from NY State. Every year, they re-write their grant and are refunded; however, with budget cuts, they are not sure how much they will receive from the state this year. All donations are tax deductible and it was asked that residents, who would like to make a donation, contact the center.

Mayor Rosenblum and the Board thanked Dr. Levy and his staff for all of their work.

B. Resolution for NY State Shared Services Grant with Consortium of Municipalities and IBM For Collaborative Municipal Services Concept

Mr. Slingerland stated that this was discussed at a previous work session. We have an agreement with several municipalities and IBM to submit an application to the local government efficiency program to discuss ways to work with a company like IBM who could prepare a platform

that would save duplication in effort. This application to the state is for \$50,000. Mr. Slingerland stated that he anticipates that our match would be \$1,000 - \$2,000, but is trying to get that waived.

WHEREAS, The Board of Trustees of the Village of Mamaroneck recognizes that there are inherent benefits in cooperating with other municipal jurisdictions to study and implement the sharing of municipal computer and software support services, and

WHEREAS, the decision to use certain computer software in various government departments is made primarily for the purpose of meeting a particular department's individual need, and

WHEREAS, the integration of that software with other operating software systems may not be the primary factor in reaching a determination, and

WHEREAS, each software application or a combination of several software applications must reside on a series of computer servers that each municipality must purchase, support and upgrade as software requirements become more complicated, and

WHEREAS, the cost of purchasing, supporting and maintaining the above redundant equipment over time becomes an increasing financial burden to local governments, and

WHEREAS, the use of technology in the public sector should ultimately benefit our residents by providing them internet access to Town/Village Hall to transact business, purchase permits and enroll in various programs, now therefore be it;

C. LGE Grant Application w/Villages of Port Chester, Rye Brook, Mamaroneck, Larchmont, Town of Mamaroneck and Town of Rye to study the Consolidation and Dissolutions of Local Governments

Mayor Rosenblum stated that there have been public comments on this and there was a meeting held last week with the Town of Mamaroneck, Town of Rye, Village of Port Chester and Village of Rye Brook. There were open questions at the end of that meeting that have not been answered. At that time, the Village of Mamaroneck was not in support with going ahead. There has been a slight change since that time; however, the Board is not going to move forward at this time, but will discuss further at their next work session scheduled for March 15. Mr. Slingerland stated that this was put together with the interests of the Village's of Port Chester and Rye Brook and this Board wants to ensure that the interests of the Village of Mamaroneck are taken into consideration. The grant application is due on March 17 and he is hoping that the application can be agreeable to all.

Trustee Hofstetter informed residents that there has been a change in New York State law that allows for a referendum to be put on local ballots if enough signatures are gathered, to vote on dissolution and consolidation of local governments. It is much better for the Village if officials and residents are educated on these possibilities, if the municipalities decide to go forward. He further stated that it is extremely important to assure that Rye Neck is taken care, before moving forward.

Mayor Rosenblum stated that there are several scenarios that could happen, and that residents should not panic, as this Board will make sure that Rye Neck is taken care of.

This item was tabled to the 3/15 Board of Trustee Work Session

- 5. NEW BUSINESS
- A. Transfer of Funds for Firehouse Kitchens

Mr. Slingerland stated that this is for the completion of work at the new firehouse. Trustee Hofstetter stated that he is concerned about approving a budget transfer on the firehouse when there are still outstanding issues. Until there is a final accounting of all the monies spent, Trustee Hofstetter believes that this should be tabled. Mr. Slingerland stated that all money allocated for the firehouse project is tied up for those projects and if we wait, it will put the completion of the kitchens off for three to four months.

Trustee Ryan asked if we can recoup any of this money. Mr. Slingerland is not sure if any money will be recouped. Trustee Ryan also asked if it has been decided which bid would be accepted. Mr. Slingerland stated that the bids are still being reviewed. When asked why the amount of the transfer is \$60,000, when the bids came in around \$30,000 - \$35,000, Mr. Fusco stated that it is his understanding that the additional money will be used to outfit the kitchens and to cover an outstanding Frank & Lindy Plumbing invoice. Trustee Hofstetter is not going to vote in favor as he would be more comfortable waiting to get a final accounting of the monies spent. Trustee Ryan feels very pulled on this issue and she is in hopes that we will recoup some of this money, although she understands it is not certain. However, because this was part of the original specs, she will vote in favor.

WHEREAS, by resolution dated January, 8 2007, the Village of Mamaroneck Board of Trustees appropriated the sum of \$9,400,000 for the construction of the new Palmer Avenue Firehouse located at 146 Palmer Avenue, Mamaroneck, NY and among the four (4) prime contracts for this work, the Village awarded the General Construction Contract to Subolo Contracting Corporation, 433 Manville Road, Pleasantville, NY 10570 in the amount of \$5,551,000; and

WHEREAS, an item provided for in the general construction contract specifications was the construction of kitchens and in their original submission, Subolo Contracting identified a cost for this work of approximately \$60,000; and

WHEREAS, during the course of construction, rather than have Subolo perform the work, the Village believed that this kitchen work could be done a lower cost if it was separated from the base contract and performed by companies that specialize in Kitchen installation; and

WHEREAS, although there was a \$60,000 credit towards the general construction contract as a result of parsing the kitchen installation work, those funds were expended to cover other project change orders and cost overruns caused by circumstances beyond the Village's control; and

WHEREAS, upon final completion of the Palmer Avenue Firehouse Project a final closeout will be performed and a determination of final costs due to the contractors and consultants will be made and a final budget transfer request may be submitted to the Board of Trustees for consideration at a future meeting, however, a budget transfer is currently required in order to perform the kitchen installation work; now therefore be it

Resolution Requesting Home Rule Legislation (as amended) For Assembly bill number A 9182-B and State Senate bill number S6152-B to correct a Pension System Matter for two Police Officers employed by the Village of Mamaroneck, NY

WHEREAS, Scott A. Fraoli and Dominic Lanza (the officers) are presently employed by the Village of Mamaroneck Police Department; and

WHEREAS, pursuant to New York State Retirement and Social Security Law § 384-d the Village of Mamaroneck elected to provide an optional twenty (20) year retirement plan for police officers who chose to enroll in said plan; and

WHEREAS, in accordance with New York State Retirement and Social Security Law § 384-d (Section 384-d), any member of the New York State Retirement System who is a police officer in the Village of Mamaroneck may elect to contribute to the twenty (20) year plan within one (1) year after he or she becomes a police officer; and

WHEREAS, Village Police Officers Scott A. Fraoli and Dominic Lanza failed to enroll in the twenty (20) year retirement plan under § 384-d within the one (1) year time period and instead unintentionally enrolled in the twenty (20) year retirement plan covered by § 375-i; and

WHEREAS, in order for the officers to join the twenty (20) year retirement program the State of New York must enact special legislation and the Village must make a home rule request; and

WHEREAS, the Village of Mamaroneck is requesting the legislation in order to correct an inequity that resulted from the actions or inactions of the officers; and

WHEREAS, the fiscal implications of this home rule request would result in a past service cost contribution of approximately \$188,000 from the Village of Mamaroneck and an increase of approximately \$7,700 in the annual contribution of the Village; and

WHEREAS, the Board of Trustees of the Village of Mamaroneck believes that it is in the best interests of the Village to request the New York State Legislature to adopt such home rule legislation;

Mayor Rosenblum asked about the Town's participation. Mr. Slingerland stated that there are past stipulations that the Town will refund half of the cost of replacement of the bridge and that the Town has confirmed this.

C. File for the Record – Westchester County C-67-07-S28 Sidewalk Improvement Project on on Boston Post Road

Mr. Slingerland reported that this has been filed for the record with the Clerk-Treasurer's office.

D. File for the Record – IMA Contract – Westchester County Refuse Disposal District #1

Mr. Slingerland reported that this has been filed for the record with the Clerk-Treasurer's office. He also stated that this is a 10-year based agreement with the first 5-year renewal at the County's option and the second 5-year renewal by mutual agreement.

Mr. Slingerland also reported that his office has put out to bid the parking ticket and parking citation management services. There is a company that has worked with us for several years, but his office is confirming that we are getting the best services at the best price. Trustee Hofstetter asked if this would include tickets being written on a better material, as a ticket he received was frozen to his windshield and when he peeled it off, it was not readable. When taken in for payment, it could not be reconciled at the Court Clerk's office immediately. Mr. Slingerland stated that the goal is to have improved, handheld equipment to scan the bar code that is on everyone's windshield and to print tickets on Mylar or plastic. Mayor Rosenblum stated that it has come to the Board's attention that there are hundreds of thousands of dollars being lost by unpaid ticket and asked that the Village Manager work with the Village Attorney and Chief of Police to study has this can be rectified.

Mr. Slingerland reported that he received communication from Cablevision that affective April 5, 2010 they will no longer be offering the analog family package to new customers.

7. FLOOD MITIGATION REPORT

Mr. Slingerland reported that the Army Corps of Engineers is working to schedule a kick off meeting for the first week of April. As soon as that date is confirmed, the Village will issue a press

release. The County stream permit is still being reviewed by the County. They repeated their request for information; which Mr. Slingerland will follow up on. His office is moving forward on several grants; the \$125,000 FEMA grant and the \$485,000 EPA grant for storm water remediation. Mr. Slingerland discovered that there is an exiting memorandum of agreement with the County for the remediation of inflow and infiltration and it is his understanding that the original intent of the \$485,000 grant was to remove the inflow and infiltration from the sanitary sewer systems. However, we may need a law change and he will follow this procedure with the appropriate entities. His office continues to work with Mrs. Lowey's office regarding the appropriations grants submitted. Ms. Jackson, Chair of the Flood Mitigation Committee, stated that they are planning to invite County Executive Astorino to go on a river walk as they have found that until you see the problems, the magnitude it is not understood. This invitation will be drafted by Mr. Slingerland and will come from the Mayor and Board. They are hoping to have the walk on April 15, the anniversary of the flood.

Mayor Rosenblum asked how we were going to move forward on negotiating with Harrison on use of the Munzimucker and what authority we have to clean the rivers. Mr. Slingerland stated that we can do the same cleaning that was done last year and the DPW continues to clean the storm drain grates. The Committee is working on coordinating the river clean up date.

8. REPORT FROM CLERK-TREASURER

Mr. Fusco reported that the Tax Lien Sale will take place at Village Hall at 123 Mamaroneck Avenue on Wednesday March 10 at 10 a.m. Mr. Fusco also requested an Executive Session to discuss contract issues in regard to the Tax Lien Sale.
