A. Authorization for Village Manager to Execute Agreement with NY GIS Group

Assistant Building Inspector Rob Melillo appeared. Mr. Melillo presented the proposal that will take advantage of the grant monies the Village has received for this purpose, as well as reporting on the advantages of this program. Mr. Slingerland stated that the proposal in the packages will be changed slightly including that the Village of Mamaroneck will own the data compiled. Another change is that instead of having the information scanned and therefore static, the information will be inputted into the system, and updated whenever the Assessor updates it here. Mr. Melillo explained to the Board how the Village could charge for some of the services that will be offered on line through this service, therefore, recouping some of the yearly service charge. This will also lessen companies from coming into the building department and going through files, which in the past resulted in missing or misfiled information.

the Village of Mamaroneck, which must be reflected in the agreement; and

WHEREAS, THE NY GIS GROUP has agreed to these terms and the Village and THE NY GIS

GROUP wish to proceed with this project to fruition, including the annual operation and maintenance

of the information and data by THE NY GIS GROUP, with additional charges to be spelled out on a

unit price basis by property parcel for inputting new data to reflect new building permit information

such as the construction of an addition that changes the footprint of a property, or the creation of a

subdivision or site plan for a new structure, or structures.

F. Authorization for Village Manager to Execute Agreement with Village Attorney

Trustee Ryan asked if Ms. Derrico will be attending HCZM and Ethics Board meetings as part of her retainer agreement. Mayor Rosenblum stated that she would attend those or any other Board or Committee meeting as required. Trustee Ryan also asked who would be the person instructing Ms. Derrico if she was needed at a meeting. Mayor Rosenblum stated that would come from the Village Manager. Trustee Ryan asked how the Board will know how Ms. Derrico is spending her time doing the work for the Village and if there could be an accounting of this done. Ms. Derrico stated that currently she is in the Village office on Mondays and Tuesdays; however she will meet with Mr. Slingerland to work out a system which will show the days she will be in the office and/or performing Village work so that it may be monitored. Trustee Ryan stated is uncomfortable paying for December as there was no accepted contract in place and it is not customary to pay for a service when you have no idea what the charges will be.

Trustee Hofstetter had another pro forma contract which includes an insurance and indemnification clause as well as a professional liability clause and ownership of documents clause. He also stated that this contract calls for a 90 day termination clause, when other contracts are at will. He would also like to see a dispute resolution clause in the contract. Trustee Hofstetter asked about the clause that states that in the event Ms. Derrico is not available, a representative from her office would fill in. Ms. Derrico stated that in this case, Ms. Martha McCarty will work with the Village and this would be to fully cover the Village's needs. She also stated that this may happen with court calendars as there may be two court appearances at the same time. Trustee Hofstetter believes that Ms. McCarty's name should also appear in the contract. Trustee Ryan stated that she is uncomfortable with this arrangement as the individual will have access to files and to other information that may be confidential

Trustee Ryan questioned the 90 day clause. She believes that this is not Village policy. She asked that this be investigated.

Mr. Tom Murphy of Prospect Avenue appeared. Mr. Murphy questioned non-retainer services and that one of the things not covered by retainer is comprehensive zoning revisions. He has heard that the Board would like to change many things about the zoning code. Has the Board considered the cost of this? Another question is on non return services litigation. He asked if this means the attorney can charge when she is talking to other attorneys handling our litigation. He also has issue with the 90 day cancellation clause. On a one year contract, this is one-quarter of the length of the contract and if the Board decides that they do not like the work being done, they still have to pay for three months. Mr. Murphy stated that one part of the law that was not changed this evening is the attorney can be removed by a majority vote of the Board. If this happens, it does not seem in the best interest of the Village to have to pay for three additional months. Mr. Murphy urged that this contract be reviewed by another attorney who handles contracts, as the Board is negotiating this contract with no legal representation.

Ms. Randi Robinowitz of Lawn Terrace appeared. Ms. Robinowitz agrees with the idea of running this contract by one of our labor attorneys and that this be done before the contract is approved.

Ms. Nancy Wasserman of Raleigh Road appeared. Ms. Wasserman asked what Ms. Insardi had to do if she had to be in two places at one time? Trustee Hofstetter stated that this never arose as the Village was her only client.

Trustee Hofstetter stated that he saw on many news reports that the Village Attorney compensation was supposed to be \$40,000, now we are talking about \$60,000 for 16 hours per week and \$205/hour for any additional work. The total compensation of the previous attorney was \$161,000 and given the number of meetings that the attorney will have to attend, if this number of hours amounts to 10 hours per week; the amount would be exactly the same as paid to the previous attorney. If the attorney were to work 35 hours per week the cost would be \$262,000 per year. As the contract does not delineate if Ms. Derrico will be using the hours attending meetings as part of her 16 hours per week, or charging the hourly fee for these meeting, Trustee Hofstetter is extremely concerned that the Village is heading down the same path it was on in the past. He feels that we had a competent person in the position who was never asked if she would consider working part time. He is also concerned that the bi-weekly reports have not been received since the beginning of December and the last one received was prepared by the previous attorney. Ms. Derrico informed him that her report will be received by the Board before their next work session. Trustee Hofstetter is also concerned as contract does not have the clauses that Mr. Hofstetter would like to see in it; as he mentioned above.

Trustee Ryan reiterated her concerns, which include paying retroactively, the 90 day clause, no delineation of the scope of work to be performed and conflicts of interest, specifically her business associate filling in for her on Village business and in Village Hall and how Ms. Derrico's work for the Village will be handled when her husband's firm (that represents the Village on some issues) is involved.

WHEREAS, the Village desires to retain counsel to advise the Village Board of Trustees, Planning Board, Village Manager, Village Clerk, Village Engineer and Other Village Staff; and
