A. Authorization for Village Manager to Execute Canon Copier Lease Agreement

Mr. Sarnoff gave a brief background on how the Village has been trying to align their copier leases for years and have not been satisfied with the Xerox copiers nor the service provided. He, Mr. Fusco and Ms. Roberts have met with two companies that are on state contract and after all the information was gathered, it was recommended that the Village go with Canon copiers through Vista Digital Solutions.

Mr. Asim Ali from Vista Digital Solutions appeared and answered the Board's questions.

- Pickup and return of all Xerox equipment
- Buyout of existing Xerox leases
- Free toners and associated machine parts
- Monthly Preventative Maintenance service calls
- Quarterly service satisfaction meeting with account representatives
- Lease term of 63 months, however eligibility for upgrades every 36 months
- A pool of 3,150,000 copies over the lease term : and

WHEREAS, in pursuit of our due diligence responsibility, Village staff visited existing customers and contacted references at Rye Middle School and the Mamaroneck Union Free School District and they reported positive experiences with Vista Digital Solutions and Canon copiers.

E. Authorization to Execute Taylor's Lane Leachate Sampling Contract with Zion Environmental Mr. Slingerland reminded residents that the Village is continuing the clean up of the Taylors Lane site. There is an ongoing issue with Leachate entering the groundwater and the DEC has asked that we work with the County to dispose of this into the stormwater system. At this point, it cannot be disposed of through the stormwater system. The sampling being contracted is for DEC requirements. Mr. Slingerland stated that there may be additional sampling required by the County when we begin to dispose in the sanitary system.

RESOLUTION RE: AUTHORIZATION TO EXECUTE A PROFESSIONAL SERVICES AGREEMENT FOR LEACHATE SAMPLING AT THE TAYLOR'S LANE SITE

WHEREAS, in accordance with our grant agreement with New York State for remediation at the Taylor's Lane Site, periodic sampling is required to measure the levels of Leachate in the soil; and

WHEREAS, in accordance with this requirement, staff prepared a Request for Proposals (RFP) for this professional service which provided for ten sampling events over a five-year period; and

WHEREAS, on the RFP return date, three (3) responses were received with the lowest responsible bid submitted by Zion Environmental (Zion), 172 Excelsior Avenue, Middletown, NY 10940, in the amount of \$35,000; and

WHEREAS, although the Village has not directly contracted with Zion in the past, they have previous experience with the Taylor's Lane site as they were a subcontractor for other vendors during previous sampling periods and the Village was satisfied with the quality of their work.

F. Support of Home Rule Legislation to allow Hotel Occupancy Tax

Mr. Sarnoff stated that last year, the Village of Rye Brook was the first village in New York State to receive special legislation to allow it to levy a hotel occupancy tax. Since that time, Assemblyman Latimer asked the Village if this is something we would be interested in as we have two motels in the Village. Two bills have been introduced by Assemblyman Latimer and Senator Oppenheimer after the Board asked them to follow up on this. The Village's support of this Home Rule Legislation is needed.

Ms. Barbara Epstein, owner of the Mamaroneck Motel appeared. Ms. Epstein is not sure how this is going to affect her motel and asked what percentage the tax will be. Mr. Sarnoff believes that it is 3% per day. Ms. Epstein is concerned that this will be a hardship that will affect her small business. She hopes that the Board is very mindful when they deliberate on supporting this legislation. Trustee Hofstetter stated that this legislation only permits the imposition of the tax if they decide to implement it. They are not passing the implementation of the tax at this time.

3. Establishing Emergency Response Parking for Fire Department Drivers at Volunteers

Mr. Slingerland stated that this is something that has been requested by the Fire Council, to have adequate parking for the emergency response fire department drivers at Volunteers Fire House on Mamaroneck Avenue. It was recommended that there be three spaces provided for this purpose. Trustee Ryan asked how this will impact the businesses located there as it is a very busy street and very few spaces. Trustee Santoro spoke with the store owners and they are not happy with this proposition. Trustee Santoro suggested that part of the sidewalk be taken when they are scheduled to be redone, as it is very wide, so that drivers can pull into two spots head first, which will take up less room. The Board was concerned that it would be dangerous backing out of these spots as Mamaroneck Avenue is curved at this point and they will not be seen by oncoming traffic. The Board suggested looking at having these parking spaces on Sheldrake Avenue. Trustee Santoro stated that a major issue is that they frequently need to park in the early hours when parking is not allowed and perhaps changing the Code to state that parking of fire department personnel vehicles is permissible 24 hours a day would be a solution.

The Board agreed to table this item and ask the Traffic Commission to revisit this issue.

N. Budget Transfer to Provide Additional Funding for 2010-2011 Snow and Ice Removal Budget

RESOLUTION RE: SUPPLEMENTAL APPROPRIATION TO FY 2010/11 BUDGET

WHEREAS, under New York State and local laws and the basic tenets of local and municipal government, the Village of Mamaroneck maintains primary responsibility for control of snow and ice on all local roads to ensure continued access of public roadways for emergency vehicles and other routine traffic, as well as access roads to major highways and thoroughfares like I-95 and US-1; and

WHEREAS, in order to provide such snow and ice control in a safe and cost effective manner, the Village uses Village employees and equipment, and private contractors as needed, to perform this service; and

WHEREAS, the average annual snow fall for the NY Metropolitan Region, including the Village of Mamaroneck, is approximately 30 inches per year (from the National Weather Service), however, the Village has experienced numerous storms this year with snowfall accumulations during the 2010/2011 winter in excess of 60 inches, which is approximately double our annual average; and

WHEREAS, as a result of the significant level of snowfall during the 2010/11 winter, the Department of Public works has advised the Village Manager of cost overruns in the Village's snow budget A.5142 of approximately \$125,400 for materials and supplies, employee overtime, and outside contractors necessary to clear and remove snow in order to restore local roads and streets to a level of safe and open vehicular access; and

WHEREAS, the Village Manager, in his capacity as Budget Officer has reviewed this matter and based on these discussions recommends that the Board of Trustees provide a supplemental appropriation to cover current and anticipated expenses for the remainder of Fiscal Year 2010/11.

The economy is in difficult shape, but consumer spending has been increasing. A huge increase in gasoline and oil costs have been seen, which affects food and transportation costs. This will impact utilities, the price of asphalt and fuel costs.

Mr. Slingerland received a letter and detail plans for the Rockland Avenue Bridge project from the New York State Thruway Authority.

7. FLOOD MITIGATION REPORT

Mr. Slingerland stated that bids were due last week on the Hazard Mitigation Plan RFP. We received eight responses; six of these were under \$40,000. These are being reviewed and they hope to have a recommendation to the Board by their next meeting. The Department of Public Works has been cleaning the catch basins and storm grates at the Mamaroneck River Dam. We experienced our first large rain of the season last week and there was no flooding. Trustee Hofstetter asked that the rivers be checked at the high tide point in the Sound to see if things are backing up. Mr. Slingerland reported on the testing being done at the Jefferson Avenue Bridge and that the design should be done shortly. Trustee Hofstetter is concerned with having the work done on the Jefferson Avenue, Barry Avenue and Rockland Avenue Bridges at roughly the same time. Mr. Slingerland stated that he will coordinate these projects to have the least amount of impact possible.

Mr. Daniel S. Natchez, president of Daniel S. Natchez and Associates appeared to address the Board regarding the question of underwater lands being owned or not owned by the state. There are pending applications and appeals before the Zoning Board and this does not concern these applications. Because this question affects the Village's entire harbor and waterfront areas, he proposes, on behalf of the Shore Acres Property Association and others, that the Board pass a resolution asking the state of New York if they own the lands now or formerly underwater. Trustee Ryan spoke with Assemblyman Latimer about this and he and Senator Oppenheimer have written a letter to the Department of State asking that a study to determine who owns the half acre in question by the Mamaroneck Beach and Yacht Club be done. Trustee Ryan read an email sent by Assemblyman Latimer regarding this issue and their request made. Mr. Natchez is appreciates this, but he believes that as this affects much more than just this half acre, the Village should go on record asking for this to be determined.

Mr. Silverberg reminded the Board that Mr. Natchez is a party to an action brought against the Planning Board regarding the use of this property. Mr. Natchez is correct that this issue has nothing to do with the application currently before the Village; however, he and his counsel have raised issue regarding the ownership of this property. His counsel forwarded a letter to the Village Assessor this week in which he made claims that actions of the Assessor by recognizing or not recognizing ownership of this property on a tax assessment potentially affected his clients. Under these circumstances, Mr. Silverberg suggests that the Board not take action on this issue without further discussion in executive session. Acting Mayor Santoro suggested following the advice of Mr. Silverberg and feels uncomfortable going any further with this discussion. Trustee Hofstetter believes that the resolution does not ask for the Board to do anything outside of their responsibility and does not ask that the OGS do anything outside of the ordinary. Trustee Ryan agrees that it does not appear to be out of the ordinary to ask, but as it has already been asked by Assemblyman Latimer and Congresswoman Oppenheimer and if nothing comes from this request, then perhaps the Board can move forward. Trustee Hofstetter believes that all parties involved would like to have this resolved as soon as possible. Trustee Hofstetter asked that the following resolution presented by Mr. Natchez be included here for the record:

Whereas there has been a threat of new litigation against the Village of Mamaroneck regarding ownership of lands now or formerly underwater in the vicinity of the Mamaroneck Beach & Yacht Club, and

Whereas the Board of Trustees of the Village of Mamaroneck has a fiduciary obligation to protect the Village of Mamaroneck from litigation as best it can, and

Whereas the Village has a well established and successful policy of working with the State of New York regarding the use of lands now or formerly underwater, and

Whereas Otter Creek is a designated Critical Environmental Area, and

Whereas substantive issues that have been raised abut the land now or formerly underwater that nay or may not belong to Mamaroneck Beach & Yacht Club, the State of New York, or other party(ies), and

Whereas the determination of such ownership can affect existing practices with respect to land now or formerly underwater on the east side of the Mamaroneck Harbor as well as the administration of much of the waterfront of our maritime community, and

Whereas the Village of Mamaroneck desires to continue to cooperate and to avoid unintended conflict with the State of New York and other waterfront property owners in the administration of the Village of Mamaroneck's Land Use Policies,

Now Therefore Be It Resolved that the Board of Trustees of the Village of Mamaroneck request the New York State Office of General Services, as landlord for New York State lands above and below water, to study and to advise the Village of Mamaroneck as to the Sate of New York's ownership interest, if any, in the lands now or formerly underwater around Mamaroneck Beach Club, including Otter Creek area in the vicinity of the Club.

Trustee Ryan believes that this should be discussed further in executive session and followed up on with Assemblyman Latimer and Senator Oppenheimer.

<u>Updates from the Board</u>

Trustee Hofstetter stated that he received an invitation to the Annual "Seniors" Prom from the

Town at Mamaroneck High School, run by the high school students. Unfortunately, they will be at a

meeting that evening. There will also be a St. Patrick's Day luncheon at the Weaver Street Firehouse on

March 14. Trustee Hofstetter asked that the presentation on the Showboat be put on the Village's

website.

Acting Mayor Santoro reported that early camp registration starts March 3. There will be a new

summer program for ages 5-13, which is an all sports camp. There will also be an LWRP Update Meeting

on March 2 at 7:30 0.m.

Mr. Bill Reed appeared in support of the Showboat moving to the Village of Mamaroneck.

On motion of Trustee Ryan, seconded by Trustee Albert,

RESOLVED that the Board of Trustees convene to executive session to discussion personnel and

matters of pending litigation.
