Mayor Rosenblum asked for a moment of silence in mark the loss of one of our police officers and friend, Sergeant Tom Anderson.

Mayor Rosenblum requested that Item 4H, under New Business be taken out of order.

#### 4. NEW BUSINESS

H. Resolution Appointing Police Sergeant

On the motion of Mayor Rosenblum, seconded by Trustee Ryan, and vote of four in favor, none opposed, the Board of Trustees of the Village of Mamaroneck hereby convenes as the Board of Police Commissioners of the Village of Mamaroneck.

On the motion of Mayor Rosenblum, seconded by Trustee Santoro, and vote of four in favor, none opposed, the Board of Police Commissioners of the Village of Mamaroneck hereby adopts the following resolution:

Chief Christopher Leahy appeared to speak on the appointment and the importance of this position in the department. Chief Leahy congratulated Officer Ricozzi on his stellar career and on his appointment. Chief Leahy believes that he will excel in this position.

Mayor Rosenblum swore in Officer Ricozzi.

#### MAYORS REPORT

Mayor Rosenblum asked to take this out of order as the children need to get home. He stated that he was invited by Ms. Katherine Offner to attend her Bellows fourth grade class to see their Butterfly project.

Ms. Offner appeared with students from her current as well as last year's class. Ms. Offner stated that last year, her class watched a video entitled *The Paperclips Project* about a class in Whitwell Tennessee who decided to foster a greater understanding of the number of people killed in the Holocaust by collecting eleven million paper clips to represent all of the victims of the Holocaust. Norwegians wore paperclips on their lapel in protest of the Jews of Norway having to wear a yellow Star of David on theirs. This project eventually garnered world wide publicity and they not only reached their goal of collecting 11 million paper clips, but gathered three times that amount. The German government along with two journalists, who publicized the project, sent an actual cattle car to house what would eventually become a Children's Holocaust Memorial Museum on the grounds of the school. Six million paperclips were put into a Plexiglas container within the rail car to memorialize the number of Jews killed. Eleven million paperclips were put into a triangle tomb to remember all of the victims of the Holocaust. The current students of the school act as stewards and curators for the museum as they continue to receive paperclips, letters from surviving families and even hate mail.

Ms. Offner stated that she and her students have been fortunate to be able to speak to Ms. Hooper and her students in Whitwell, TN. Ms. Offner's class decided to collect butterflies to represent the 1.25 million children that died during in the Holocaust. It was their hope to complete the project by the time last year's fourth grade class graduates from Rye Neck High School. The butterfly has particular significance. The poem, I never saw another butterfly, was written by a young boy who perished during the Holocaust and the butterfly became a symbol to the children. Children of Ms. Offner's current and this year's class appeared to show some of the collection and to share their personal reflections of the project.

The Board thanked Ms. Offner and the children for attending this evening and for their bringing their project to the attention of the residents.

#### PUBLIC MEETING ON PRE-DISASTER HAZARD MITIGATION PLAN

Mr. Sarnoff gave a brief background on the draft multi-hazard mitigation plan. The disaster mitigation act of 2000 and the national flood insurance program require that all local governments adopt an approved mitigation plan to be eligible to receive future hazard mitigation and flood prevention grant funding. To fulfill this requirement, the Village sought and received a planning grant from FEMA. We conducted an RFP process and the retention of the company ETG, to draft a plan which will be adopted by the Board and FEMA. A steering committee of residents as well as members of the staff was formed to help with this plan. The timeline and achievements to date were reviewed by Mr. Sarnoff. Tonight is the second public meeting being held. Public comments need to be received within thirty days of posting the notice of the meeting; which was posted on March 13, 2012. Mr. Sarnoff therefore asked that any and all comments be received by Friday, April 13, 2012.

Mr. Sarnoff introduced the members of ETG, Ms. Valerie Rifkin and Dr. Jim Brower. Ms. Rifkin and Dr. Brower made a PowerPoint presentation on the plan, which is available in hard copy at 123 Mamaroneck Avenue and will be posted on the Village's website. Dr. Brower stated that this plan has many benefits; it identifies the critical hazards and provides remedies, it makes the Village eligible for FEMA hazard mitigation grants, it engages the community in planning and also coordinates with neighboring communities. Dr. Brower explained the process that this plan went through, including coordination with outside agencies; i.e. the county and power and utility companies. Dr. Brower stated that public comments received will be reviewed and incorporated into the plan if appropriate.

Dr. Brower reviewed the coordination of the planning process with the committee, Village staff and ETG, this included hazard identification and assessment, developing mitigation measures, identifying goals and measures and developing the plan. This plan has been sent to FEMA for their input and then that plan is

forwarded to the Board of Trustees for their input and approval. This plan must be updated and revised every five years.

Mayor Rosenblum reported that the Village of Larchmont is just beginning their hazard mitigation plan work with the county. This puts the Village of Mamaroneck a year and one-half ahead of them and many other municipalities in getting this plan done.

Ms. Valerie Rifkin reported on the hazard assessment and identification. This included reviews of websites, documents, prior studies done and discussions with residents. Hazards are prioritized and ranked for scope, frequency, impact and onset and duration of events. Significant hazards were reviewed and prioritized for further analysis. These hazards can have significant impact on health, safety and property damage. Risks to the vulnerable population were assessed next. Ms. Rifkin reviewed the 100 and 500 year flood plain map as well as the hurricane inundation zone. Risks to structures and critical facilities were studied next. These buildings were inventoried. An impact and damage analysis was done including the replacement cost to these buildings. Ms. Rifkin encouraged residents to review the plan and give their feedback.

Dr. Brower appeared to review the next steps, which includes setting community objectives and goals including mitigation planning. Numerous tables listing activities were developed and action plans to address these activities made part of the plan. Objectives and plans were prioritized as well as a cost benefit analysis done. Sources of funding were identified. The next step is FEMA reviewing the plan and sending their comments. Those comments as well as public comment will then be incorporated into the plan and the plan sent back to FEMA for approval. Upon approval by FEMA, the plan will be submitted to the Board for their adoption. As things change and projects change the plan will change and be updated.

Ms. Sue McCrory of The Crescent appeared. She asked how this public meeting differs from the one held earlier. Ms. Rifkin answered that it is required that two public meetings are held; the first to get initial ideas and the second for review. Ms. McCrory asked if the committee studied how many structures that are in the flood zone are safe from flooding and how many are not during a 100 and 500 year storm. Ms. Rifkin stated that they did not. Ms. McCrory believes that this is important as it seems that what is known gets done. She believes that if the Village had a list of properties that are not safe from flooding and what it would take to get them safe or flood compliant existed, that a process would start and that progress could be measured.

Mr. Dan Natchez of Alda Road appeared on behalf of the Coordinated Council of Neighborhood Associations. The CCNA reviewed the plan and adopted a resolution which Mr. Natchez read and filed for the

record. He stated that he found the plan to be very well written and a major step in the right direction. The CCNA will be submitting some comments which they believe could help the plan. They are concerned that the plan is an "after the fact" plan. Mr. Natchez believes that it does not significantly outline how to prevent the hazards from occurring.

Mr. Paul Ryan of Waverly Avenue appeared. Mr. Ryan was a member of the All Hazards Mitigation Plan Committee. Mr. Ryan disagrees with Mr. Natchez in that it is an after the fact. He believes that it is a pre-fact plan and helped the Village prepare for Hurricane Irene. Part of the work to be done is educating the public on what to do at the time of a future event. The committee did anticipate the rise in sea level and it will be up to the Board of Trustees to change zoning codes if they feel necessary. As far as the comment he has heard to prevent residential development in flood prone areas, this would turn into a taking of property, which is not cost effective for municipalities. Residential development can be one of the least dense uses of property and a municipality cannot tell a resident what they can and cannot use their property for. We need to follow New York State laws regarding flood regulations which are very strict. Mr. Ryan believes that the committee and ETG did a fantastic job and looked at not only what hazards can happen here, but how events in neighboring communities could affect the Village. Mr. Ryan stated that having this plan will lower the flood insurance premium costs for residents as well as opening up funding opportunities for residents affected by flooding.

Trustee Hofstetter stated that this is going to require educating the residents and it is an important document to pay attention to. One of the most interesting things he got from the plan is that there were 64 major disaster declarations in NY State since 1954 and 46 of those were either due to hurricanes or flooding which affected the Village. Trustee Hofstetter believes that the resources we need to service structures built in flood areas needs to be looked at as well.

Mayor Rosenblum noted that this is a continuing process and comments should be sent to the Village Manager's office. The Mayor believes that no plan is viewed perfect by all; he believes this is an excellent start and thanked the committee, staff and ETG for all of their work on it.

#### PUBLIC HEARING ON TENTATIVE BUDGET FOR FISCAL YEAR 2012-2013

Mayor Rosenblum read the public hearing notice. Mr. Slingerland stated that this is a 2% tax cap compliant budget totaling \$32,110,332. Mr. Slingerland noted that in 1992, the tax rate was \$129.36 per \$1000 in value. Because we have lost so much value and maintained a slow, but steady increase in expenses, the rate in 2012 is \$308.56. The largest increases in the coming year are in benefit and pension costs. Projected

increases in fuel costs and program costs were anticipated as well. Mr. Slingerland stated that budget hearings with all department heads have been scheduled and that these meetings are open to the public.

PUBLIC HEARING (CONTINUED) ON PLL C-2012 AUTHORIZING A REAL PROPERTY TAX LEVY IN EXCESS OF THE 2% PROPERTY TAX CAP

On motion of Trustee Santoro, seconded by Trustee Ryan:

RESOLVED that the Continued Public Hearing on PLL C-2012 be and is hereby open.

Ms. Sue McCrory of The Crescent appeared. Ms. McCrory asked if there will be a time limit on public comment. Mayor Rosenblum stated that yes, it will be five minutes. Ms. McCrory believes it would be helpful to post time limits when a public hearing is noticed. Mayor Rosenblum stated that a limit depends on the number of speakers. Ms. McCrory stated that her time was limited at the last meeting and she was one of only two speakers. Ms. McCrory appeared to state that she is opposed to this law as she feels the Village should show fiscal responsibility. She realizes that the Board may feel that there hands are tied due to unfunded

mandates and obligations; however, she believes that the tax cap gives us an opportunity for fiscal discipline. Ms. McCrory believes that the Village should do benchmarking in how we perform duties and what these things cost. She would like to see the Village compared to neighboring communities. This could give us some insight on how to cut costs. Trustee Hofstetter stated that during the time he was on the budget committee and also as a liaison to that committee, they pushed for performance measurements; however, that has not happened.

Mr. Dan Natchez appeared again on behalf of the CCNA. They adopted a resolution in reference to this proposed local law, which he read and filed for the record. They are in opposition to this proposed local law. Mr. Natchez stated that he does not know a family who has not had to reassess their priorities and their activities and expenditures due to the tax burdens, which are increasing in alarming rates. Mr. Natchez believes that the Village has to set the example.

On motion of Mayor Rosenblum, seconded by Trustee Santoro:

RESOLVED that Proposed Local Law C-2012 be and is hereby adopted and shall read as follows:

A local law to override the tax levy limit established in General Municipal Law §3-c

#### Section 1. Legislative Intent

It is the intent of this local law to allow the Village of Mamaroneck to adopt a budget for the fiscal year commencing June 1, 2012 – May 31, 2013 that requires a real property tax levy in excess of the "tax levy limit" as defined by General Municipal Law § 3-c.

#### Section 2. Authority

This local law is adopted pursuant to subdivision 5 of General Municipal Law §3-c, which expressly authorizes a local government's governing body to override the property tax cap for the coming fiscal year by the adoption of a local law approved by a vote of sixty percent (60%) of said governing body.

#### Section 3. Tax Levy Limit Override

The Board of Trustees of the Village of Mamaroneck, County of Westchester, is hereby authorized to adopt a budget for the fiscal year commencing June 1, 2012- May 31, 2013 that requires a real property tax levy in excess of the amount otherwise prescribed in General Municipal Law §3-c.

Section 4. Severability

If a court determines that any clause, sentence, paragraph, subdivision, or part of this local law or the

application thereof to any person, firm or corporation, or circumstance is invalid or unconstitutional, the

court's order or judgment shall not affect, impair, or invalidate the remainder of this local law, but shall be

confined in its operation to the clause, sentence, paragraph, subdivision, or part of this local law or in its

application to the person, individual, firm or corporation or circumstance, directly involved in the controversy

in which such judgment or order shall be rendered.

Section 5. Effective date

This local law shall take effect immediately upon filing with the Secretary of State.

Trustee Hofstetter stated that he is voting no as he believes that given the tentative budget they have been given,

the Village should be able to come in well under 2%. He sees no reason to pass this law. He believes that it is

perfectly reasonable to be able to stay under 2%.

Trustee Ryan is uncomfortable not passing this as they have not met as a Board to discuss the budget nor

have they met with the department heads to discuss their plans for the year. She does not want to have her

hands tied before she has met with the department heads so that they can have the flexibility if needed. She is

voting yes.

Trustee Santoro stated that he agrees with Trustee Ryan. He has not had the opportunity to review the

budget and would like to have some leeway in the event the Village needs it. He does not believe that we will,

but would like to have the option. He is voting yes.

Mayor Rosenblum thanked the speakers for their comments. The first year he was in office, the budget

was at 0.35%. His ultimate goal is to have a zero percent increase; however, to be successful and creative, he

stated that we have to begin running this Village like a business. Mayor Rosenblum stated that the taxpayers

know better what to do with their money and he would like money to stay in the taxpayers hands. We need to

be able to address any unforeseen fiscal situation and will vote yes.

Trustee Hofstetter asked to clarify his understanding that as this has passed, the proposed budget may go

up. Mayor Rosenblum stated that this is not true; this is just an added tool.

Trustee Ryan stated that she does not know what the department heads took out that she would like to be able to be part of a decision on removing or perhaps moving things around in the budget. She anticipates that the budget increase will stay where it is or hopefully go lower after the department meetings.

PROPOSED LOCAL LAW D-2012 AMENDING AUTHORITY OF VILLAGE ATTORNEY

Mayor Rosenblum read the proposed changes to the law, which is changing the word candidate to attorney.

Ms. Sue McCrory of The Crescent appeared to confirm that any consultation that the Village Attorney participates in with any other Village consulting attorney is covered under his retainer agreement and the Village will not be billed in addition. Mayor Rosenblum and Village Attorney Charles Goldberger confirmed that this is true. Ms. McCrory is concerned as this is not law; this is part of Mr. Goldberger's retainer agreement and can change with the change of Village Attorney. Mayor Rosenblum stated that this law could be changed if necessary and that this Board cannot bind future Boards.

Trustee Hofstetter asked if there was a conflict between the Village Attorney and a Land Use Board Attorney, how that would be addressed. Mr. Goldberger stated that in a land use case, he would defer to the Land Use Attorney; however, if the case were going to come before the Board for determination, than it would be in his purview to handle.

§ 78-3. Powers and Duties.

The Village Attorney shall render legal counsel to the Mayor and Board of Trustees, the Village Manager, the Board of Ethics and other Village departments and authorities; the Village Attorney shall represent the Village in civil litigation and do related work as required; the Village Attorney shall communicate and coordinate with such other special counsel(s) as may be necessary including, but not limited to, Land Use Counsel, Bond Counsel, Labor Counsel, General Liability Counsel (as assigned by insurance company(ies) and Village Prosecutor.

**Section II.** This Local Law shall take effect immediately upon filing with the Secretary of State.

Mr. Stuart Tiekert of Beach Avenue appeared on a point of order. He believes that the Public Hearing on PLL C-2012 was never closed. Ms. Roberts stated that her notes show that there was no motion to close the hearing. Mr. Goldberger stated that before closing the hearing, there should first be a motion to reconsider.

Mr. Stuart Tiekert appeared again. Mr. Tiekert stated that the Board has procedural mayhem and asked the Board to please follow their meeting procedures. It is only fair to the citizens that the Board follow their own rules. Mr. Tiekert stated that one month ago the Board was presented with a resolution to the drainage problem on Pine Street. A lot has happened since then. The federal litigation that he and a neighbor were dragged into due to the Village's mismanagement of the situation has been dropped. He is not sure if it has been dropped against the Village. He stated that the plans that were submitted to the Board when they passed

their resolution have been changed; an RFP has been sent out and he believes that the costs appear to be grossly underestimated, the plans are inconsistent and the plan for the tree is unworkable. Mr. Tiekert stated that it appears that \$15,000 of engineering work was done without authorization and there is no data or calculations that say this drainage plan will work. Mr. Tiekert stated that Pine Street has been an issue for 30 years and has cost the tax payers \$100,000 and it appears that it will cost them an additional \$50,000. There is one question that has been asked for 30 years that has not been answered by this Board or any previous Board and that is "is Pine Street suitably improved". Mr. Tiekert believes that this will still not be answered after all of this proposed work is done. Mr. Tiekert asked that the Board suspend this plan as he believes that it is nowhere ready to go forward.

Ms. Doreen Roney of Highview Street appeared to confirm that the Board received her email on the errata changes. The Board confirmed the receipt. Ms. Roney has submitted numerous data on errors in the Comprehensive Plan. The letter she sent today was three pages; there were another 11 pages from the Department of State that highlighted areas of the Comprehensive Plan that are still incorrect and not corrected in the proposed errata sheet. In Figure 6.3, critical environmental areas are not mapped; all wetlands as well as the national wetlands are not mapped. There is a six-lot subdivision in the Plan that will have text added to it after the adoption of the errata changes that was not approved as it failed consistency determination by the HCZM and NY DOS. Ms. Roney stated that it is her opinion that BFJ Planning is not delivering the high quality work that the Village is expecting. She has these concerns, as well as concerns regarding the careless errors in the LWRP. After the last meeting, there were angry interactions with residents over errors in the Comprehensive Plan with Mr. Fish. It is her opinion that perhaps the Village Planner who has been here for thirty years is too cozy and it may be time to look for another planning firm.

Ms. Sue McCrory of The Crescent appeared regarding Item 4L, authorizing non-union employee salary increases. Ms. McCrory does not have issue with the raises; however she believes that giving retroactive pay increases is in direct violation with the gift provision in the NY State Constitution and the gift and loan clause. Ms. McCrory suggested that the Board receive legal clarification on whether this is consistent with NY State law before moving forward.

#### 3. OLD BUSINESS

A. Resolution to Schedule a Public Hearing on PLL E-2012 amending Chapter 126, Building Construction Regarding Certificate of Occupancy of Completion

Mr. Slingerland gave an overview of the Proposed Local Law. Trustee Santoro asked if this will affect all open Certificates of Occupancy, or only those going forward. Mr. Slingerland stated that this would be for all open permits.

#### STATEMENT OF SUPPORT FOR NEW YORK STATE PENSION TIER VI

It is known that municipalities within Westchester County have among the highest property tax rates in the United States. Unfunded mandates imposed by higher levels of government are a major contributing factor exacerbating this tax burden. In addition to these unfunded mandates the required annual contributions that municipalities must make to the New York State and Local Government Retirement System also have a large affect on municipal budgets.

In a resolution adopted by this Board on December 20, 2010, we expressed our support for positive consideration of a mandate relief package as proposed by the New York Conference of Mayors (NYCOM) and presented to the New York State Legislature. Among the recommendations submitted by NYCOM on behalf of its member municipalities was the creation of a new pension tier.

As a positive step, the New York State Legislature working with Governor Cuomo has taken a proactive step to help the taxpayers of the State of New York by establishing a new pension tier for employees hired after April 1, 2012.

Among the major benefits to municipalities, Tier VI provides for a graduated employee contribution rate based on salary, ranging from 3% to 6%, which continues through the entire term of employment. This contrasts with the existing system under which a majority of employees contribute 3% of salary for the first 10 years of employment only. Other benefits include an increase in the minimum retirement age for non-uniformed personnel to 63, modification of the pension calculation rate, and the provision of an optional defined contribution plan for non-union personnel.

All told, it is estimated that Tier VI will save State and local governments over \$80 billion dollars over the next 30 years. However, these savings will not occur until employees in the new Tier VI begin to be hired by municipalities.

As a reminder and policy position to the State of New York, the Village of Mamaroneck requests mandate relief along the lines that have been communicated previously to the State of New York.

Looking at big-ticket items, from the aspect of cost-benefit balance, the largest expense any municipal entity in New York State faces is the expense for providing employees and retirees with health benefits. Presently, providing health benefits for these employees and retirees costs the Village roughly ten percent of our annual expenses, which exceeds the Village's contributions to the pension system. Also, the Wicks Law for larger projects continues to drive up bidding costs by as much as 15% and 25%. For major, large scale projects such as new offices or facilities, these additional expenses can run into the millions of dollars.

The Village is requesting New York State to provide mandate relief by focusing on amending laws to reduce the costs on big-ticket expenses, especially health benefits, and the Wicks Law.

## RESOLUTION RE: AUHTORIZATION TO INITATE A PILOT POGRAM TO ALLOW SIDEWALK CAFES PRIOR TO APRIL 1, 2012

WHEREAS, the sidewalk cafe regulations as established pursuant to Chapter 258 of the Code of the Village of Mamaroneck are designed to allow sidewalk cafés on public property in locations where they are determined to be appropriate by the Village Manager and as identified in the Code, they aim to achieve the following:

- Provide adequate space for pedestrians on the sidewalk adjacent to sidewalk cafés and to ensure access to adjacent commercial and retail uses.

- Promote sidewalk cafes as useful and properly planned visual amenities which better relate to the

streetscape.

- Promote the most desirable use of land and buildings in the village.

WHEREAS, pursuant to §258-3 of the Code of the Village of Mamaroneck, Sidewalk Cafés are

permitted between April 1 and October 31 of each calendar year as the temperature typically remains mild

through March into early April; and

WHEREAS, temperatures for the month of March are much higher than compared to previous years

and as a result, several restaurants have expressed a desire to operate sidewalk cafés prior to the April 1

commencement date to take advantage of the unseasonably warm weather; and

WHEREAS, the spirit of the law is to allow sidewalk cafes when weather conditions are optimal and

while April 1 is typically an appropriate day to allow the installation of sidewalk cafes, however, given the

unseasonably warm weather it may be beneficial to the community to allow the installation of such cafés in

advance of the commencement date for 2012.

On motion of Mayor Rosenblum, seconded by Trustee Ryan:

RESOLVED, that the Village Manager is herein authorized to begin issuing sidewalk café permits prior

to the April 1 statutory date insofar as applicants comply with all other requirements as set forth in Chapter 258

of the Code of the Village of Mamaroneck.

#### 6. FLOOD MITIGATION REPORT

Mr. Slingerland announced that Saturday, April 21 between 9:30 a.m. and 4:30 p.m. will be the fourth annual clean up day in the Village of Mamaroneck beginning with a tree planting ceremony at Harbor Island Park. Mr. Dan Pfieffer, from the Hampshire Country Club appeared to announce that they will be helping the effort by loaning the goose dropping picker-upper. A number of the Club's personnel will also be helping out. The Board thanked Mr. Pfieffer and the Club.

Mr. Slingerland stated that the All-Hazards Mitigation Plan was filed with FEMA on February 14 and it was asked when we could expect to hear from the State on the several applicants we filed for assistance through the Hazard Mitigation Grant Program, which closed in February. These are contingent upon FEMA's review and approval of the plan. Mr. Slingerland stated that the State is aware that FEMA is conducting their review and we have asked FEMA to get back to us as soon as possible. Mr. Slingerland also announced that we will be moving forward on silt removal and additional work to help mitigate flooding. Mr. Slingerland reported on a meeting that took place last week with FEMA and the DEC. This was purely an informational meeting where no policies were established or amended. This was a community assistance visit on the 818 The Crescent file. We were represented by our land use attorneys, as well as the current and previous building inspectors. There were additional discussions regarding flood plain variances. Based on the building department's records, we have issued approximately three since the floods in 2007 out of several hundred building permits. The removal of the "cumulative" provision from the code was discussed, and how this could affect the CRS rating. Trustee Hofstetter asked where the meeting took place. Mr. Slingerland stated that it took place at Beach Point Club.
