(b) SIGNS CAN NOT HAVE MORE THAN 3 COLORS AS PER VILLAGE CODE SEC. 286-10 (C). APPLICANT WOULD HAVE TO APPLY TO ZONING BOARD OF APPEALS FOR PERMISSION FOR LARGE ACCESSORY SIGN AND FOR MORE THAN 3 COLORS
