### **OLD BUSINESS:**

# MAMARONECK BEACH AND YACHT CLUB –TO OBTAIN A PERIMETER PERMIT FOR A DOCKING FACILITY

Mr. Paul Noto Esq. and Mr. Michael Ludwig/Ocean Coastal Consultants of Trumbull, Connecticut were present to represent the applicant.

A stenographer was present to transcribe the application of the Mamaroneck Beach and Yacht Club.

Mr. Noto gave an overview of the application, noting the following:

- Appropriate notifications were done
- The Mamaroneck Beach and Yacht Club has been in existence for 50-55 years
- The Mamaroneck Beach and Yacht Club is in the MR Zone
- The facility pre-dated the perimeter permit
- Submission completed
- There are no changes to the existing footprint

Mr. Ludwig discussed the perimeter, noting the following:

- The perimeter is laid out within the boundaries of the Mamaroneck Beach and Yacht
- Discussion of Part A

- Discussion of Part B
- North side of dock B is held by the Mamaroneck Beach and Yacht Club
- The perimeter meets Village requirements and there is no change in the square footage of the dockage, as is covered in the letter from the Army Corps of Engineers
- No additional boats added
- No change in the use, boats or square footage of dockage
- No loss of navigational servitude
- No orders of environmental impacts

The Chairman, Commission and representatives for the applicant held a discussion regarding the proposed application.

On a motion by Mr. Gallagher, seconded by Mr. Weiner, for the Commission to authorize the Village to retain a consultant/expert to advise the Board on the correct perimeter of the property and to make sure that the Board is not missing any information.

The requested documents are: The metes and bounds should be annotated on the full size survey and plans, copy of licensing agreement, State DEC letter on their position on the rock reef and the ancillary issue on Otter Creek, more accurate information on the dredge that was done and show the depths within the perimeter on the drawings, copy of the deed that describes the actual metes and bounds description of the land that

is the subject of the license and for Mr. Spinelli to confirm the existing square footage of the docks that are there now on the plans.
