A. Barry C. Melancon and Patricia Gaudet Melancon – 580 Shore Acres Drive Reconfiguration of Existing Recreational Docking Facility and Maintaining Existing Seawall and Riprap

Discussion by Board members: Chairman read letter from Planning Board. Bob Galvin, AICP – Village Planner explained Planning Board letter regarding the issue between chains and anchors versus pilings. Bert Segal mentioned that during the storm, pilings weathered better than chains and anchors.

Sven Hoeger, HCZM Environmental Consultant stated his opinion that pilings would be a greater asset to water quality than the alternative of chains and anchors, which tend to scour the bottom and is less friendly to marine life.

Anna L. Georgiou, Counsel to the HCZMC, mentioned that if application is approved would the board want to raise the height of the pilings per the consulting engineer's recommendation from 13.5 feet to 15 feet, and if so it should be stated in the resolution.

Public Comments:

Mr. Joe Russo – Harbor Master for the Village of Mamaroneck, discussed pilings vs. chains and anchors. See attached e-mail sent to Sally Roberts on 11-20-12.

Mr. Dan Natchez of Daniel S. Natchez & Associates addressed the Board on behalf of the Melancons. Dan Natchez discussed the type of pilings proposed. Mr. Natchez also stated that if chains and anchors were to be used on this particular float, the float would have to be widened due to the fact that the chains would move 5 to 7 feet and the float was not meant to move 5 to 7 feet. Mr. Natchez also discussed the caps on top of the pilings. He explained that they are there to prevent water from going inside the pilings, which can freeze and cause deterioration. It also serves to prevent birds from falling into the pilings and getting stuck.

Mr. Wexler expressed his concern that the Planning Board in discussing the wetland permit saw community and visual character as an issue. The Planning Board felt that the HCZM should review it for the visual impact on the Harbor.

Finkbeiner, PLS dated October 25, 2012 ("Application"); and

WHEREAS, the public hearing for this Application opened at the November 29, 2012 meeting of the Commission was thereafter closed on that same date; and

WHEREAS, the Commission has considered and evaluated the Application, including consistency with the Village of Mamaroneck Local Waterfront Revitalization Program ("LWRP").

The Applicant agreed to raise the height of the proposed piles to a minimum elevation 15.0 feet NAVD as set forth in Plans prepared by Lemond and Associates, dated October 26, 2012 and last revised October 28, 2012.
