2. OLD BUSINESS

A. 448 Mamaroneck Avenue – Smashburger: Amended site plan to include landscaping (Cont.)

Village of Mamaroneck Planning Board February 27, 2013 Page 1 of 3 Jennifer Gray, Esq., Keane & Beane, appeared for the applicant and said the design has been modified. She stated that she worked with Ms. Oakley to finalize the landscaping plan. One of three Crabapple trees was eliminated and replaced with a Rhododendron. dimensions for the ramp landing were revised and included on the site plan. The drawings

were done to scale.

Ms. Oakley read into the record her letter on the landscaping modifications.

Mr. Ianniello said a letter was received from Stuart Tiekert, resident, stating his concerns.

This was reviewed by the Planning Board and included in the record.

Mr. Galvin indicated that the outdoor seating requires a separate Sidewalk Café Permit

annually approved and issued by the Village Manager, and is not part of the Site Plan.

Mr. Steinman said that an executed License Agreement for the use of public property for

the ramp and the installation and maintenance of the plantings is required for approval.

SEQRA

Mr. Galvin indicated that the action was determined to be a Type II by the Planning Board

and SEQRA was closed out at the last Planning Board meeting on 2/13/13.

LWRP Consistency

On motion by Mr. Sjunnemark, seconded by Mr. Sterk, the Planning Board determined that

the application was consistent with the policies of the LWRP.

Site Plan Approval

On motion of Mr. Sterk, seconded by Mr. Sjunnemark, the Amended Site Plan for 448 Mamaroneck Avenue, Smashburger, was approved subject to (1) a notation included on the drawing indicating that the outdoor seating is subject to an annual Sidewalk Café Permit approved and issued by the Village Manager and not considered part of the amended site plan approval; (2) an executed License Agreement between the Village and applicant for the use of public property for the handicapped accessible ramp and the installation and maintenance of the plantings; and (3) approval of the Final Site Plan Resolution to be

reviewed at the March 13, 2013 Planning Board meeting.
