Ms. Insardi gave background on this Proposed Local Law and the previous hearings held. After

the July 6 Public Hearing, the then Proposed Local Law 8-2009 was redrafted and distributed to the

Board and posted on the website. Ms. Insardi informed the Board and residents that she believed the

draft was in its final form when submitted; however, it has come to her attention that the Board would

like to make additional changes. Therefore, she suggested opening the public hearing, hearing the

comments of those residents present, but not adopting the Law this evening. The Proposed Local Law

will be redrafted to include the changes the Board feels appropriate and discussed at the September 9

Work Session. A public hearing will then be scheduled for a future meeting.

Ms. Insardi also stated that there was correspondence received from Suzanne McCrory and Stuart

Tiekert for the record.

Mr. Norman Rosenblum of Carroll Avenue, declared candidate for Mayor in the November 2009

election, appeared. Mr. Rosenblum agrees with the intent of the law in regard to the use of Village

property; however he believes there is a potential problem marrying this with the code governing

sidewalks and curbs.

Mayor Savolt stated that this is a very unique situation where residents have put things in the

Village's right of way and this law is a way to try and get a handle on what has already been done.

Mr. Benny Salanitro of Brook Street, appeared. Mr. Salanitro had several suggested changes and

revisions to the Proposed Local Law, which he communicated to the Board. Mr. Salanitro stated that he

will provide the Village Attorney with a copy of his notes.
