The Tentative Budget is also available for review at the Mamaroneck Public Library.

Said Tentative Budget includes compensation for the Mayor of \$9,000.00 per annum and for the Trustees of \$5,000.00 per annum.

RESOLVED that the Public Hearing on the Fiscal Year 2009-2010 tentative budget be and is

hereby open:

Village Manager Slingerland gave an overview of the tentative budget. He summarized the budget

message stating that the tentative budget is \$29,434,871. Appropriations increased by 2.9%, and

estimated non-property tax revenues decreased by 6.29%. The Manager also stated that the proposed

tax rate is \$289.92 per \$1000 of assessed valuation, an increase in the rate of \$18.47 per \$1000 of assessed

value. He further stated that this represents a 6.81% tax rate increase which roughly calculates to an annual increase of \$277 for an average home assessed. Mr. Slingerland touched on the highlights of the

budget including union raises of 4% for PBA and 4.25% for CSEA employees; total employee costs of

\$15.8 million which is 65.2% of the total general fund spending plan; flooding remediation plans; fund

balance and beginning fund transfers. At the start of the budget review it was recommended to use

\$150,000 of the un-designated fund balance to offset and reduce reliance on property taxes. He also

reported that the Village's fund balance is approximately 7% of our annual operating expenses. This is on

the low side and it has been recommended to increase this amount to improve our bond rating and

decrease lending costs. Mr. Slingerland touched on the GASB 45 accounting standard that is now

required.

Mr. Slingerland informed the residents that the Board has been working with him, the Budget

Committee and department heads to try and increase revenue and reduce costs, therefore decreasing the

tentative tax increase.

Mayor Savolt stated that the Board is looking at fees, many of which have not been raised in years.

Ms. Ellen Hauptman of Chestnut Avenue appeared to clarify the tax increase and why there is a

gap between the increase in spending and the tax increase. Mr. Slingerland explained that this is

attributed to the decrease in non-property tax revenue.

The Board decided to hold the hearing open to the April 27, 2009 meeting. The Mayor asked

residents to please communicate their feelings on the budget and if there are services that they feel can be

cut to let them know.

Trustee Murphy reminded residents that other communities may have lower tax increases this

year, and that is due to their using money from their fund balance to offset a larger increase.

Unfortunately, the Village does not have a large fund balance due to the payment of legal fees for useless

lawsuits

This Public Hearing was adjourned to the April 27, 2009 Board of Trustee Regular Meeting.
